Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Townsend's Combined Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 3, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period ended December 3, 2024 and the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 3, 2024 and December 31, 2023 and for the period ended December 3, 2024 and the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audits of the Financial Statements section of our report. Notes to Financial Statements

December 3, 2024 and December 31, 2023

1. Summary of Significant Plan Provisions

The following description of the Townsends Combined Pension Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- a. **General** – The Plan was a noncontributory, defined benefit plan which provided pension benefits to employees of Townsends, Inc. and its subsidiaries (the “Employer” or “Townsends”) who had met the eligibility requirements and were participating in the Plan as of December 31, 2002. Effective December 31, 2002, the Plan was frozen with respect to new participants and the accumulation of additional benefits for existing participants. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Plan’s previous sponsor, Townsends, filed for bankruptcy on December 19, 2010. Effective February 25, 2011, Townsends, was sold in two separate transactions. Effective with the sale, all employees of Townsends were terminated. Effective May 31, 2011, The Indian River Trust (“Plan sponsor”), sole shareholder of Townsends, assumed responsibility for administering and maintaining the Plan and for funding all Plan liabilities. Effective September 30, 2023, the Plan was terminated. As of December 3, 2024, all assets had been distributed out of the Plan.

- b. **Funding policy** – The Plan sponsor agreed to make contributions to the Plan that met or exceeded the minimum funding requirements of ERISA. No contributions were required or made for the period ended December 3, 2024 or the year ended December 31, 2023.
- c. **Pension benefits** – Normal retirement benefits began at age 65. The normal form in which benefits were paid is a life annuity or qualified joint and survivor annuity. Other payment options were available, as described in the Plan agreements. The Plan permitted early retirement when a participant had both attained 55 years of age and completed 10 years of service. The Plan also allowed for death benefits, as described in the Plan agreements. Effective December 31, 2002, accruals under the Plan ceased. A participant’s accrued benefit will not increase or decrease after December 31, 2002 due to changes in the participant’s compensation or years of service.
- d. **Termination of the Plan** – The Plan was terminated under the Pension Benefit Guaranty Corporation (“PBGC”) standard termination process effective as of the close of business on September 30, 2023. As of December 3, 2024, all assets of the Plan were distributed in accordance with the provisions of ERISA. The Plan administrator has taken all actions required to comply with applicable PBGC, Internal Revenue Service (“IRS”), or other governmental regulations. The net assets of the Plan have been allocated, as prescribed in ERISA and its related regulations, generally to provide the following benefits in the order indicated:
 1. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.

Notes to Financial Statements

2. Other vested benefits insured by the PBGC up to the applicable limitations (discussed below).
3. All other vested benefits (that is, vested benefits not insured by the PBGC).
4. All nonvested benefits.

2. Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are reported at fair value. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net change in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the period.

- d. **Actuarial present value of accumulated plan benefits** – Accumulated plan benefits are those future periodic payments, including lump sum distributions, that are attributable under the Plan’s provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits are based on a percentage of eligible compensation for each applicable year of service. Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included, to the extent attributable to employee service rendered through December 31, 2002. The actuarial present value of accumulated plan benefits is determined by an independent actuary and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money and the probability of payment between the valuation date and the expected date of payment.

Notes to Financial Statements

2. **Summary of Significant Accounting Policies** (cont.)

- e. **Payment of benefits** – Benefits are recorded when paid.
- f. **Administrative expenses** – All administrative expenses for operating and maintaining the Plan were paid from Plan assets.

3. **Investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Principal Life Insurance Company ("Principal Life"), the custodian of the Plan, and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedule:

- a. Investments at fair value as shown on the accompanying statement of net assets available for benefits of \$0 and \$17,593,373 as of December 3, 2024 and December 31, 2023, respectively.
- b. Net change in fair value of investments as shown on the accompanying statement of changes in net assets available for benefits of \$36,812 and \$1,040,754 for the period ended December 3, 2024 and the year ended December 31, 2023, respectively.
- c. All investment transactions that occurred during the period ended December 3, 2024 and the year ended December 31, 2023.
- d. All the information included in the supplemental schedule.

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Notes to Financial Statements**December 3, 2024 and December 31, 2023****4. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2023.

Pooled separate accounts: These investments are valued based on the net asset value ("NAV") of the pooled separate account multiplied by the number of shares held by the Plan at year-end. The NAV is determined based on the fair value of the underlying investments adjusted for expenses. The NAV is used as a practical expedient to estimate fair value.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
