Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of A.E. Robinson Oil Co., Inc. Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).
- The information in the 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with U.S. generally accepted auditing standards (U.S. GAAS). 1. Description of Plan

The following description of the A.E. Robinson Oil Co., Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

General

The Plan covers eligible employees of A.E. Robinson Oil Co., Inc. (the "Company"). The purpose of the Plan is to provide retirement income and other benefits to eligible employees of the Company. The Plan is a prototype defined contribution plan sponsored by ADP Retirement Services with a 401(k) salary deferral arrangement. Reliance Trust Company, (trustee) serves as the Plan's trustee.

Eligibility

Employees are eligible to participate in the Plan as well as any employer safe harbor or profit-sharing contributions when they have completed one year of service, as defined by the Plan documents, and have attained the age of 18. The entry date for all contribution types is the first day of the plan year quarter coinciding with or following the date the employee satisfies the Plan's eligibility requirements.

Contributions

Participants are permitted to make elective deferrals as a pre-tax deferral or as a Roth deferral in any amount up to 90% of their compensation subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants deferring to the Plan are eligible for a safe harbor matching contribution equal to 100% of salary deferrals that do not exceed 3% of the employee's compensation plus 50% of salary deferrals between 3% and 5% of an employee's compensation. For purposes of calculating the safe harbor matching contribution, the compensation and deferrals are determined on a payroll period basis.

The Plan also offers an employer discretionary profit-sharing provision applicable to all active employees who have completed at least 1,000 hours of service during the plan year. Profit sharing contributions made to the Plan are allocated in the ratio that a participant's eligible compensation bears to the total eligible compensation paid to all eligible participants. For the year ended December 31, 2024, the Company contributed \$300,000 as a discretionary profit sharing amount.

Investments held by the Plan on behalf of participants are participant-directed, meaning that the individual participant selects the investments for his or her individual account.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company safe harbor matching contributions, as well as an allocation of (a) the Company's profit-sharing contributions, (b) plan earnings, and (c) charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon and the Company's safe harbor matching contributions. Vesting of any employer nonelective or discretionary profit-sharing contributions will vest in equal installments over five years.

Payment of Benefits

On termination of service, a participant with an account balance of more than \$5,000 may elect to receive either a lump-sum distribution of their entire vested account balance, a partial distribution of any portion of their vested account balance, or installments over a period consistent with the terms of the Plan document. Vested terminated balances greater than \$1,000 but less than \$5,000, for which there is no participant direction, are automatically distributed to an individual retirement account for the benefit of the participant. Participants are permitted to elect in-service withdrawals for hardship reasons or if age 59 ½ is attained.

Forfeited Accounts

Forfeited accounts are allocated in the Plan year in which the break in service occurs, to the extent attributable to nonvested nonelective or profit-sharing contributions. For the year ended December 31, 2024, forfeitures used to reduce employer safe harbor contributions totaled approximately \$7,281. Forfeitures were not used to reduce administrative fees in 2024. As of December 31, 2024 and 2023, there was \$20 and \$19, respectively, of unallocated forfeitures.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan have been prepared under the accrual basis, except that benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual amounts may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by investment advisors and trustee. The Plan invests in shares of registered investment companies (e.g. mutual funds) and units of a common collective trust fund. See Note 4 for disclosure of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Net appreciation in fair value include the Plan's realized and unrealized gains and losses on investments bought and sold as well as those held during the year.

Certain management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, certain management fees and operating expenses are reflected as a direct reduction of investment return for such investments.

Payment of Benefits

Benefits may be paid upon termination, death, disability, retirement or hardship. Benefit payments are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from the accompanying financial statements.

Subsequent Events

The Plan has considered transactions or events occurring through August 5, 2025, which was the date that the financial statements were available to be issued.

3. Certified Information

4. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Mutual Funds - Investments in mutual funds are valued daily at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

Common/Collective Trust ("CCT") – The fair value of the CCT is determined using Level 2 inputs. The fair value of the investments is each CCT's pro-rata share of the fair value of the securities in the underlying separate account(s) in which the CCT participates. The CCT provides a fixed interest rate for a fixed period that will apply to the entire guaranteed value. The interest rate is reset every quarter as determined by MetLife with consideration of the fair value of the separate accounts, the anticipated market yields-to-maturity of benchmark indices of the separate accounts, expected payments into and out of the contract, amortization of the difference, if any, between the fair value of the separate accounts and the guaranteed value of the contract, and the fees allowed under the CCT. The Plan's management has determined that its investment in the Stable Value Fund is classified as Level 2 in the fair value hierarchy.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants should refer to the Plan documents for a description of the priorities or distribution of Plan benefits in the event of termination.

6. Tax Status

The Company adopted a prototype non-standardized profit sharing and 401(k) plan which received a favorable opinion letter from the Internal Revenue Service dated October 6, 2020. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to audit by various taxing authorities; however, there are currently no audits for any tax periods in progress.

7. Administrative Expenses

The Company absorbs significant costs associated with administering the Plan. For the year ended December 31, 2024, certain fees for fiduciary services and investment advisory services of \$23,933 were being charged to the Plan and allocated to the participants.

8. Related Party/Party In-Interest Transactions

Reliance Trust Company performed trustee services for the Plan for the years ended December 31, 2024 and 2023. Reliance Trust Company is considered a party-in-interest to the Plan. Accordingly, transactions with the trustee, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Certain employees and officers of the Company, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.
