Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

(1) Description of the Plan

The following brief description of Hylan Datacom & Electrical, LLC 401(k) Plan (the "Plan") is provided for general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan was established and became effective on January 1, 2018. Hylan Datacom & Electrical, LLC (the "Company") has general responsibility for the administration of the Plan, including, but not limited to, complying with reporting and disclosure requirements, establishing and maintaining Plan records and adopting amendments to the Plan.

Hylan Datacom & Electrical, LLC consists of four divisions: Down Under Construction, Hylan West, Western Utility, and Hylan Services. The Company provides design and construction services related to fiber optic cabling, wireless networks, intelligent traffic systems and more. The divisions provide services in their respective areas of the United States.

General - The Plan is a defined contribution plan covering all eligible full-time employees of the Company and its wholly owned subsidiaries, who have at least 3 months of service and are age twenty one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the named fiduciary/administrator of the Plan and pays the majority of administrative costs incurred by the Plan. Reliance Trust Company is the custodian of the Plan.

Contributions - There are four different contribution types available in the Plan:

Employee Salary Deferrals and Roth 401(k) Deferrals: Employees, at their discretion, may defer a percentage of their compensation as defined by the Plan.

Employee Rollover Contributions: Employees may deposit into the Plan distributions received from other retirement plans and certain IRAs.

Employer Qualified Safe Harbor Contributions: The employer commits to making certain contributions to the Plan to ensure that nondiscrimination regulations are met.

Employer Profit Sharing Contributions: Each year, the employer may make a discretionary profit sharing contribution to the Plan.

The Internal Revenue Code (the "Code") limits the maximum amount that can be contributed as salary deferral (on a pre-tax basis or after-tax basis). Those limits for 2024 and 2023 were \$23,000 and \$22,500, respectively. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions as limited by the Code.

Investment Elections - Participants direct the investment of their entire interest in the Plan into various investment options offered by the Plan and can change their investment options at a frequency determined by the Administrator of the Plan.

Vesting - Participants are immediately 100% vested in their salary deferrals, catch-up contributions and rollover contributions. Company contributions are vested as follows:

Participants are 100% invested in their profit sharing contributions if they are employed on or after their Normal Retirement Age or if they die or become disabled.

Participants are 100% invested in their qualified safe harbor contributions if they are employed on or after their Normal Retirement Age or if they die or become disabled.

Participant Accounts - Each participant's account is credited with the participant's contributions and an allocation of (a) employer profit sharing contributions, if any, (b) employer matching contributions, (c) dividends, interest, and investment gains. Each participant's account is reduced by withdrawals, investment losses, administrative expenses, and any forfeitures.

Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to 50% of their vested interest in the Plan. A participant may not have more than one loan outstanding at any point in time. The loans bear interest at a rate equal to the Prime Rate plus 1%. All loans will be due and payable in full upon the Participant's termination of employment.

Payment of Benefits - Upon separation from the Company, a participant (or participant's beneficiary) whose vested account balance exceeds \$5,000 may receive their balance as a single lump sum or installments over a period of time not to exceed the participant's assumed life expectancy, dependent upon the election of the participant.

For a participant whose vested account balance is \$5,000 or less, the Plan will distribute the vested balance in a single lump-sum payment.

Forfeited Accounts - As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,962 and \$55,920, respectively. These amounts may be used to reduce future employer contributions or administrative expenses. In 2024 and 2023, employer contributions/administrative expenses were reduced by \$-0- and \$21,817, respectively for forfeited nonvested accounts.

(2) Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Adoption of New Accounting Standard - Effective January 1, 2023, the Plan adopted ASC 326 which changed how entities will measure credit losses for certain financial assets that aren't measured at fair value through changes in net assets available for benefits. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under this standard, disclosures are required to provide users of the financial statements with useful information in analyzing the Plan's exposure to credit risk and the measurement of credit losses. The primary financial assets held by the Plan that are subject to the guidance in ASC 326, are participant and employer contribution receivables and notes receivable from participants. The impact of the adoption was not considered material to the financial statements and primarily resulted solely in enhanced disclosures.

Use of Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the Plan may file a lawsuit or foreclose on the security for the loan. A loan that is in default may be considered a distribution from the Plan.

Payment of Benefits - Benefits are recorded upon distribution.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments..

Subsequent Events - The Plan has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued.

(3) Information Certified and Provided by Reliance Trust Company (Unaudited)

The following is a summary of the Plan's investment information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedules, that was prepared by or derived from information provided by Reliance Trust Company (the "Trustee"), and furnished to the plan administrator. The plan administrator has obtained certification from the trustee that information provided to the plan administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Notes 4 and 5 and accompanying supplemental schedule related to the following assets:

(4) Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 - Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

(4) Fair Value Measurements (Continued)

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

Following is a description of the valuation methodologies used for major categories of assets measured at fair value by the Plan.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Transfers Between Levels - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instruments and size of the transfer relative to the total net assets available for benefits.

(5) Group Annuity Contract

The Plan is invested in a group fixed annuity issued by The Lincoln National Life Insurance Company ("Lincoln") totaling \$338,823 and \$424,141 at December 31, 2024 and 2023, respectively. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The fund invests in a broadly diversified portfolio of predominantly fixed income instruments with insulation from insurance company obligations through a separate account structure.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

(5) Group Annuity Contract (Continued)

The Plan's ability to receive amounts due is dependent on these issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

(6) Related Parties and Parties-in-Interest Transactions

Certain Plan investments are managed by Reliance Trust Company ("Reliance"). Reliance is the trustee and custodian of the plan assets as defined by the Plan, and therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan directly to Reliance for investment management services amounted to \$49,894 and \$46,337 for the years ended December 31, 2024 and 2023, respectively.

(7) Income Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing/money purchase plan. The non-standardized pre-approved profit sharing/money purchase plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service (IRS) states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. . The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in all amounts credited to their accounts.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(10) Delayed Deposit of Contributions

DOL regulations require that salary deferrals to a 401 (k) plan and loan repayments that are withheld from an employee's paycheck must be deposited into the Plan as soon as they can be reasonably segregated from the employer's general assets, but in no event later than the fifteenth business day of the month following the month in which the participant contributions are withheld.

The Plan failed to remit certain deposits timely in the amount of \$-0- and \$73,922 for the years ended December 31, 2024 and 2023, respectively. The Plan Sponsor has remitted \$73,922 of the principal amount with respect to the delayed deposit for December 31, 2023 and has restored all lost earnings to Plan participants for the delayed deposit.
