## **Note 1. Description of the Plan**

### ***General***

The following description of LinkOne Holdings, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document and *Summary Plan Description* for a more complete description of the Plan’s provisions, which are available from the plan administrator.

The Plan was established January 1, 2012, by LinkOne Holdings, Inc. (the “Plan Sponsor”) as a defined contribution qualified retirement plan for the benefit of its employees age 18 or older.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Reliance Trust Company serves as the Plan’s trustee and Automatic Data Processing, Inc.’s Retirement Services is the Plan’s record keeper.

### ***Contributions***

Participants may contribute up to 90% of pretax annual compensation to their account. Roth contributions are permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted.

The Plan Sponsor may make discretionary employer matching contributions to match dollar-for-dollar on the first 3% of employee deferrals and 50 cents per dollar on the next 2%, with a maximum of \$4,000 annually.

The Plan Sponsor may also make annual discretionary profit-sharing contributions in which participants must be employed on the last day of the plan year and have worked 1,000 hours during the plan year to be eligible. No profit-sharing contributions were authorized for 2024 or 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### ***Participant Investment Account Options***

Participants have the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

The Plan includes an automatic contribution arrangement. Each eligible participant not currently participating will be automatically enrolled in the Plan as a participant unless they affirmatively elect otherwise. The percentage of compensation deferred on each participant’s behalf as a pretax elective deferral is 3% and will increase by 1% each year up to a maximum of 10%.

### ***Participant Accounts***

Each participant’s account is credited with the participant’s contribution, the Plan Sponsor’s contributions, plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Plan Sponsor's matching and profit-sharing contribution portion of their accounts plus earnings thereon is based on years of continuous service with the Plan Sponsor. A participant is fully vested after six years of continuous service.

***Payment of Benefits***

Upon termination of services, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution, installments, or partial withdrawals. For participants with vested balances not exceeding \$1,000, the plan administrator will authorize the benefit payment without the participant's consent as a single lump-sum payment. Absent an election made by a participant, account balances greater than \$1,000 and not exceeding \$5,000 will be directly rolled over to an individual retirement account. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

***Forfeited Accounts***

At December 31, 2024 or 2023, forfeited nonvested accounts totaled \$109,586 and \$52,649, respectively. Forfeited nonvested accounts may be used to pay administrative fees or reduce future employer contributions. In 2024 or 2023 employer contributions remitted to the Plan for 2024 or 2023 were reduced by \$0 and \$2,301 from forfeited nonvested accounts, respectively.

***Notes Receivable from Participants***

The plan document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan is \$500. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on prime rate plus 1%. The maximum number of loans a participant may have outstanding at one time is one.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interest in the collective trust fund is valued based on information reported by the investment advisor using the audited financial statement of the stable value fund at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Rollover of Liquidating Trust Certificates***

On May 30, 2019, the Board of Directors of 3D Holdings, Inc., voted to terminate the 3D Holdings, Inc. Employee Stock Ownership Plan (ESOP) in connection with the sale of certain assets by the Plan Sponsor. Upon the ESOP's termination, all remaining ESOP participants became 100% vested in that plan and were provided the option to have their cash account balance rolled into any qualified plan (including the Plan) or IRA, or receive a lump-sum distribution.

In connection with the sale of certain assets by the Plan Sponsor effective May 30, 2019, the ESOP acquired an interest in an escrow account, the purpose of which is to pay certain liabilities, if any, associated with the sold assets. In connection with the ESOP's termination, the ESOP's interest in the escrow was transferred to the 3D Holdings, Inc. Employee Stock Ownership Plan Liquidating Trust (the "Liquidating Trust") established effective March 26, 2020. The Liquidating Trust was established for the benefit of Company employees participating in the ESOP at the time of the ESOP's termination, of which each former ESOP participant may be entitled to a distribution from the Liquidating Trust consisting of a portion of the funds currently held in the escrow.

Pursuant to the terms of the Liquidating Trust, each employee participating in the ESOP received a "Certificate of Participation" in the Liquidating Trust (the "Liquidating Trust Certificates") evidencing an interest in the Liquidating Trust (each such recipient of the Liquidating Trust Certificate is referred to as a "Certificate Holder"). Certificate Holders also participating in the LinkOne Holdings, Inc. 401(k) Plan were permitted to rollover their Liquidating Trust Certificates into the 401(k) Plan as part of a tax-deferred rollover under Section 402 of the Internal Revenue Code.

The Plan Sponsor determined that it was necessary to establish the LinkOne Holdings, Inc. 401(k) Plan Trust for the Liquidating Trust Certificates, a separate trust under the LinkOne Holdings, Inc. 401(k) Plan, to hold in custody and safekeeping the Liquidating Trust Certificates rolled over to the 401(k) Plan.

On May 30, 2023, the restriction on the escrow account lapsed, and the Liquidating Trust received cash proceeds of \$1,299,102, relating to the interest in the Liquidating Trust of the Certificate Holders participating in the LinkOne Holdings, Inc. 401(k) Plan, at which time the Certificate Holders' Liquidating Trust Certificates, previously valued at \$793,152, as of December 21, 2022, were redeemed, and the cash proceeds were distributed in July 2023 from the Liquidating Trust and transferred into the Certificate Holders' account in the LinkOne Holdings, Inc. 401(k) Plan.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Plan Sponsor or the Plan, at the Plan Sponsor's discretion.

**Note 3. Certification of Plan Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following investment information certified by Reliance Trust Company, a qualified institution, except for comparing such investment information certified by the trustee with information included in the Plan's financial statements and ERISA-required supplemental schedule as of December 31, 2024 and 2023.

**Note 5. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Fees incurred by the Plan for recordkeeping, administrative, and investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are primarily paid through revenue sharing, rather than a direct payment. Individually nonmaterial direct expenses paid to parties in interest totaled \$55,383 for 2024 and \$41,531 for 2023. The Plan Sponsor provides certain additional administrative services at no cost to the Plan.

**Note 6. Plan Termination**

Although it has not expressed an intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions accounts.

**Note 7. Tax Status**

The Plan operates under an adoption agreement in connection with a nonstandardized prototype retirement plan and trust document sponsored by ADP, LLC. The prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.
