Note 1 – Description of the Plan

The following description of CLA USA, Inc. 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan and includes the employees of CLA USA, Inc., CLA Estate Services, Inc., Winning Strategics Marketing, Inc., Templar Management, LLC, CLA Estate Planning, LLC, Carol Loper & Associates, Inc., CLA Financial Services, Inc., CLA Insurance Group, Inc., Eagle Estate Service, Inc., and Eagle Financial Group, Inc. (collectively, the “Plan Sponsor” or “Company”) to participate in the Plan upon meeting the eligibility requirements, as defined. The Plan is established under Section 401(a) of the Internal Revenue Code (“IRC”), which includes qualified cash or deferred arrangements as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Effective March 27, 2020, the Plan administratively adopted the provisions of the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”), related to participant loans and distributions. The Plan Sponsor has until December 31, 2025 to amend the Plan for changes allowed by the CARES Act. The Plan has not been formally amended to adopt these provisions as of December 31, 2024.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE 2.0”) was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first plan year beginning on or after January 1, 2025 to amend the Plan for changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of December 31, 2024.

Plan Administration

The Plan Sponsor is responsible for the administration and operation of the Plan. Reliance Trust Company serves as the Plan’s directed trustee (“Trustee”) and is responsible for the custody and management of the Plan’s assets. Accordingly, the trustee has been granted discretionary authority concerning investment and management activities. ADP, Inc. (“ADP”) provides recordkeeping and administrative services to the Plan and is responsible for maintaining participant accounts and transactions related to participant initiated activity.

Eligibility

Participants are eligible to make elective deferral contributions and receive Company matching contributions on the first day following the completion of one year of service and attaining the age of 21. Participants are eligible to receive Company profit sharing contributions after completing one year of eligible service, defined as 1,000 hours of service in a given plan year.

Participant Contributions

Eligible participants are permitted to contribute from 1% up to 90% of their eligible annual compensation, as defined by the Plan, and subject to the maximum contribution under Section 402(g) of the IRC, of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. For 2024, the maximum allowable pre-tax contribution under the IRC rules was \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollovers). Participants direct the investment of contributions into various investment options offered by the Plan.

Company Contributions

Company matching contributions are discretionary. The Company may also make discretionary profit sharing contributions. During the year ended December 31, 2024, the Company made no matching or profit sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and rollover contributions, and allocations of (a) the Company's contributions, (b) Plan earnings (losses), and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and earnings thereon. Vesting in the Company's discretionary matching contribution and profit sharing contribution portion of their accounts, plus actual earnings thereon, is as follows:

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$500, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The maximum number of loans outstanding at any time for any participant is two. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan's administrator at the time the loan is approved. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are determined by the Plan's administrator when any scheduled repayment remains unpaid at the end of the cure period, as specified in the separate loan agreement, or there is an outstanding principal balance existing on a loan after the last scheduled repayment date. Upon default, the Plan's administrator shall direct the Trustee to reclass the unpaid balances and foreclose on the promissory note and offset the participant's vested account interest as soon as a distributable event occurs.

Payment of Benefits

On termination of service due to death, disability, or retirement, benefit payments under the Plan are made as a lump-sum payment as requested by the participant, equal to the value of the participant's vested interest. For terminated participant balances less than \$7,000 individually, the Plan shall disburse on behalf of the participant or their designated beneficiary, via a direct rollover, as determined by the Plan's administrator. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants are permitted to request in-service distributions from their vested Plan accounts at any time after having attained age 59 ½. Hardship distributions are permitted subject to certain limits, pursuant to the plan provisions.

Forfeitures

Forfeitures represent unallocated, unvested portions of terminated participants' accounts. These funds may be used to pay administrative expenses or to reduce future employer matching or discretionary profit-sharing contributions. Unallocated forfeitures available for use total \$5,354 and \$2,558 as of December 31, 2024 and 2023, respectively. No forfeitures were used to reduce Company contributions or pay administrative expenses during 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. The Plan has no obligation to reimburse the Company for expenses paid on its behalf. Fees related to the administration of distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Note 2 – Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements are as follows:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

In preparing financial statements, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of statement of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates. Significant items subject to such estimates and assumptions include the fair value of investments.

Investment Valuation and Income Recognition

Plan assets are invested in mutual funds and a stable value fund. Investments in mutual funds are stated at fair value as determined on the open market while the stable value fund is stated at fair value as determined by the fund issuer. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes realized gains and losses on investments bought and sold, as well as held during the year.

Contributions and Receivables

Contributions from participants are recorded based on the date the contribution has been separated from a participant's pay by the Employer, which is the pay date.

Employer matching contributions and employer profit sharing contributions, if any, are recorded in the year they are earned and to coincide with the year which the Employer records the contribution to its general ledger. The Plan records receivables for contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when earned. No allowance for credit losses has been recorded as of 2024 and 2023.

Benefits Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses by the Plan are recorded when incurred. Accruals for Plan expenses not related to benefit payments are recorded when due.

Subsequent Events

The Plan has evaluated subsequent events through June 11, 2025, the date the financial statements were available to be issued. No subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

Note 3 – Information Prepared and Certified by the Trustee

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, the Trustee, Reliance Trust Company, the qualified institution of the Plan, has supplied the plan administrator with a certification as to the completeness and accuracy of all investment information related on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Accordingly, as requested by the plan administrator, the Plan's independent auditor performed no audit procedures on the certified information other than to agree the certified information to the related information included in the financial statements and supplemental schedule.

Note 4 – Fair Value Measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual funds – The fair value is determined on the basis of quoted prices in an active market. Shares of mutual funds are valued at the net asset value (NAV) of shares held by the Plan on the last business day of the Plan year where the price of the fund is quoted in an active market and are classified within level 1 of the valuation hierarchy.

Stable Value funds – Stable value funds are a common/collective trust funds (CCT) and are valued at the NAV, as determined by the issuer. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the CCT, the issuer reserves the right to require a twelve-month notification in order to ensure that securities liquidations will be carried out in an orderly business manner. Investments in the CCT can be redeemed daily and there are no unfunded commitments. Accordingly, these NAV-based investments have been excluded from the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 6 – Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA Plan sponsored by ADP, LLC (the “ADP Plan”). On October 6, 2020, the Internal Revenue Service (“IRS”) stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”) and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Note 6 – Tax Status (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

Note 7 – Party-In-Interest Transactions

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Company, and certain others. As such, transactions conducted by Reliance Trust Company and ADP qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company discretionary profit-sharing contributions.
