Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Super Care Inc. 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. Description of Plan

The following description of the Super Care, Inc. 401(k) Profit Sharing Plan & Trust (the "Plan") is provided for general information purposes. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit-sharing plan for the eligible employees of Super Care, Inc. (the "Company"). The defined contribution plan was established effective January 1, 1996, as restated October 12, 2021. The Plan has a pretax salary reduction provision as defined under Section 401 of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). On July 9, 2022, the management of the Plan sponsor elected to merge the Plan with the Rick's Medical Supply 401(k) Plan. On January 6, 2023, the plans were merged, and the surviving plan was amended.

Eligibility

The Plan covers all employees, excluding union employees, leased employees, and non-resident aliens. For purposes of employer matching contributions and non-elective contributions, the term "eligible employee" will not include an employee as the result of a transaction described in Code Section 401(b)(6)(C). All employees of the Company are eligible to participate in the Plan provided they are 21 years or older and have been employed with the Company for six months or more. Employees can enter the Plan at the start of the following quarter after satisfying the eligibility requirements.

Contributions

Effective July 1, 2024, each year, participants may contribute up to 90% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code ("IRC"). Prior to July 1, 2024, the limit was 92% of pretax annual compensation. Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe harbor matching participant contributions at a rate of 100% of the participant's compensation that is deferred up to 3% of the participant's compensation and 50% of the participant's contributions that exceed 3% but do not exceed 5%. For the year ended December 31, 2024, the Company made safe harbor matching contributions of \$680,173.

Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Participant accounts are credited with the participant's contributions and allocations of (a) the Company's discretionary contributions, (b) the Company's matching contributions, and (c) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, participant contributions, or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions plus actual earnings thereon. A participant is 100% vested in his or her non-elective contributions after three years. A participant is 100% vested in his or her employer matching contributions after six years of credited service. A participant is 20% vested after two years of credited service and continues to vest in increments of 20% until 100% vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 for up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be repaid over a period not extending beyond five years from the date of the loan, unless such loan is used to acquire a principal residence. The maximum loan term for a principal residence loan is 10 years. The notes receivable are secured by the vested balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates, as determined by the Plan administrator. Interest rates on participant loans ranged from 4.25% to 9.5% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Benefit Payments

Upon reaching retirement age or upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, an annuity, or periodic installments over a period not to exceed certain prescribed life expectancy limits.

Participants are fully vested and entitled to receive their full account balance upon retirement, disability, or death. Upon reaching the retirement age of 65 or upon termination of service, a participant may elect to receive a lump-sum payment equal to the vested value of his or her account.

Forfeited Accounts

As of December 31, 2024 and 2023, there were \$10 and \$0, respectively, of forfeited nonvested amounts. Forfeitures may first be used to pay any administrative expenses. During 2024, employer contributions were reduced by \$3,343, from forfeited nonvested accounts, in accordance with plan provisions.

Investments

Each participant directs the allocation of his or her contribution, and employer-matching and discretionary contributions, to a variety of investment options offered by the Plan.

Administrative Expenses

Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan's investments reported at fair value consist of registered investment companies and pooled separate accounts ("PSAs") valued at fair market value and net asset value ("NAV") as a practical expedient, respectively. Accordingly, these investments are excluded from the fair value hierarchy disclosures.

PSAs are valued at NAV, which is based on the fair value of the underlying investments of the PSAs, less any liabilities. The underlying investments of the PSAs are mainly equity and fixed income securities and short-term investments. The investment strategies of the Plan's PSAs vary generally based on the investment objectives of the asset class of which they are a part. Such investment strategies include investments in fixed income securities and investments in equity securities in domestic and international markets for growth and value objectives, as well as the ability to replicate market indexes and to invest in emerging markets. The Plan had no funded commitments related to PSAs. The redemption of PSAs is subject to the preference of individual Plan participants and contains no restriction on the timing of redemption.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2024 and 2023.

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued based upon the unit values of such pooled accounts held by the Plan at year-end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from, or corroborated by, observable market data by correlation or other means and are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its evaluation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Information Certified by the Plan's Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, ADP Retirement Trust Services, LLC, the current Custodian of the Plan, has certified the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statement of net assets available for benefits, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the period from July 1, 2024 through December 31, 2024. John Hancock Life Insurance Company, the previous Custodian of the Plan, has certified the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statement of net assets available for benefits as of December 31, 2023, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the period from January 1, 2024 through June 30, 2024.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. Party-In-Interest Transactions

Certain Plan investments are units of pooled separate accounts managed by John Hancock. John Hancock was the custodian until June 30, 2024 as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Additionally, notes receivable from participants and the related interest income are considered exempt party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of the investment.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. Tax Status

The Company is using a non-standardized preapproved profit-sharing plan which received a favorable opinion letter on June 30, 2020. The Plan has been amended and related since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2024 and 2023, three and two investments, respectively represented a concentration of greater than 10% of the Plan's net assets available for benefits.

9. Subsequent Events

The Plan evaluated subsequent events that occurred after December 31, 2024 through July 14, 2025, the date when the financial statements were available to be issued. Except as disclosed in the paragraph below, no material subsequent events have occurred that require recognition or additional disclosure in these financial statements.

Effective January 1, 2025, the Plan sponsor's management elected to allow Roth deferrals, remove the safe harbor match, implement automatic enrollment at 4% for all non-participating employees with a 1% annual escalation to a maximum of 10%, the annual discretionary match vesting schedule changed from 6-year graded to 5-year graded, reduce the service requirement for plan eligibility from six months to three months and change when employees can enter the plan from the start of the following quarter to the following month. These subsequent events had no impact on the audit as of December 31, 2024.
