1. Description of Plan

The following description of the Emtec Global Services, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Emtec Global Services, LLC (the Company) who are age twenty or older. Effective October 1, 2008, any "temporary W-2 employee" who has commenced employment after July 1, 2008, has completed one year of service and has attained age 20 shall be eligible to participate in the plan. After reaching eligibility, participants are automatically enrolled in the Plan with a 3% deferral rate which will escalate by 1% on or after the first day of each succeeding Plan Year after the Plan Year that the Participant's Automatic Deferrals first were implemented under the applicable arrangement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 90% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan may make discretionary matching contributions. In 2024, the Plan contributed 50% of participant deferrals up to 6% of compensation deferred by participant. In addition, the Plan may make a discretionary profit-sharing contribution at the end of the Plan year. Only eligible employees who have completed 1,000 hours of service and are employed on December 31st will be eligible to receive an allocation. Contributions are subject to certain limitations. No discretionary contributions were made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the matching and/or profit sharing contribution's and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant compensation or contributions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 40% vested after two years of service and an additional 20% each year thereafter. A participant is 100% vested after five years of service.

Participant Loans

Participant loans are classified as notes receivable from participants, which are segregated from plan investments and measured at their unpaid principal balance plus any accrued but unpaid interest.

Participants may borrow from their fund accounts a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loan terms range from 1 to 5 years and bear interest at Prime plus 1%. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. The loans are measured at unpaid principal balance plus accrued but unpaid interest.

1. Description of Plan, continued

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may also receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

Forfeitures attributable to employer contributions are retained in the Plan and will be first used to pay administrative expenses. Any remaining amounts will be used to reduce future employer contributions payable under the plan. As of December 31, 2024 and 2023, respectively, the Plan had \$143,581 and \$76,016 net forfeitures available for reduction of future employer's contributions. During the year ended December 31, 2024, the Plan received additional forfeitures and interest of \$144,083, and \$76,518 was used to pay plan administration fees and offset employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Fair Value Accounting

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Valuation techniques used in fair value measurements need to maximize the use of observable inputs and minimize the use of unobservable inputs. A valuation method may produce a fair value measurement that may not be indicative of net realizable value or reflective of future fair values. The Plan's Trustees determine the valuation policies utilizing information provided by the investment advisers and custodians. Furthermore, although the Plan's Trustees believe their valuation methods are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions could result in different fair value measurements at the reporting date. The expanded disclosure requirements are included in Note 3.

Allowance for Credit Losses

When the company records customer receivables, contract assets, and financing receivables arising from revenue transactions, the company records an allowance for credit losses for the current expected credit losses (CECL) inherent in the asset over its expected life. The allowance for credit losses is a valuation account deducted from the amortized cost basis of the assets to present their net carrying value at the amount expected to be collected. Each period the allowance for credit losses is adjusted through earnings to reflect expected credit losses over the remaining lives of the assets. We evaluate debt securities with unrealized losses to determine whether any of the losses arise from concerns about the issuer's credit or the underlying collateral and record an allowance for credit losses, if required.

Contributions

Contributions to the Plan are recorded in the period that payroll is taken from Plan participants. Employer matching contributions are recorded based on employee contributions during the period.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. The employer absorbs recordkeeping, accounting, legal, and trustee service fees.

Payment of Benefits

Benefits are recorded when paid.

Reclassifications

Certain reclassifications have been made to prior year's balances in order to conform to current year presentation.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

9. Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Tax Status

The Plan obtained its latest determination letter on October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.
