As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions and maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1 - Plan Description**

The following brief description of the SBM Offshore USA, Inc. Savings and Retirement Plan (the Plan) is provided for general information only. Participants should refer to the plan document for more detailed information.

**General**

The Plan is a defined contribution plan covering eligible employees of SBM Offshore USA, Inc., and participating employers (collectively, the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was adopted by the Company on July 16, 1990, and has since been amended and restated. Vanguard Fiduciary Trust Company (Vanguard) serves as the Plan's trustee and The Vanguard Group, Inc. serves as the Plan's recordkeeper. SBM Offshore USA, Inc. is named as the plan administrator in the plan document.

**Eligibility**

Provided an employee is not an excluded employee, as defined in the plan document, he or she is eligible to participate in the Plan on the first day of the calendar quarter coinciding with or following his or her date of hire.

**Contributions**

The Plan is a defined contribution plan to which participants may defer pre-tax or Roth contributions up to 100% of their compensation, as defined in the plan document, subject to limitations set forth in the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, subject to the limitations of the IRC.

The Company may make discretionary matching contributions limited to 6% of eligible compensation. For the year ended December 31, 2024, the Company matched 50% of the first 6% of eligible compensation contributed by the participant. The Company also makes a safe harbor contribution equal to 3% of each eligible employee's base compensation, as defined in the plan document. Additional discretionary profit-sharing contribution amounts may be contributed at the option of the Company. For the year ended December 31, 2024, the Company did not make an additional discretionary profit-sharing contribution.

**Vesting and Forfeitures**

Participants are fully vested at all times in their contributions plus actual earnings thereon and in the Company safe harbor contributions plus actual earnings thereon. A participant's interest in the discretionary matching contributions and discretionary profit-sharing contributions made by the Company vests in annual increments of 20% after one year of service, becoming 100% vested after five years of service.

The Plan has a special provision stating that once a participant reaches the age of 55, the participant is fully vested in all money sources, regardless of years of service.

Forfeited discretionary matching contributions and discretionary profit-sharing contributions from unvested participants who have terminated are used to reduce the Company's future contributions or to pay plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$18,830 and \$6,386, respectively. During 2024, forfeitures of \$41,583 were used to offset discretionary matching contributions.

**Participant Accounts**

Upon enrollment in the Plan, a participant may direct the investment of his or her account balance. The investment options available include mutual funds and a common/collective trust fund. Participants may change their investment options at any time. Investment income or loss, net of certain investment-related expenses, is allocated daily to participants based on their respective balances in the funds.

**Notes Receivable from Participants**

Participants may borrow from their vested accounts, for a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance in the previous 12 months or 50% of their account balance. The term of the notes are generally up to five years, unless used for the purchase of a principal residence, in which case the term may be extended to 30 years. The notes are secured by the balance in the participant's account and bears interest at a rate of the prime rate plus 2% at the time the loan is issued. The loans are repaid through payroll deductions or direct payment by the participant.

**Benefit Payments**

Distributions may be made to participants upon termination of employment, retirement, death or disability. A participant may elect to receive their distribution in the form of a lump sum amount or installments, equal to the value of the participant's vested interest in his or her account. In-service distributions are permitted for certain age-related reasons or by anyone requesting a distribution from their participant rollover account. In the event of an immediate and heavy financial need, as defined by the Plan, participants may request a hardship distribution of their elective contributions.

Upon termination, participants with a vested account balance of \$1,000 or less shall receive an automatic lump sum distribution from the Plan. For participants who terminate with a vested account balance of more than \$1,000 but less than \$5,000, the plan administrator shall make a direct rollover into an individual retirement account. Upon withdrawal from the Plan, participants may be subject to taxes on contributions and income earned.

**Note 2 - Summary of Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are presented using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes realized gains or losses on investments sold during the year as well as unrealized gains or losses on the investments held at the end of the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023, as the notes are collateralized by the participants' account balances. In general, notes receivable from participants are considered in default 90 days following a missed loan repayment. Defaulted notes receivable are treated as distributions based upon the terms of the plan document when a distributable event has occurred. Interest income is recorded on the accrual basis.

**Benefit Payments**

Benefits paid to participants or beneficiaries are recorded when paid.

**Administrative Expenses**

Fees and expenses incurred in the administration of the Plan, are paid by the Company at its discretion, to the extent not paid by the Plan.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and market risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and may impact participants' account balances, and the amounts reported in the financial statements.

**Subsequent Events**

The plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 24, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Information Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Vanguard Fiduciary Trust Company as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that all of the information is complete and accurate. Information included in the financial statements and accompanying notes to financial statements as to investments, notes receivable from participants, interest and dividend income, net appreciation in fair value of investments, interest income on notes receivable from participants and all of the related information in the supplemental schedule of assets (held at end of year) is presented in reliance solely upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements, the accompanying notes, and the supplemental schedule of assets (held at end of year).

**Note 4 - Fair Value Measurements**

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* These are valued on a daily basis based upon their quoted market prices.

*Common/Collective Trust Fund:* This fund is valued at its net asset value (NAV) as determined by the issuer, based on the value of the underlying investments, less applicable fees charged by the issuer. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

**Note 5 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and all balances will be distributed.

**Note 6 - Tax Status**

Effective January 1, 2022, the Plan was amended and restated via its adoption of a pre-approved plan. The pre-approved plan received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that it was in compliance with the applicable requirements of the IRC. The pre-approved plan has been amended since receiving its IRS letter; however, the plan administrator believes that the Plan continues to be designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Party-in-Interest Transactions**

Certain investments offered by the Plan are mutual funds managed by an affiliate of the trustee. Therefore, the Plan's investment transactions in these funds qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions of ERISA and the IRC.
