Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Sawdey Solution Services, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1. Description of the Plan

The following description of Sawdey Solution Services, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description or the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all employees of Sawdey Solution Services, Inc. (the Company and Plan sponsor) and affiliates who have attained 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute amounts up to certain limitations as stipulated by applicable Internal Revenue Code (IRC) Code Sections. Pre-tax elective deferrals and after-tax Roth contributions are available. Participants who have attained age 50 by the end of the year are eligible to make catch-up contributions.

The Plan Sponsor makes a required matching contribution which is equal to 100% of the first 3% deferred by a participant plus 50% of the next 2% deferred a participant. The Plan also allows for additional discretionary contributions. There were no such discretionary contributions made by the Plan Sponsor for the 2024 Plan year.

Participant accounts

Each participant's account is credited with the participant's contributions, Company contributions, and actual earnings thereon. Each participant's account is charged with his or her withdrawals and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions, rollover contributions, and employer required matching contributions, plus actual earnings thereon. Vesting in the additional discretionary matching contributions plus earnings thereon is based on years of continuous service. Participants vest in additional discretionary contributions after six years of credited service. Earlier vesting may occur upon death or disability.

Forfeitures

There were forfeited, non-vested account balances of \$663 and \$836 at December 31, 2024 and 2023, respectively. Forfeited amounts can be used to reduce Plan expenses and offset future employer contributions. During 2024, forfeited, non-vested accounts of \$3,445 were used to reduce employer contributions.

Payment of benefits

Upon termination of service due to disability, death, retirement, or other reasons, a participant may elect to receive a lump-sum payment equal to the value of the participant's vested interest in their account. Hardship distributions are also permitted, as defined by the Plan.

Notes receivable from participants

Participants may borrow from their fund accounts. Loans may not exceed the lesser of \$50,000 or 50% of a participant's vested account balance and the repayment period shall not exceed five years. Each loan is collateralized by the remaining balance in the participant's account. Interest rates on participant loans ranged from 3.25% to 8.50% as of December 31, 2024 and 2023.

Investment options

Participants may direct the investment of their accounts into various investment options offered under the Plan. Participants may change their investment choices on a daily basis.

Note 2. Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Accounting Standards Codification (ASC) as produced by the Financial Accounting Standards Board (FASB) is the sole source of authoritative U.S. GAAP.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from estimates as additional information becomes available in the future.

Investment valuation and income recognition

Investments held by the Plan are reported at fair value, with the exception of the guaranteed investment contract (GIC), which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value generally reflects amount participants would receive if they were to initiate permitted transactions of the Plan and is the relevant measure for the portion of assets attributed to fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Notes receivable from participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

A significant portion of the Plan's administrative expenses are paid by the Plan Sponsor.

Investment management fees and operating expenses.

Investment management fees and operating expense charged to the Plan for investments in various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair value of investments.

Date of management's review

Subsequent events have been evaluated by management through August 05, 2025, the date the statements were available to be issued.

Note 3. Information Certified by the Plan's Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Voya Retirement Insurance and Annuity Company, the custodian of the Plan, has certified to the completeness and accuracy of all investment information reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Schedule of Assets (Held at End of Year) at December 31, 2024, and the related net appreciation in fair value of investments information reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

Note 4. Guaranteed Investment Contract

The Plan holds an interest in VOYA Fixed Account Fund, a guaranteed investment contract (GIC). Contributions to Voya Institutional Trust Company (Voya) under this contract are maintained in general accounts that are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the contract underlying this investment option meets the criteria to be considered fully benefit-responsive, it is reported at contract value in the statements of net assets available for benefits. Contract value, as reported to the Plan by VOYA represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Contract value may be subject to adjustments in connection with contract holder directed withdrawals that are subject to market value adjustment or under limited circumstances for certain in-service participant withdrawals.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,226,374 and \$1,294,139, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer of the fund. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan, (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the GIC issuer to terminate the contract with the

Plan. Examples of such events include (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract, and (4) a material misrepresentation. The Plan administrator is not aware of the occurrence or likely occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants.

The crediting interest rate for the fund is reset daily by the issuer but cannot be less than 3%. The crediting interest rate is based upon a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. A market value adjustment may apply to amounts withdrawn at the request of the contract holder. Under the terms of the contract, the Plan Sponsor must provide a minimum of 90 days notice to Voya prior to redemption of the contract.

Note 5. Fair Value Measurement

FASB ASC 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Party-in-Interest Transactions

Certain administrative services are provided by the Company at no cost to the Plan and certain administrative costs incurred by the Plan are paid by the Company.

The Plan's administrative fees result from services rendered by parties-in-interest.

Certain Plan investments are units of investment contracts managed by Voya Institutional Trust Company. Voya Institutional Trust Company is affiliated with the trustee, Voya Retirement Insurance and Annuity Company, and therefore, these transactions qualify as party-in-interest transactions.

Note 7. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in their accounts.
