### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of THE QUMULUS 401(K) PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of THE QUMULUS 401(K) PLAN's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Principal Trust Company, a qualified institution, as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**NOTE 1—PLAN DESCRIPTION**

The Qumulus 401(k) Plan and Retirement Trust (the “Plan”) is a defined contribution plan designed to operate under the provisions of Section 401(k) of the Internal Revenue Code (“IRC”). The Plan covers all eligible employees of QSRSoft, LLC (the “Company”) who are age 18 or older. Employees of the following companies in the controlled group can also join the plan: Duneland Property Management LLC; Henkel Management, LLC; QSR Services, LLC. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The following description of the Plan provides only summary information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

The plan was originally effective January 1, 2015. The Plan was amended and restated as of January 1, 2022.

**ELIGIBILITY**

Employees age 18 or older (other than those covered by a collective bargaining agreement and non-resident aliens) are eligible to make deferrals and rollovers to the Plan and receive Company discretionary and safe harbor contributions.

**CONTRIBUTIONS**

Eligible employees may elect to defer up to 100% of eligible compensation on a pre-tax basis, after-tax basis (“Roth”), or a combination of both. These contributions are subject to certain limitations of the IRC. The maximum amount able to be deferred for 2024 and 2023 was \$23,000 and \$22,500, respectively. Participants who are at least age 50 may make additional “catch-up” contributions. The maximum amount for the catch-up contributions was \$7,500 for 2024 and 2023. The Plan has the automatic enrollment feature for all employees, which starts at 6% and increases 1% each year until reaching 10%, unless employees change their contribution rates. Participants may also roll over amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe harbor contributions of 3% of compensation in order to satisfy Code section 401(k)(12). The Company can also elect to make discretionary profit-sharing contributions.

**PARTICIPANT ACCOUNTS**

Each participant’s account is credited with the participant’s contribution, the Company’s safe harbor contribution, and an allocation of the Company’s discretionary profit-sharing contribution, if applicable, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant contributions, plan compensation, or account balances, as defined by the Plan document. Participants are entitled to the vested portions of their accounts.

Participants are 100% vested in their elective deferrals, rollover contributions and safe harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary contributions portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after six years of credited service.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Loans are not permitted to be taken from the Plan.

**PAYMENT OF BENEFITS**

Upon retirement after attaining age 65, a participant may elect to receive a lump sum payment. Only partial installment distributions are permitted for required minimum distributions. An entire account balance can be paid to a beneficiary upon the death of a participant. Force-out distributions can be made for balances not exceeding \$5,000. In-service withdrawals can be taken for certain financial hardship circumstances. Rollover account balances can be withdrawn at any time.

**FORFEITURES**

Forfeited non-vested accounts are used to reduce employer contributions or pay expense of the Plan. In 2024 and 2023, forfeitures in the amount of \$9,010 and \$21,067 were used to fund a portion of the employer contributions, respectively. In 2024 and 2023, forfeitures in the amount of \$1,746 and \$1,928 were used to pay expenses of the Plan, respectively. Forfeitures available for future use were \$-0- as of December 31, 2024 and \$1,275 as of December 31, 2023, respectively.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES****BASIS OF ACCOUNTING**

The accompanying financial statements have been prepared using the accrual basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

## INVESTMENT VALUATION AND INCOME RECOGNITION

Investments held by a defined contribution plan are required to be reported at fair value, except for investments with contract values. Contract value is the relevant measure for those investments because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. The Plan's investments at December 31, 2024 and 2023 were held by Principal Trust Company (Principal). Investments other than the Principal Fixed Income Guaranty Option are stated at fair value as of December 31, 2024 and 2023. In accordance with U.S. GAAP, this investment is excluded from the fair value hierarchy. Investments in mutual funds are valued at the net asset value of shares held by the Plan at year-end.

The Principal Fixed Income Guaranteed Option is a fully benefit-responsive investment contract. It is a single group annuity contract with a fixed rate of interest. Under the terms of the contract, the composite crediting rate is reset on a semi-annual basis and will never be less than the guaranteed minimum interest rate. Contract value, as reported to the Plan by Principal, represents participant contributions and earnings, less withdrawals and administrative expenses. At December 31, 2024 and 2023, fair value and contract value were equal. Fair value is the amount a plan sponsor would receive if they were to withdraw or transfer funds prior to maturity. This event is not probable to occur. The fair value represents the discontinuation value or 95% of the contract value. The 5% surrender face is described in the contract. The market yield for the Fund was 1.10% from December of 2022 through June of 2023 and .90% from July of 2023 to December of 2024.

Purchases and sales of securities are reflected on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation of fair value of investments held represents the change in market value of the investments from the beginning of the Plan year (or date the investments were purchased, if later) to the end of the Plan year.

## PAYMENT OF BENEFITS

Benefits are recorded when paid.

## ADMINISTRATIVE EXPENSES

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

**NOTE 3—FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Level 1 Fair Value Measurements**

Mutual funds are valued at quoted net asset values of the shares held by the Plan at year-end.

**Level 2 and Level 3 Fair Value Measurements**

Level 2 and Level 3 Fair Value Measurements are not applicable to the Plan for 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4—INFORMATION CERTIFIED BY TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C). Accordingly, Principal Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and schedule is complete and accurate.

- a. Investments, as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- b. Investment income, as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- c. The schedule of assets (held at end of year) as of December 31, 2024, as shown on Schedule H - Line 4(i).

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 5—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Company provides to the Plan certain accounting and administrative services for which no fees are charged. In addition, the majority of the expenses of the Plan are paid by the Company.

Plan investments are managed by Principal Trust Company (“Principal”), the trustee of the Plan. Various fees are paid to Principal for these services, some of which are deducted from plan earnings. The Plan’s investment advisor is also paid various fees from the Plan. Principal and the investment advisor are parties-in-interest.

**NOTE 6—PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan at any time subject to the provisions of ERISA. If the Company should decide to terminate the Plan, participants would become 100% vested in the discretionary Company profit-sharing contribution portion of their accounts.

**NOTE 7—TAX STATUS**

The Plan has adopted the CCH Incorporated Non-Standardized Pre Approved Profit Sharing Plan With CODA. CCH has obtained a letter from the Internal Revenue Service (IRS) dated June 30, 2020 which states that the non-standardized plan is acceptable for use by employers for the benefit of their employees under Internal Revenue Code (IRC) Section 401. Although the Plan has been amended since the date of the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8—RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9—PROHIBITED TRANSACTIONS**

401(k) and Roth deferrals totaling \$6,871 from a payroll in February of 2024 which were not remitted to the trust in a timely manner were corrected on July 16, 2025 through the Voluntary Fiduciary Correction Program with the U.S. Department of Labor. Lost earnings were calculated and applied to the accounts of the affected plan participants.

401(k) and Roth deferrals totaling \$7,660 from a payroll in February of 2023 which were not remitted to the trust in a timely manner were corrected on September 25, 2024 through the Voluntary Fiduciary Correction Program with the U.S. Department of Labor. Lost earnings were calculated and applied to the accounts of the affected plan participants.

**NOTE 10—SUBSEQUENT EVENTS**

Management has evaluated subsequent events through July 29, 2025, the date which the financial statements were available for issue. There were no subsequent events which require disclosure.
