### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Continental Envelope Corporation Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income and Securities Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### NOTE A--DESCRIPTION OF PLAN

The following description of the Continental Envelope Corporation Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is sponsored by Continental Envelope Corporation (the "Company") for employees of the Company. The Plan, designated as a defined contribution plan, was established on March 27, 1972, and has been amended and restated, effective January 1, 2015. The restatement in January 2015 was to adopt a new prototype plan (see Note E); no plan terms were changed. The Plan was amended in March 2020 to provide optional relief items for the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act"). The Plan was amended effective January 1, 2021 to comply with the Bipartisan Budget Act of 2018 and final regulations related to hardship distributions the Plan's prototype adoption agreement. The Participant vesting requirements were also changed from a 6-year graduated scale to a 3-year cliff. The Plan was most recently restated effective February 18, 2022, to adopt an update to the non-standardized pre-approved plan offered by Principal Life Insurance Company (see Note J). The Plan provides for contributions to be made under salary deferral agreements pursuant to Section 401(k) of the Internal Revenue Code (the "Code"). The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 ("ERISA").

The Plan Trustee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### Contributions

Participants are eligible to participate in the Plan on their hire date. Eligible participants are automatically enrolled into the Plan to defer at 5% of the employee's compensation into the Plan. If the participant does not choose a different deferral percentage, subsequent to being automatically enrolled, the deferral percentage will be automatically increased each January 1 by 1% up to a maximum of 12%. Amounts deferred under the automatic deferral provisions of the Plan are invested in the appropriate Principal Trust Target Date Fund. Participants may contribute pre-tax compensation to the Plan by means of a salary deferral agreement not to exceed the maximum percentage permitted by law of their annual compensation. Contributions are subject to limitations as provided in the Code and as described in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans in accordance with Plan provisions. Salary deferral contributions are funded proximate to the withholding date. Participants may elect to treat all or part of their elective deferrals to the Plan to be treated as after-tax Roth contributions.

The Company may make discretionary matching contributions in accordance with Plan provisions. Additional amounts may be contributed at the option of the Company's board of directors under qualified matching and qualified nonelective contribution provisions of the Plan. Company contributions are funded annually after the close of the Plan year and within statutory time frames. All contributions are subject to certain limitations as defined in the Plan.

Participants direct the investment of all deferral and allocated Company contributions into various investment options offered by the Plan.

### NOTE A--DESCRIPTION OF PLAN-continued

#### Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's discretionary contributions, if any, as well as allocations of Plan earnings (loss), and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Investment Options

Upon enrollment in the Plan, participants may direct employee contributions in one or more of the investment options offered by the Plan. The current investment choices are more fully described in the Plan's literature. Participants may change their investment options at any time in accordance with Plan provisions, however, certain charges and restrictions may apply. The Plan currently offers various investment options, which include a diverse group of registered investment companies, pooled separate accounts and common collective trust funds.

#### Vesting

Participants are immediately vested in their voluntary contributions and in qualified nonelective Company contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts, plus earnings thereon, is based on years of credited service. Participants are 100% vested after three years of credited service.

Participants who attain the normal retirement age of 65, or who terminate employment due to death or disability, are 100% vested in their account balances.

#### Payment of Benefits

Upon termination of employment due to death, disability, retirement or Plan termination, a participant is entitled to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or partial payments in accordance with Plan provisions. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution in accordance with Plan provisions. There were no benefits allocated to participants who elected to withdraw from the Plan but had not yet been paid at December 31, 2024 and 2023.

#### **Payment of Benefits-continued**

All distributions will be made as soon as administratively feasible. Mandatory distributions greater than \$1,000 but less than \$5,000, may be paid in a direct rollover to an individual retirement plan designated by the Plan Administrator. These distributions will be made if a participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or does not elect to receive the distribution directly. If a participant has a vested account balance greater than \$5,000, they are not required to take a distribution from the Plan until required distribution rules apply.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of a participant's vested account balance, reduced by an outstanding loan balance, or \$50,000 reduced by the highest outstanding loan balance during the one-year period ending on the date before the loan is made and bear a reasonable rate of interest (5.25% to 10.50% at December 31, 2024 and 2023) commensurate with local prevailing rates as determined by the Plan Administrator. Loans are for a period not to exceed five years, unless it is for the purchase of a principal residence, which allows for a term of the lesser of 10 years or a period of years consistent with commercial home loan practices. Principal and interest shall be paid ratably by participants through payroll deductions.

#### **Forfeited Accounts**

Forfeited nonvested accounts may be used to pay Plan expenses and to reduce future employer contributions. Any forfeitures left after paying Plan expenses may be used to reduce future employer contributions, as directed by the Plan sponsor. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,963 and \$9,129, respectively. During the years ended December 31, 2024 and 2023, the Plan used \$ - and \$2,983, respectively of the forfeited nonvested accounts to reduce the employer matching contributions.

### **NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and Custodian (see Note C).

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on an accrual basis. Dividends are recorded at the ex-dividend date.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loans to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Expenses specifically incurred by or attributable to a specific participant are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation of fair value of investments.

#### Accounting Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### Date of Management's Review

Subsequent events were evaluated through July 25, 2025, which is the date the financial statements were available to be issued.

### NOTE C--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Gains and losses (realized and unrealized) are reported as net appreciation (depreciation) in the fair value of investments in the Statement of Changes in Net Assets Available for Benefits.

Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the assets, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities' liquidations will be carried out in an orderly business manner. These funds represent investment in actively managed collective investment trust funds that invest primarily in a variety of mutual funds, Principal Life separate accounts and collective trust funds. The investments are valued at the fair value per unit multiplied by the number of units held as of the measurement date.

Following is a description of the valuation methodologies used for Plan assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies value mutual funds at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The stable value collective investment trust is valued at the NAV of units of the Principal Trust Company collective trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities' liquidations will be carried out in an orderly business manner.

Shares of pooled separate accounts are valued at the NAV of units held by the pooled separate account. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV for the pooled separate accounts is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The Trust Income Fund and Target Retirement Funds (common collective trust funds) are valued at the net asset value ("NAV") of units of the applicable Fund. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value, using the market approach. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE D--INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

Except for comparing such information as certified by the Custodian to information included in the Plan's financial statements and supplemental schedule, the Plan's independent auditors did not perform any auditing procedures on the certified information. ### NOTE E--TAX STATUS

On June 30, 2020, the Internal Revenue Service stated that the prototype plan document, subsequently adopted by the Plan, as then designed as qualified under section 401(k) of the Internal Revenue Code (the "IRC"). The Plan has been amended and restated since receiving the determination letter. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### NOTE F--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

### **NOTE G--RISKS AND UNCERTAINTIES**

The Plan's assets are invested directly and indirectly in various investment securities which are purchased or managed by the Custodian. Investments are exposed to various risks such as interest rate, market, and credit risks. The Plan's assets are subject to the changes in value of these underlying investments, including the potential for bankruptcy of one or more of the companies in which they are invested.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The participants who have borrowed from the Plan are all employees of the Company in the Chicagoland area, and their ability to repay the notes could be affected by the economic conditions in the industry in general, the economic conditions in the Chicago metropolitan area or the economic situation of the Company itself.

### **NOTE H--RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain employees of the Company provide administrative services for the Plan and are not reimbursed for their services. Certain other administrative expenses are paid by the Company on behalf of the Plan. These amounts are not material to the financial statements.

Plan investments consist of pooled separate accounts and common collective trust funds managed by the Custodian; and therefore, qualify as party-in-interest transactions. The Custodian performed administrative and recordkeeping services for the Plan which were paid for with Plan assets.

### **NOTE I--RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS-continued**

The recordkeeper provides certain administrative services to the Plan pursuant to a service agreement between the Plan and the recordkeeper. The recordkeeper receives revenue from the investment provider for the cost of the Plan's recordkeeping and service package. This revenue is used to offset certain amounts owed to the recordkeeper for its administrative services to the Plan.

### **NOTE J--PLAN AMENDMENTS**

Effective May 15, 2023, the Plan was amended to allow for participants over the age of 65 to take in service withdrawals.
