Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1. Description of the Plan

The following description of the Olympic Sports & Spine PLLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General:

The Plan is a contributory defined contribution plan established September 1, 1994 covering all eligible employees of Olympic Sports & Spine PLLC. Eligible employees are those employees who have reached twenty-one years of age. Employees that are covered by a collective bargaining agreement, a non-resident alien, or a leased employee are not eligible to participate in the Plan. Eligible employees may enter the Plan to make salary deferral contributions at the beginning of each month following meeting the eligibility requirements.

To be eligible for discretionary matching or non elective contributions, an employee must be employed by the Company on the last day of the Plan year.

On December 29, 2022, the SECURE 2.0 Act of 2022 was signed into law, which provides both required and optional future enhancements to tax qualified retirement plans and their participants. The provisions of the SECURE 2.0 Act may be effective and operationalized prior to formally amending the Plan document. The Plan has until December 31, 2026 to formally amend the Plan documents. The Plan is implementing required provisions in accordance with the applicable effective dates and is continually evaluating the optional provisions.

Contributions:

Upon meeting eligibility requirements, participants are automatically enrolled in the Plan with salary deferrals of 6 percent of eligible compensation. Participants may elect a different deferral amount or opt-out of the automatic enrollment program.

Each year participants may contribute Roth or pretax contributions that comprise the lesser of 100 percent of eligible compensation or the maximum amount allowed by law. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Sponsor may contribute a discretionary matching contribution. The discretionary matching contribution for the year ended December 31, 2024, was 64.91 percent of the participant deferrals up to 6 percent of eligible wages.

The Sponsor may also make non elective contributions at the discretion of the Sponsor's Board of Directors. For 2024, the Sponsor did not make any non elective contributions.

Participant Accounts and Investment Options:

Contributions from Plan participants and the Plan Sponsor discretionary matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Contributions to participant accounts are deposited into participant-directed funds at John Hancock Life Insurance Company (U.S.A.). The Sponsor periodically reviews the investment fund options available to participants and drops or adds investment funds as warranted.

Each participant account is credited with the participant's contribution and allocation of the Employer's contribution as determined above and an allocation of net income, gain, or loss based on account balances as defined.

Notes Receivable from Participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of 50 percent of their vested account balance or \$50,000. Loan transactions are treated as a transfer between investment funds and the Participant Loan fund. Loan terms range from one to five years, or more, if for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at 1 percent over prime rate at the time of the loan initiation. Interest rates range from 4.25 percent to 9.5 percent at December 31, 2024. Principal and interest is paid ratably through payroll deductions.

Vesting:

The participants are 100 percent vested in participant salary deferral contributions, rollovers, and the related earnings at all times. Vesting in all other Sponsor contributions plus earnings is based on years of credited service. Generally, a participant is 100 percent vested in the discretionary matching and non elective contributions after six years of credited service or upon age 65, retirement, death, disability or termination of the Plan.

Forfeitures:

Nonvested participant account balances forfeited into the Plan during the years ended December 31, 2024 and 2023, totaled \$54,314 and \$52,571, respectively.

Forfeitures of nonvested account balances can be used in a permissible method in accordance with the terms of the Plan. For 2024, forfeitures of \$60,750 were utilized to pay plan expenses.

Payment of Benefits:

Upon termination of service, disability, death or retirement, a participant whose vested account exceeds \$5,000 may elect to leave their vested account balance invested in the Plan or receive a lump-sum payment equal to the value of their account. Terminated participants with a vested account balance less than \$5,000 will automatically be paid as defined in the Plan Document. In-service distributions are allowed in accordance with the terms of the Plan.

NOTE 2. Summary of Significant Accounting Policies

Basis of Presentation:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America and present the net assets available for Plan benefits and the changes in those net assets.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions of net assets available for benefits during the reporting period. Actual results may differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are classified as distributions based upon the terms of the Plan documents.

Payment of Benefits:

Benefits are recorded when paid.

Administrative and Investment Management Expenses:

The Plan's expenses are paid either by the Plan or Plan Sponsor, as determined by the trustees, plan document, or service provider agreements. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements and are not intended to be reimbursed by the Plan. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

NOTE 3. Risks and Uncertainties

The Plan is exposed to market and credit risk due to the various foreign and domestic investment securities that may be selected by the participant in any combination. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 4. Information Certified by the Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, was obtained by management and agreed to or derived from information certified as complete and accurate as of December 31, 2024 and 2023, and for the year ended December 31, 2024 by John Hancock Life Insurance Company (U.S.A.) as follows:

- Investments and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.

NOTE 5. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosure*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: The value of each pooled separate account is stated at net asset value as provided by John Hancock Life Insurance Company (U.S.A.). Realized and unrealized gains and losses from the assets in the pooled separate accounts are credited to or charged against the accounts without regard to other income, gains or losses of John Hancock Life Insurance Company (U.S.A.). The redemption frequency for participants is two transfers per calendar month, and the redemption notice period for the Plan is 30 days. In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation techniques and inputs is appropriate and consistent with other market participants, the use of different techniques and inputs or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6. Party-in-Interest Transactions and Administration of Plan Assets

A party-in-interest is defined as a fiduciary or employee of the plan, any person who provides service to the plan, an employer whose employees are covered by the plan, an employee organization whose members are covered by the plan, a person who owns 50 percent or more of such an employer or employee organization, or a relative of such persons mentioned.

The Plan's investment options are held in participant directed accounts at John Hancock Life Insurance Company (U.S.A.), the custodian of the Plan; therefore, any transaction executed with John Hancock Life Insurance Company (U.S.A.) qualifies as a party-in-interest transaction.

As described in Note 2, the Plan paid certain expenses related to plan operations and investment activities to various service providers. These transactions are party-in-interest transactions.

The Plan Sponsor is a party-in-interest. Certain administrative functions are performed by employees of the Sponsor. No such employee receives compensation from the Plan. The Sponsor has the discretion to appoint or remove any trustee or agent of the Plan. The Trustees have the full power to administer the Plan and apply all of its provisions on behalf of the Sponsor.

NOTE 7. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Definiti LLC and received a favorable opinion letter dated June 30, 2020. Although the opinion letter is not specific to the Plan, the Plan administrator believes that the Plan is currently designed and is currently being operated in compliance with applicable requirements of the Internal Revenue Code; therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Management evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no material uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

NOTE 8. Plan Termination

Although it has not expressed any intent to do so, the Sponsors have the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 9. Subsequent Events

The date to which events occurring after December 31, 2024, the date of the most recent statement of net assets available for benefits, have been evaluated for possible adjustments to the financial statements or disclosure is July 31, 2025, which is the date on which the financial statements were available to be issued.
