Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of A-1 Freeman Moving & Storage, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the A-1 Freeman Moving & Storage, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan was formed effective July 1, 1990, with the last amendment effective January 1, 2018, and the most recent restatement effective June 30, 2020. It is a Code Section 401(k) Defined Contribution Retirement Plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is designed to provide retirement benefits to eligible employees of A-1 Freeman Moving & Storage, LLC (“A-1 Freeman”).

Contributions and Forfeitures - When employees have (a) attained the age of 20 1/2, and (b) met the six months of eligibility service requirement, they become eligible to participate in the Plan. The entry dates are quarterly following the date the employee meets the eligibility requirements. Employees who reach eligibility are automatically enrolled in the Plan at 3% on the next entry date with annual increases of 1% to a maximum of 6% unless elected otherwise.

Participants may make contributions during the Plan year through regular payroll deductions which are limited by provisions of the Internal Revenue Code. The employer may, but is not required to, make matching contributions in an amount the employer, in its sole discretion, may determine. The employer’s matching contributions totaled \$238,319. The non-vested portions of participant account balances are forfeitable if a participant leaves the Plan and are used to reduce the employer’s matching contributions or pay Plan expenses. Unallocated forfeited non-vested accounts totaled \$2,755 and \$6,725 at December 31, 2024, and 2023, respectively. Forfeitures of \$8,406 were used to offset employer contributions during the year ended December 31, 2024.

Participant Accounts - Each participant’s account is credited with the participant’s contributions and allocations of the employer’s matching contributions and Plan earnings and charged with an allocation of administrative expenses.

Vesting - Participants are immediately vested in their elective deferral contributions, plus the earnings thereon. Participants become vested in the employer’s matching contributions, and the earnings thereon, at retirement age, as defined in the Plan, or in the event of death or disability.

Prior to participants’ retirement age, the employer’s matching contributions become vested as follows:

Payment of Benefits - If a participant's vested account balance exceeds \$5,000, his or her consent is required to distribute the account before the participant reaches normal retirement age (or age 62 if later). A participant may elect to have his or her vested account balance distributed as soon as administratively feasible following termination of employment or may elect to postpone the distribution until age 70 ½. If a participant's vested account balance is less than \$5,000, a distribution will be made regardless of whether consent is obtained. If a participant dies before receiving a distribution of his or her account, the full amount of the account will be paid to the designated beneficiaries.

Notes Receivable from Participants - Notes receivable represent loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Loans are made available to all qualifying participants. A participant may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. The repayment period of any loan will be no more than five years unless any such loan is for the purchase of a participant's primary residence. The loan is secured by the balance in the participants' account and bears interest at rates based on prevailing market rates, as specified in the plan agreement. Principal and interest are paid through payroll deductions. All loans outstanding at December 31, 2024, have rates from 5.25% to 10.50% and mature through 2030.

Investment Options - Upon enrollment in the Plan, a participant may direct employee contributions among investment choices in increments of 1%. Participants may change their investment options on any normal business day.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are presented on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America "(GAAP)".

Use of Estimates - The preparation of financial statements in conformity with GAAP requires plan management to make estimates and assumptions that affect the reported amounts of plan assets, liabilities, and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan has a contract with Great-West Life & Annuity Insurance Company, d/b/a Empower Retirement, where Empower Retirement maintains contributions in a contract holder's account and such contributions are allocated according to participant's elections to the various investment options. The participants' accounts are credited with earnings on the underlying investments less any plan benefits paid and charges for Empower Retirement management fees and investment expenses.

The Plan's investments are reported at fair value, with the exception of the Key Guaranteed Portfolio Fund, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are reported at the ex-

dividend date. Net change in fair value of investments includes gains and losses on investments bought and sold as well as held during the year.

Investment Fees and Expenses - Contract administration expenses, including participant fees and asset charges, are paid for by the Plan. Actual administration expenses less loan fees for the year ended December 31, 2024, totaled \$64,153, no plan forfeitures were used to offset fees during 2024.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - The plan administrator has evaluated subsequent events through August 1, 2025, the date the financial statements were available to be issued. There were no subsequent events requiring recognition or disclosure in the accompanying financial statements.

NOTE 3 - PLAN TERMINATION

Although it has not expressed any intent to do so, A-1 Freeman has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants' accounts will become 100% vested.

NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards establish the framework for measuring fair value. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan measures fair value in accordance with accounting standards that establishes a fair value hierarchy based on the observability of inputs used to measure fair value. These inputs are summarized in the three broad levels listed below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value of measurement.

In many cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

Mutual funds – The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs). While the Plan believes its valuation

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

The Plan has a group annuity contract with Great-West Life & Annuity Insurance Company, d/b/a Empower Retirement that invests contributions in the Key Guaranteed Portfolio Fund. Contract value is the relevant measurement attribute for the group annuity contract since the contract was determined to be fully benefit-responsive. The fund is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The reported values for the fund are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than zero percent. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Such interest rates are reviewed on a quarterly basis for resetting. The fund yield rate earned by the plan for the year ended December 31, 2024, and 2023 was 1.41% and 1.23% respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- Amendments to the plan document (including complete or partial plan termination or merger with another plan),
- Bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan or
- The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE 6 - TAX STATUS

The Plan currently does not have a letter from the Internal Revenue Service (“IRS”) indicating that the Plan constitutes a qualified plan under Section 401(k) of the Internal Revenue Code. A-1 Freeman does not believe that a determination letter is needed because the plan documents are prototype documents which have previously been approved by the IRS and have not had any provisions modified to require a determination letter. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provisions for income taxes have been included in the Plan’s financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

NOTE 7 - INFORMATION CERTIFIED BY TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Great-West Life & Annuity Insurance Company, d/b/a Empower Retirement, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value, fully benefit responsive investment contract at contract value, unallocated cash and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024, and 2023.
- Net change in fair value of investments, interest and dividends, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 8 - CONCENTRATION RISK

The Plan may maintain cash in bank deposit accounts which, at times, may exceed the federally insured limits, presenting the Plan with a risk of loss of amounts in excess of the federally insured amount.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 - PARTIES-IN-INTEREST TRANSACTIONS

Certain investment funds and notes receivable from participants are managed by Empower Retirement, and their related entities, and therefore qualify as party-in-interest transactions.
