Employee 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of U.M.C., Inc. Employee 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

1. Basis of Presentation

The accompanying financial statements of U.M.C., Inc. Employee 401(k) Plan (the Plan) have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

2. Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in guaranteed investment contracts are stated at contract value.

As described in the Accounting Standards Codification ("ASC"), 946, *Financial Services – Investment Companies*, investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales are recorded on the trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net change in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

3. Contributions

Contributions from Plan participants and employer contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation.

4. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment recorded.

5. Participant Direction of Investments

Subject to the provisions of the Plan, a participant has the right to direct the investments of the balance in their accounts in the specific investment funds made available by the Plan administrator. At December 31, 2024 and 2023 all investments are participant directed.

6. Payment of Benefits

Benefits are recorded when paid.

7. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE B – DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General and Eligibility

The Plan is a defined contribution plan originally effective January 1, 1989, covering substantially all employees of U.M.C., Inc. (the Employer). Employees are eligible for participation upon attaining 18 years of age and completion of one month of service.

NOTE B – DESCRIPTION OF THE PLAN - CONTINUED

1. General and Eligibility - Continued

An eligible employee may become a participant on the next entrance date, which is the on the first day of the next quarter of the Plan year coinciding with or following the date eligibility requirements are met.

The Employer is responsible for appointing an administrator and trustee for the Plan. The trustee has discretionary powers in executing investment transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The costs of the Plan administration are the responsibility of the Plan.

2. Contributions

The Plan allows participants to contribute up to 100% of annual eligible compensation, as defined by the Plan, subject to limits imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified sources. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled unless they elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation with contributions invested in a designated fund.

All Employer contributions are determined at the discretion of the Employer. The Employer may make matching contributions, or qualified non-elective contributions to the Plan. Employer matching contributions, when made, are made to all participants regardless of service and are based on a discretionary percentage of participant salary deferrals. For the year ended December 31, 2024, the Employer matched 100% of the employee deferral for the year, up to 5% of eligible compensation. The Employer made discretionary matching contributions totaling \$745,187 during the year ended December 31, 2024.

3. Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Employer's matching contribution, (b) the Employer's qualified non-elective contributions and (c) investment income (loss) net of administrative expenses. Allocations are based on participant compensation or account balances, as defined.

NOTE B – DESCRIPTION OF THE PLAN - CONTINUED

3. Participant Accounts - Continued

Changes in a participant's deferral percentage for future contributions and reallocation of participant investment accounts among the investment options may be made at any time during the Plan year.

4. Vesting

Participants immediately vest in their employee and the employer's qualified non-elective contributions. Participants vest in all employer matching contributions at the rate of 33% after one year of service, 67% after two years of service and become 100% vested after three years of service, as defined by the Plan. Only whole years of service are calculated for vesting.

5. Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination of the participant's employment, a participant may receive a lump sum distribution equal to the participant's vested account balance. Participants with balances of \$5,000 or less are subject to involuntary lump sum distributions. Hardship distributions are not permitted. See Secure Act 2.0 note for description of optional benefit payment provisions adopted during the year ended December 31, 2024.

6. Notes Receivable from Participants

Loans to participants from a participant's vested balance are permitted up to the lesser of fifty percent of the vested balance or a maximum of \$50,000 for each participant. The minimum note amount is \$1,000. Each participant is limited to one outstanding loan. The loans shall bear a reasonable rate of interest, be adequately secured, and have a definite repayment schedule, generally over a period not to exceed five years. Principal and interest are paid ratably through payroll deductions.

7. Forfeited Accounts

Forfeited non-vested accounts may be used to reduce future discretionary profit sharing contributions. As of December 31, 2024 and 2023, the balance of unapplied forfeitures of non-vested accounts is approximately \$200 and \$100 respectively. Employer contributions and administrative expense paid from forfeitures totaled approximately \$27,700 for the year ending December 31, 2024.

8. ERISA Fee Recapture Account

JP Morgan Invest Holdings LLC (JP Morgan) is the recordkeeper of the Plan and, therefore, is a party-in-interest. JP Morgan receives revenue from mutual fund service providers for services JP Morgan provides to those funds. This revenue is used to offset certain amounts owed to JP Morgan for its recordkeeping services to the Plan. JP Morgan remits excess revenues to the Plan as earnings. During the year ended December 31, 2024, the plan received approximately \$59,700 in revenue sharing payments that are reported as other income.

As of December 31, 2024 and 2023, the balance of unallocated plan assets in the ERISA fee recapture account is approximately \$71,400 and \$68,500, respectively. Administrative expenses paid from the account totaled approximately \$58,100 during the year ending December 31, 2024.

9. Risks and Uncertainties

The Plan is comprised of investments in a combination of investment securities. Investment securities are exposed to various risks, such as interest, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation method used for assets measured at fair value. There have been no changes in the method used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end based on quoted market prices.

Common collective trust funds: Valued at the net asset value (NAV) of units held by the Plan at year end. The NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund. NAV is used as a practical expedient to estimate fair value. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan provides an investment option issued by Lincoln National Life Insurance Company (Lincoln) that simulates the performance of a guaranteed investment contract. Lincoln maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.70%. The net crediting interest rate is 1.95% at December 31, 2024.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semiannually basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value with the issuers. Examples of such events include (1) transfers of assets from the fund into a competing investment option and (2) when total distributions and transfers in the fund exceed certain levels. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

NOTE F – FEDERAL INCOME TAXES

The Plan has adopted a non-standardized pre-approved profit sharing plan of Empower Retirement LLC. Empower Retirement LLC obtained its latest opinion letter on November 14, 2022, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the advisory letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. There are no reconciling differences between the financial statements and the Form 5500 as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue and Regulations, Revenue Rulings, court decisions, and other evidence. The federal income tax returns of the Plan are subject to examination by the IRS generally for three years after they were filed.

NOTE G – PARTY-IN-INTEREST TRANSACTIONS

Empower Trust Company, LLC (Empower) is the trustee of the Plan. Empower holds the Plan's investments and executes transactions. JP Morgan is the plan recordkeeper. The Sage Advisory Group is the Plan advisor and acts as the fiduciary to the Plan.

NOTE H – ADMINISTRATIVE EXPENSES

The Plan pays administrative expenses that consist primarily of administrative fees to the trustee. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Employer on behalf of the Plan.

NOTE I – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to reduce, suspend, or discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE J - SECURE ACT 2.0

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as "SECURE Act 2.0". SECURE Act 2.0 contains over 90 new retirement provisions continuing the reforms that began with the 2019 SECURE Act. These provisions have varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Effective September 10, 2024, the Plan adopted a provision allowing for penalty tax exceptions for early distributions due to terminal illness. Effective October 15, 2024, the Plan adopted a provision allowing for distributions due to qualified disaster recoveries.

NOTE K - SUBSEQUENT EVENTS

The Company has evaluated subsequent events through July 30, 2025, the date which the financial statements were available to be issued.
