Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Angus Barn 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). Opinion

Basis for Opinion

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The following description of Angus Barn 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants in the Plan should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan became effective on August 19, 1980. It is a defined contribution plan covering all full-time employees of The Angus Barn Ltd., LLC (the "Company") who have one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may contribute a percentage of their pre-tax or after-tax ("Roth") annual compensation, not to exceed the maximum allowed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Effective July 1, 2021, employees are automatically enrolled in the Plan at a pre-tax deferral rate of 4%, unless the employee opts out. Effective January 1, 2024, the Plan was amended to increase the automatic deferral rate to 6%. The Plan also permits rollover contributions from other qualifying retirement plans. The Company makes a discretionary matching contribution of 50% of the participants' contributions up to 6% of the participants' salary. The Company may also make a profit sharing contribution at their discretion. There was no profit sharing contribution for the year ended December 31, 2024.

Participant Accounts

Employee contributions, employer 401(k) matching contributions, employer profit sharing contributions, and rollover contributions activity is maintained separately in each participant's account. Participants direct the investment of their account balances into various investment options offered by the Plan, which they may change at any time. Each participant's account is credited with an allocation of the Company's contribution, Plan earnings and forfeitures of terminated participants' nonvested accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account, based on the Plan's vesting schedule.

Vesting

Participants are vested immediately in the compensation deferral portion of their investment account as well as the rollover portion of their investment account plus actual earnings thereon. Participant vesting in the Company's contributions portion of their accounts is determined on a graduated basis based upon years of creditable service. A participant is fully vested in the Company 401(k) matching contributions and Company profit sharing contributions after six years of credited service.

Forfeited Accounts

At December 31, 2024, there were no forfeited non-vested accounts. Forfeited amounts can be used to reduce the employer matching contributions or to pay plan expenses. During the year ended December 31, 2024, the Plan used \$11,353 of forfeited accounts to pay plan expenses.

Payment of Benefits

Generally, the participant becomes eligible to receive benefits on their normal retirement age (55 or the fifth anniversary of participation), death, disability, termination of service, or other reasons of proven financial hardship. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account. Benefits are payable in lump sum payments with certain exceptions allowed. Participants are also eligible to take in-service withdrawals once they attain age 59 ½.

Hardship Withdrawals

Upon approval by the plan administrator, a participant may withdraw all or part of their elective contributions for immediate and severe financial need. In accordance with IRS regulations, the participant must exhaust all other assets available prior to obtaining the hardship withdrawal.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50 percent of their vested account balance. The maximum aggregate dollar amount of notes receivable from any participant may not exceed \$50,000 reduced by the excess of the participant's highest outstanding participant loan balance during the twelve-month period ending on the date of the loan over the participant's current outstanding participant loan balance on the date of the loan. A participant can only have one loan outstanding at a time. The notes are secured by the balance in the participants' accounts and bear interest at a fixed rate of prime plus 2.0% (9.50% at December 31, 2024) as of the date of the new loan. Principal and interest are paid ratably through payroll deductions. Total notes receivable from participants were \$376,433 and \$200,508 at December 31, 2024 and 2023, respectively.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Plan Expenses

Certain plan expenses are paid by the plan sponsor as provided by the plan document. Expenses related to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participants' accounts.

Payment of Benefits

Benefits are recorded when paid.

Cash and Cash Equivalents

The Plan considers all invested cash balances to be cash equivalents.

Investment Valuation and Income Recognition

Investments consist of collective investment trust funds, interest bearing cash and cash equivalents, self-directed brokerage accounts and mutual funds. Investments in mutual funds, interest bearing cash and cash equivalents and self-directed brokerage accounts are valued at quoted market prices established in an active market which represent the net asset value of shares held by the Plan at year end. Fair value of the collective investment trust funds is based on the cost plus credited interest, less expenses, subject to market value adjustments for early termination. See Note 7 for additional discussion of the valuation of the collective investment trust funds.

Purchases and sales of securities are recorded on the trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized appreciation and depreciation in the value of investments are allocated to the participant accounts based on participant holdings in each fund.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

3. Federal Income Taxes

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing plan document. This document received an opinion letter dated June 30 2020, in which the IRS stated that the document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). As allowed by the IRS, the Plan is relying on the opinion letter issued on the plan document for its own qualification. The plan document has been amended for changes required by the IRS since receiving the opinion letter. The plan administrator believes the Plan is designed and currently operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

3. Federal Income Taxes (Continued)

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

5. Investments

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the accompanying financial statements and supplemental schedule was obtained or derived from information certified as complete and accurate by First-Citizens Bank & Trust Company ("First-Citizens"), the trustee of the Plan, and was not subject to audit for the years ended December 31:

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 Inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

Level 2 Inputs are based on significant other observable inputs such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs are unobservable and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses Level 2 inputs when market prices are not attainable but other observable inputs are available to arrive at a fair value, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There were no Level 2 or 3 investments in the Plan.

Level 1 Fair Value Measurements

The fair value of mutual funds, interest bearing cash and cash equivalents and self-directed brokerage accounts is based on quoted net asset values of the shares held by the Plan at year end.

7. Collective Investment Trust Funds

The Plan invests in various collective investment trust funds ("CITs") managed by First-Citizens. The CITs sell new units and repurchase outstanding units on each valuation date at the net asset value ("NAV") per unit established on such valuation dates. There were no unfunded commitments.

8. Party-in-Interest Transactions

Plan investments are managed by First-Citizens. First-Citizens is the trustee as defined by the Plan. Newport Trust Company (“Newport”) was the Plan’s record keeper through November 13, 2024. Ascensus, LLC is the Plan’s record keeper as of November 14, 2024. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan to the trustee, record keepers and other parties-in-interest for contract administration and investment management services were \$37,884 for the year ended December 31, 2024. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with a party-in-interest. All of these transactions are exempt from being prohibited transactions by ERISA.

9. Risks and Uncertainties

The Plan invests in various investment securities as directed by its participants. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

10. Subsequent Events

The Company has evaluated events and transactions for potential recognition or disclosure in the financial statements through July 25, 2025, which is the date the financial statements were available to be issued.

In December 2022, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2022 (“SECURE Act 2.0”) that continued the retirement system reform previously passed in 2020. Certain provisions of the SECURE Act 2.0 are effective at various dates through 2026, with the plan amendment for the adoption of SECURE Act 2.0 due by December 31, 2026.
