Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Bulk & Spur 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Plan Description

The following description of Bulk & Spur (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution profit sharing plan covering substantially all eligible, non-union employees of Albany Transport, Inc., Bulk Transit Corporation, and Spur Transit, Inc. (the “Plan Sponsor”). Under the terms of the Plan, employees who have attained the age of 21 are eligible for participation after one year of service. The Board of Directors of the Plan Sponsor control and manage the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2022, the Plan was amended and restated for the cycle 3 restatement period. As part of the restatement, the Plan name was changed from Albany/Bulk/Spur 401(k) Plan to the Bulk & Spur 401(k) Plan.

Contributions

Participants may elect to contribute a portion of their pre-tax annual compensation, as defined in the Plan. For 2024 and 2023, the Company elected to make safe harbor matching contributions of 100% of the participant’s elective deferrals that do not exceed 4% of their compensation. Contributions are subject to certain Internal Revenue Code limitations. Participants may also contribute amounts representing distributions from any other qualified plan, rollovers, with proof that the contribution has been in such a plan.

Participant Accounts

Individual accounts are maintained for each Plan participant to reflect the participant’s entire interest under the Plan. Each participant’s account is credited with the participant’s elective deferral contribution, the Plan Sponsor’s matching contribution, and participant rollover contributions. Adjustments are made to participant’s accounts for (1) distributions; and (2) net income or loss attributable to a directed account. Plan earnings are allocated to participants based on a daily valuation of the participant’s respective funds. The benefit to which a participant is entitled is the amount that can be provided from the participant’s vested account.

Plan Description (continued)

Vesting

Participants are immediately vested in their elective deferrals, safe harbor matching contributions, and actual earnings thereon. Vesting in discretionary matching contributions is based on years of service. The vesting schedule is as follows:

Investment Options

Participants direct the investment of their accounts into various investment options offered by the Plan. Participants may currently choose from a variety of different pooled separate accounts with varying investment objectives and degrees of risk.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their deferral account balance, whichever is less. The interest rate charged to the participant for the loan is credited to the participant's account. Loan payments are made through payroll deductions and must be paid back within five years. Loans for a principal residence may exceed five years. The loans are secured by the balance in the participant's account. If the participant terminates employment with the Plan Sponsor prior to completing payments on the loan, the outstanding balance may be taxed and subject to penalty.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reason, a participant may elect to receive either a lump-sum distribution and/or equal installments of the participant's vested interest in their account. The Plan also permits distributions due to hardship under certain circumstances.

Forfeitures

Forfeitures are used to reduce the Plan Sponsor's contribution to the Plan and to pay Plan expenses. During 2024 and 2023, \$1,074 and \$4,634 of forfeitures were used to reduce the Plan Sponsor's contribution and to pay Plan expenses, respectively.

Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan Administrator to make estimates and assumptions that may affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodians and insurance company. See Fair Value footnote for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses

Administrative expenses paid by the Plan relate to recordkeeping fees. All other expenses incurred in administering the Plan are paid by the Plan Sponsor and are excluded from these financial statements.

Reclassification

Certain accounts presented on the 2023 Statements of Net Assets Available for Benefits have been reclassified in order to conform to 2024 presentation.

Notes to Financial Statements

December 31, 2024 and 2023

Fair Value Measurements

Generally accepted accounting principles include a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at fair value based on the underlying investment reported to the Plan by John Hancock.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information included in the financial statements and ERISA-required supplemental schedule.

Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$51,134 of administrative fees to the recordkeeper and Custodian for the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

Party-in-Interest Transactions (continued)

Certain Plan investments are shares in accounts that are managed by John Hancock Life Insurance Company USA. John Hancock Life Insurance Company USA is the Custodian as defined by the Plan and qualifies as a party-in-interest.

The Plan paid audit fees for the years ended December 31, 2024 and 2023. The independent auditor is classified as a party-in-interest.

Tax Status

The Company adopted a non-standardized form of a prototype plan sponsored by John Hancock USA. The prototype plan has received an opinion letter from the Internal Revenue Service as to the prototype of the plan's qualified status. The Plan Administrator believes the Plan is designed and is being operated in compliance with the approved prototype and applicable provisions of the Internal Revenue Code and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require management of an organization to evaluate tax positions taken by the organization and recognize tax liability if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. There are currently no audits for any tax periods in progress. Plan management believed it is no longer subject to income tax examinations for tax years prior to 2021.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Recent market conditions have resulted in an unusually high degree of volatility and increased the risks and short-term liquidity associated with certain investments held by the Plan, which could impact the value of investments after the date of these financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right, under the Plan, to discontinue contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

Subsequent Events

The Plan evaluated subsequent events through July 10, 2025, the date the financial statements were issued.
