Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Silver Oak Cellars 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Silver Oak Cellars 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Board of Silver Oak Wines Cellars, LLC (the "Plan Sponsor") established the Plan as of January 1, 1984. The Plan is a multiple-employer defined contribution plan covering all employees of Silver Oak Wine Cellars, LLC, Rawah Vineyards, LLC, The Oak Cooperage, LLC, and Metamorphosis Wines, LLC. (the "Company" or "Employer"). The Plan is intended to conform to and qualify under Section 401 of the Internal Revenue Code of 1996, as amended (IRC). The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Administration

The Plan Sponsor is responsible for the administration and operation of the Plan. Principal Life Insurance Company (the "Custodian") serves as the Plan's asset custodian and is responsible for the custody and management of the Plan's assets, as well as the Plan's recordkeeper and is responsible for maintaining participant accounts and transactions related to participant initiated activity. Principal Life Insurance Company also serves as the Plan's third-party administrators, who has such responsibilities as performing annual compliance testing and preparing the Form 5500.

Investment Committee

The Plan is supervised by its Trustees and an Investment Committee comprised of seven members who are all employees of the Company. The Investment Committee has the authority to make and deal with any investment in any manner consistent with the Silver Oak Cellars 401(k) Profit Sharing Plan Investment Policy Statement. The Investment Committee is assisted by an independent, registered investment advisor, First Western Trust, in managing the overall investment process and supervision of the Plan's investments.

Eligibility

All employees of the Company are eligible to participate in the Plan once they have one year of service and a minimum of 1,000 hours worked in a Plan year, as defined by the Plan document.

Effective July 1, 2019, the Plan was amended so that the entry date will be the first day of the month following the month in which eligibility requirements are met.

Employer Contributions Funding Policy

The Employer can make discretionary matching contributions to eligible participants of 100% of the participant's elective deferral up to a maximum of 4% of eligible compensation, as defined by the Plan. Additionally, the Employer is allowed to make discretionary non-elective contributions of 11% of eligible compensation, as defined by the Plan, to active participants. Contributions are subject to regulatory limits. Historically, the Employer contributions for the discretionary non-elective contributions are calculated and remitted to the Plan subsequent to year-end, therefore included as a contribution receivable in the statement of net assets available for benefits.

Participant Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan. Participants may also elect to make Roth contributions on an after-tax basis of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catchup contributions. Contributions are subject to regulatory limitations. Participants may also contribute amounts representing distributions from other qualified retirement plans as rollover contributions. The Plan has an automatic enrollment feature in which eligible employees will be automatically enrolled at 4% pre-tax elective deferral unless the employee makes a contrary election or opts out.

Participant Accounts

Each participant's account is credited with the participant's contribution and Plan Sponsor contributions, Plan earnings (losses), and charged with an allocation of administrative expenses, unless paid by the Plan Sponsor. Allocations are based on participant compensation, account balances, or specific transaction, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. In 2018, the selection of investments in the Plan became participant-directed.

Vesting of Benefits

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the profit-sharing employer's contribution portion of their accounts is based on years of service. Currently, the Plan is using a six-year vesting schedule.

Forfeited Accounts

Forfeited non-vested contributions are first used to pay Plan expenses or to reduce any non-elective contribution, then ratably reallocated to continuing participants. There were \$16,469 and \$485 in forfeitures as of December 31, 2024 and 2023, respectively. Of total forfeitures contributed during the year, \$27 and \$6,540 were used to pay administrative expenses for the years ended December 31, 2024 and 2023, respectively.

Payment of Benefits

Distributions and withdrawals are payable upon death, disability, retirement, termination of service, upon attaining the age of 59.5 or financial hardship, as defined by the Plan. If a participant's balance is equal to or less than \$1,000, the balance is distributed immediately in a lump-sum cash payment unless a direct rollover into another qualified benefit plan is requested. Balances between \$1,000 and \$5,000 must be rolled over to an individual retirement plan designated by the Plan administrator if the participant has not requested a distribution. If the account balance is over \$7,000, the participant can consent to either a distribution paid in the form of a lump-sum payment, a direct rollover into another qualified plan, installment payments under various options equal to the value of the participant's vested interest in his or her account or postpone payment to a later date and remain in the Plan as described in the Plan Document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and changes therein.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully-vested in their accounts, as defined by the Plan Document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States (U.S. GAAP).

Contributions

Contributions from participants are recorded based on the date the contributions have been separated from the participant's pay by the Employer, which is the pay date. Employer contributions are determined by multiplying the eligible gross wages paid to each participant by the discretionary contribution percent. Contributions from the Employer are recorded based on the date the funds have been transmitted to the Plan. The Plan records receivables for contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year. Rollover contributions from participants are recorded based on the date the funds have been allocated to the participants' accounts.

Investment Valuation and Income Recognition

The investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefit payments to participants are recorded as a reduction to net assets when paid.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Management Fees and Administrative Expenses

Investment management fees and administrative expenses charged to the Plan for investments in the common collective trusts are deducted from the funds and are not reflected separately. Consequently, investment management fees and administrative expenses are reflected as a reduction of investment return for such investments. Fees charged by the Plan record keeper and investment advisor are included in Administrative Expenses in the Statement of Changes in Net Assets Available for Benefits. Administrative expenses by the Plan are recorded when incurred and accruals are recorded when due.

Subsequent Events

The Plan has been evaluated from December 31, 2024 through July 31, 2025, the date the financial statements were available to be issued. The Plan did not have any significant recognizable or unrecognizable subsequent events that would have a material impact on the presentation of the Plan's financial statements.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C). Accordingly, as permitted under such election, the Plan administrator has instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Custodian, except for comparing such information certified by the Custodian to information included in the Plan's financial statements and supplemental schedules.

Accounting standards require that fair value be determined based on the price that would be received for an asset or paid to transfer a liability ("exit price") in the principal or most advantageous market, in an orderly transaction between market participants. Such fair value is a market-based measurement, not an entity-specific measurement. U.S. GAAP establishes a three-level valuation hierarchy based upon observable and unobservable inputs. The hierarchy gives the highest priority to level 1 measurements and the lowest priority to level 3 measurements. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan's market assumptions.

The fair value hierarchy consists of three levels that may be used to measure fair value as follows:

Level 1 - Inputs are unadjusted quoted prices in active markets for identical assets or liabilities.

Level 2 - Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities in active markets, quoted prices for identical assets or similar assets or liabilities in markets that are not active, and inputs (other than quoted prices) such as interest rates and yield curves that are observable for the asset and liability, and other inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Unobservable and significant inputs for the asset or liability, and include situations where there is little, if any, market activity for the asset or liability.

NOTE 4 - FAIR VALUE MEASUREMENTS (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the valuation methodology used as of December 31, 2024 and 2023.

Common Collective Trusts

Valued at the closing price reported on the active market on which the individual securities traded. These investments are included in Level 1 of the fair value hierarchy. Consists primarily of investments principally in funds containing equity securities, fixed-income instruments, and short-term investments in accordance with each portfolio's investment objective. Investments are valued using market quotations or prices obtained from independent pricing services.

The Plan adopted the First Western Bank Defined Contribution Volume Submitter Plan and Trust (basic plan document #08), which has received a favorable opinion letter dated March 31, 2014, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.
