## **INDEPENDENT AUDITORS' REPORT**

To the Fenner Dunlop Plans Committee

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Fenner Dunlop Retirement and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP); and
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS

---

### 1. DESCRIPTION OF THE PLAN

The following description of the Fenner Dunlop Retirement and Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

*General* - The Plan, established effective May 1, 2009, is a defined contribution profit sharing plan, which covers substantially all non-union employees of Fenner Dunlop Americas, Inc. (the "Company"). Union employees whose employment is covered by a collective bargaining agreement, under which retirement benefits are subject of good-faith bargaining, are ineligible to participate in the Plan with the exception of being able to receive certain employer discretionary non-elective contributions. Participants are eligible upon hire and may enter the plan on the first day of the calendar quarter following their date of hire (January 1, April 1, July 1, and October 1). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Employee Contributions* - The Company deposits cash to the Plan based on withholdings from the employees' pretax and/or after-tax earnings. The Plan has an auto-enrollment provision under which 6% of participant compensation is deferred into the Plan; however, affirmative elections may be made to contribute less or more than the 6%. Participants are generally permitted to contribute up to 100% of their eligible compensation, subject to IRS limitations. Employees may direct their contributions into various diversified investment options.

*Employer Contributions* - The Plan provides for a safe harbor matching contribution, which was 100% of the first 6% of an employee's eligible compensation deferred for the years ended December 31, 2024 and 2023.

*Participant Accounts* - Each participant's account is credited with the employee and applicable employer contributions and an allocation of the Plan's earnings. Allocations of plan earnings are based on a participant's account balance as a percentage of the total account balances for the applicable investment option.

*Vesting* - Participants are immediately vested in their voluntary contributions, employer safe harbor matching contributions, and actual earnings thereon. Vesting of all other employer contributions and earnings thereon is according to the following schedule:

1 and over	100%

*Payment of Benefits* - On termination of service due to death, disability or retirement, and subject to certain restrictions, a participant or designated beneficiary may elect to receive an amount equal to the value of the vested interest in his or her account in the form of a qualified rollover, lump-sum payment, an annuity, or installment payments, subject to applicable tax withholding requirements. On termination of service due to other reasons, a participant may elect to receive an amount equal to the vested interest in his or her account as a lump-sum distribution or in installments if the balance exceeds \$5,000.

*Forfeitures* - Forfeitures represent the portion of non-vested benefits (employer contributions) associated with terminated employees. Forfeiture balances may be used to reduce subsequent employer contributions or pay Plan expenses. Forfeitures were nominal during the years ended December 31, 2024 and 2023.

*Notes Receivable from Participants* - Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of 50% of their vested account balance or \$50,000 from their account. The loans are secured by the balance in the participant's account and bear interest at a fixed rate. Interest rates on outstanding loans at December 31, 2024 and 2023 ranged from 4.25% to 9.50%. Repayment is generally required within five years or ten years if the loan is for a primary residence. Principal and interest are paid through regular payroll deductions.

*Administrative Expenses* - The Plan's expenses are paid by the Company or the Plan as provided by the plan document. Administrative expenses primarily represent asset-based fees charged by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, custodian of and consultant to the Plan, and participant loan and distribution charges. Participant accounts are charged with an allocation of asset-based fees. Participant loan and distribution charges are paid from the account of the participant taking the loan or distribution.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Use of Estimates* - U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in assets and liabilities at the dates of the financial statements. Actual results could differ from the estimates.

*Investment Valuation and Income Recognition* - Investments, other than the guaranteed investment contract, are carried at their fair value based on published quotations or, in the absence of readily ascertainable market values, at such values as the custodian determines. The Plan presents net appreciation (depreciation) in the value of its investments, which consists of unrealized appreciation and depreciation as well as realized gains and losses. The unrealized appreciation (depreciation) of investments is determined by the change in current value from the

beginning of the year (if held for the entire year) to the end of the year, or from the date of purchase to the end of the year. The realized gains (losses) are determined by the change in value from the date of purchase to the date of sale.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded as earned.

*Fair Value Measurements* - U.S. GAAP has a framework for measuring the fair value of financial assets which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.
- Level 2      Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds held by the Plan are valued at the closing prices reported in active markets of the shares at year end (level 1 measurement).

The Plan holds common-collective trusts which are valued at the net asset value (NAV) of the units of the common-collective trusts and are not under the fair value hierarchy. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The Plan's investments are redeemable on a daily basis without restriction.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

The guaranteed investment contract is reported at contract value and is not under the fair value hierarchy. Contract value is the relevant measurement attribute because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 3).

*Notes Receivable From Participants* - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

*Contributions* - Employee and employer safe harbor matching contributions to the Plan are recorded in the period during which the Company makes payroll deductions from the participants' earnings. Employer profit sharing contributions are recorded in the period earned.

Employee and employer contributions to the Plan are subject to certain statutory limits established by the Internal Revenue Code.

*Risks and Uncertainties* - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

*Subsequent Events* - Management has evaluated subsequent events through August 6, 2025, the date which the financial statements were available to be issued.

### **3. GUARANTEED INVESTMENT CONTRACT**

The Plan holds a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal), which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified, guaranteed interest rate.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal, represents

contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit Principal to terminate the agreement prior to the scheduled maturity date.

#### **4. CERTIFIED FINANCIAL INFORMATION**

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the custodian, has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of assets available for benefits, as of December 31, 2024 and 2023
- Investment activity and interest income on notes receivable from participants as shown in the statements of changes in assets available for benefits for the years ended December 31, 2024 and 2023
- The schedule of assets held for investment purposes as of December 31, 2024, as shown on the accompanying schedule

#### **5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, all participants shall become 100% vested in their accounts.

#### **6. INCOME TAX STATUS**

The Plan, which is in the form of a non-standardized, pre-approved plan, obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue

Code. The Plan was most recently amended and restated on July 15, 2022 and is designed and continues to be operated in compliance with the applicable provisions of the Internal Revenue Code as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements. Management believes there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to tax examinations for the years prior to December 31, 2021.

## **7. RELATED PARTIES AND PARTIES-IN-INTEREST**

Principal Trust Company is custodian and consultant to the Plan. Additionally, it is the issuer of the common-collective trusts and a guaranteed investment contract and, accordingly, is considered a party-in-interest.

Neither the Company or employees involved in the administration of the Plan receive compensation from the Plan.
