Note A: PLAN DESCRIPTION

1) General: Bond Brothers, Inc. 401(K) originated in November, 2003 and is a defined contribution plan which incorporates the provision of Section 401(K) of the Internal Revenue Code. The Plan covers all employees who meet the eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants should refer to the Plan agreement for more complete information.

2) Contributions: Each year, participants may elect to defer pretax annual compensation, as defined in the Plan up to the maximum allowed by the Internal Revenue Service. Currently, newly-eligible participants will be auto-enrolled in the plan and deferral will be set at an initial 4% pretax contribution rate and increase by 1% each year to a maximum of 6%. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. The Company may make a safe harbor contribution of at least 3% of the participant's eligible compensation. In addition, the Company may make discretionary matching and profit-sharing contributions.

3) Participant Accounts: Each participant's account is credited with allocations of a) the Company's contribution and b) the Plan's earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4) Vesting: Participants are immediately vested in their contributions and the Company's safe harbor contribution plus actual earnings thereon. Participant vesting in the Company's matching and discretionary profit-sharing contribution portion of the accounts plus actual earnings thereon is based on years of continuous service. Effective November 1, 2021, participants are 20% vested after one year of service and 20% each subsequent year until 100% vested after five years. Prior to November 1, 2021, participants were 20% vested after two years of service and 20% each subsequent year until 100% vested after six years.

5) Investment Options: Upon enrollment in the Plan, a participant may direct employee contributions in any of the diversified investment options chosen by the Plan administrator. The investment options are listed in the financial statements.

6) Payment of Benefits: On termination of service due to death, disability, or retirement, a participant or beneficiary generally will receive an annuity form of payment or elect an alternative form of payment including a lump-sum payment equal to the value of the participant's vested interest in his or her account. Special distribution rules may apply to a portion of a participant's balance attributable to the Bond Brothers, Inc. Profit-sharing Plan which was merged into the Plan effective May 1, 2006.

7) Plan Termination: The Company expects to continue the Plan indefinitely but reserves the right to amend or terminate the Plan at any time. In the event of a partial or complete termination of the Plan, each participant's account becomes fully vested.

8) Forfeited Accounts: Forfeitures of terminated participants' non-vested accounts are all noted annually and may be used to pay Plan expenses or to reduce amounts otherwise to be contributed to the Plan. During the Plan year end October 31, 2024, additional contributions totaled \$44,525, which represents unallocated forfeitures. As of the Plan year ended October 31, 2024, the remaining balance of unallocated forfeitures totaled \$20,635.

Note B: SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Net Change in Fair Value of Investments: The Plan presents in the *statement of changes in net assets available for Plan benefits*, the net change in the fair value of the investments, which consists of the realized gains or losses and the net unrealized increase (decrease) on those investments.

New Accounting Pronouncements: The Plan has considered all new accounting pronouncements issued by the Financial Accounting Standards Board or other standard setting bodies that do not require adoption until a future date and concluded that such pronouncements are not expected to have a material impact on the Plan's financial statements.

Payment of Benefits: Benefits are recorded when paid.

Expenses of the Plan: Certain expenses of maintaining the Plan are paid directly from the Company and are excluded from these financial statements. Fees related to distributions and investment advisory fees are charged directly to the participant's account and are included in the administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Reclassification: Certain amounts in the Plan year 2023 financial statements have been reclassified to conform to the Plan year 2024 presentation, with no effect on the net assets available for Plan benefits.

Use of Estimates: The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Note B: SUMMARY OF ACCOUNTING POLICIES - CONTINUED

Investment Valuation and Income Recognition: The Plan's investments in common collective trust funds and mutual funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Earnings on investments are allocated on a pro rata basis to individual participant accounts based on the type of investment and the ratio of each participant's individual account balance to the aggregate of all participant account balances.

Interest income is recognized when earned. Dividend income is recorded on the ex-dividend date. Realized gains or losses on investments are recognized upon the sale of the related investments and unrealized appreciation or depreciation is recognized at period end when the carrying values of the related investments are adjusted to their estimated fair value. Purchase and sales of securities are reflected on a trade-date basis.

Risk and Uncertainties: The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant accounts and the amounts reported in the statement of changes in net assets available for plan benefits.

Concentration of Credit Risk: Financial instruments that potentially subject the Plan to concentration of credit risk are part of the holdings in the Plan's investments. Management believes that the trustee maintains the Plan's investments with high credit quality institutions and attempts to limit the credit exposure to any particular investment.

Note D: ADMINISTRATIVE EXPENSES

Administrative expenses for the year ended October 31, 2024 is comprised of recordkeeping, custodial and investment advisory and consulting fees. These expenses were incurred in connection with the administration of the Plan.

Note E: FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs are based on quoted prices in markets that are not considered to be active for which all significant inputs are observable, either directly or indirectly. Level 3 valuations require inputs that are both significant and unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures the fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Level 1 Fair Value Measurements:

The fair value of mutual funds at October 31, 2024 and 2023 are based on quoted net asset values of the shares held by the Plan at year end.

Level 2 and 3 Fair Value Measurements:

At October 31, 2024 and 2023, there were no investments valued using these methodologies.

Note F: GROUP ANNUITY CONTRACT

The Plan has entered into a traditional fully benefit-responsive group annuity contract, called Standard Stable Value A, with Standard Insurance Company. The insurance company maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses.

The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. The crediting rate is based on a formula established by the group annuity contract issuer and is reviewed on a quarterly basis for resetting. The average interest rate credited to participant accounts in 2024 was 3.03% and 2.71% in 2023. The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note F: GROUP ANNUITY CONTRACT - CONTINUED

The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the insurance company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include Plan termination and certain other sponsor-initiated events. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan thirty days after providing written notice to the Plan. These events include violation of the contract terms, the balance of the contract falls below \$25,000 or the Internal Revenue Service disqualifies the Plan. The Plan may terminate the contract at any time after providing thirty days written notice to the contract issuer. After a contribution cessation date is declared: (a) no further contributions will be made to the group annuity contract and (b) no new participant annuity accounts will be established. The participants' annuity account value will be maintained until the payment commencement date.

Note G: PARTY-IN-INTEREST TRANSACTIONS

The Plan sponsor provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged.

Certain Plan investments are in registered investment companies and common collective trusts managed by Reliance Trust Company. Reliance Trust Company is the trustee, as defined by the Plan. These transactions qualify as exempt party-in-interest transactions. In addition, the Plan sponsor pays certain expenses in administering the Plan such as audit fees and annual report preparation fees.

Several members of the board of trustees are currently participants in the Plan and an officer of the Company serves as the trustee and Plan administrator of this Plan.

Note H: INCOME TAX STATUS

The Internal Revenue Service has ruled that the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The trustee is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of October 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan is subject to routine audits by various regulatory authorities. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

During the Plan year ended October 31 2024, the Plan Sponsor did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Delinquent Participant Contributions Disclosure under ERISA. Untimely remittances on the Schedule H, Line 4(a) – Schedule of Delinquent Participant Contributions, which totaled \$91,545, were corrected during 2025, there were also \$42,011 of delinquent contributions in 2022 which were corrected in 2023. Additionally, the Company compensated participants for lost earnings resulting from the delay in the participant contributions.
