## 1. Description of the Plan

The Ascendium Education Group, Inc. (Ascendium) 401(k) Plan (the Plan) is a defined contribution retirement plan that covers substantially all employees of Ascendium and its Affiliates (the Corporation). Ascendium is the Plan sponsor and the Boards of Directors of the Affiliated Group are responsible for the general administration of the Plan. Fidelity Management Trust Company (Fidelity) is the trustee (Trustee) and Fidelity Workplace Services LLC is the recordkeeper for the Plan. The Plan Adoption Agreement document was restated effective February 2, 2022, to incorporate standard updates to the Employee Retirement Income Security Act of 1974 (ERISA) language.

Under the Plan, participating employees may generally defer up to 75% of both eligible pretax and Roth after-tax earnings up to the Internal Revenue Service's (the IRS) annual contribution limit. Participants may also contribute amounts representing distributions from other qualified plans. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. The Corporation matches contributions based on employees' deferral percentages after three months of employment. The Corporation matches 100% of the first 3% of the participant's eligible compensation contributed to the Plan and 50% of the next 2% of the participant's eligible compensation contributed to the Plan. Employees are eligible to defer funds into the Plan as of their hire date. Newly eligible employees are automatically enrolled with an initial pretax deferral contribution of 5% after 30 days following their date of hire. Each participant designates the investment funds to which both the employee's and the Corporation's contributions are to be deposited on their behalf. Both the employee's and the Corporation's contributions are immediately 100% vested to the participant.

Ascendium contributed an annual nonelective employer contribution for 2024, which is calculated on the eligible earnings after employment requirements are met. The 2024 discretionary formula is 7% of the first \$60,000 of the eligible participant's compensation and 2% of the eligible participant's compensation over \$60,000 and up to \$150,000. No additional nonelective contributions are made for eligible compensation in excess of \$150,000. The same fixed percentages were used for 2023 nonelective employer contributions.

Participant accounts are credited with the individual participant contributions and Ascendium's matched contributions, plus any gains or losses from market fluctuations on the elected fund valuations. Fees are posted directly to the affected accounts based on fund elections within each participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Although it has not expressed any intent to do so, Ascendium has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA, as amended. Distributions would be made in accordance with the terms of the plan document.

Participants are eligible for withdrawals under certain circumstances, per the Plan provisions. This includes both withdrawals paid to participants and rollover contributions. Participants initiate requests directly with the recordkeeper and qualified requests are then routed to the Plan administrators for review and release. Benefits paid directly to participants totaled \$7,705,010 and \$6,274,901 for Plan years 2024 and 2023, respectively.

## 1. Description of the Plan (continued)

Setting Every Community Up for Retirement Enhancement Act of 2022 (SECURE 2.0) was signed into law on December 29, 2022, and includes provisions intended to expand coverage, increase retirement savings, and simplify and clarify retirement plan rules. SECURE 2.0 provisions impact employee benefit plans through both mandatory updates and optional elections with varied effective dates through 2026. Some updates are automatically incorporated through the standard Plan language, and other optional elections are reflected in Ascendium's plan amendments to the effective years. Changes for 2024 include both types of updates:

- An Amendment for optional opt-in for Portability to the Portability Services Network, LLC for participants, which created a new prohibited transaction exemption under ERISA to allow for a mandatory distribution from a former employer's plan to a new employer's plan unless the participant elects otherwise.
- An automated increase of Mandatory Cash Out from \$5,000 to \$7,000 under language formerly adopted in a Fidelity Pre-Approved Plan (PAP) (also known as "Volume Submitter") document.

Additional information about the Plan Adoption Agreement and provisions is contained in the pamphlet, *Summary Plan Description for Ascendium Education Group, Inc. 401(k) Plan*, copies of which can be obtained from the Corporation.

## 2. Significant Accounting Policies

### *Basis of Accounting*

The accompanying financial statements of the Plan have been prepared on the accrual basis. Participant contributions and related employer contributions are recorded in the year which participant contributions are withheld from compensation.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Valuation of Investments and Investment Income*

The fair values of the shares held by the Plan in mutual funds are based upon externally quoted market prices on the last business day of the plan year. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The common collective trusts are valued using the net asset value (NAV), as provided by the issuer.

## 2. Significant Accounting Policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net (depreciation) appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### *Administrative Expenses*

Administrative expenses paid by the Plan include recordkeeping and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by the Company.

### *Accounting Estimates*

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements, accompanying notes, and supplemental schedule. If events occur in future periods that affect the underlying assumptions and estimates, actual results could differ from those estimates.

## 3. Investments

Certain investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net (depreciation) appreciation in the fair value of investments, and interest and dividend income for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the plan.

## 4. Fair Value Measurements

In accordance with Accounting Standards Codification 820, *Fair Value Measurement*, the fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.

Level 2 – Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.

Level 3 – Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable. These inputs reflect management’s judgment about the assumptions that a market participant would use in pricing the investment and are based on the best available information, some of which may be internally developed.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety. Valuation techniques used are required to maximize the use of observable inputs and minimize the use of unobservable inputs.

**5. Income Tax Status**

The underlying pre-approved plan has received an opinion letter from the IRS, dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

**7. Related-Party and Party-in-Interest Transactions**

The Plan holds units of a common collective trust fund and shares of certain mutual funds, which are managed by the trustee and recordkeeper of the plan. The Plan receives interest and dividends from these investments. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules of ERISA.

**8. Subsequent Events**

The Plan has evaluated subsequent events through May 30, 2025, which is the date the financial statements were available to be issued.
