### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

### **Note 1 – Description of the Plan**

The following description of the Matanuska Telecom Association, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of Plan provisions.

**General** – The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Matanuska Telecom Association, Inc., and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Matanuska Telecom Association, Inc. (the Company), is the Plan's sponsor and serves as the Plan administrator.

**Eligibility** – Employees of the Company are eligible to participate in the Plan immediately upon their date of hire. Ineligible employees include nonresident aliens, merger and acquisition employees, leased employees, seasonal and part time union employees, or seasonal/temporary nonunion employees who have not completed one year and 1,000 hours of service. Union employees are not eligible for employer profit sharing and employer matching contributions.

### **Contributions**

*Participant contributions* – Participants may contribute up to 75% of pretax annual compensation each year, as defined in the Plan. Participants are also eligible to make Roth elective contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible non-union employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant.

*Employer profit sharing contributions* – The Company makes profit sharing contributions to the Plan equal to at least 9% of the compensation of all benefiting participants. For the year ended December 31, 2024, the Company made a 9% profit sharing contribution in the amount of \$1,694,603 to the Plan.

*Employer matching contributions* – The Company may elect to make discretionary matching contributions to the Plan. Catch-up contributions are eligible for the employer match. Employer matching contributions are not to exceed 4% of the compensation of all benefiting participants. For the year ended December 31, 2024, the Company made a 4% matching contribution in the amount of \$717,957 to the Plan.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant's account is credited with the participant's contributions, as well as allocations of Plan earnings. Each nonunion participant's account is also credited with allocations of the Company's profit sharing and matching contributions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Vesting** – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of service. Participants vest in the Company’s contributions at a rate of 50% after two years, 75% after three years, and 100% after four years of service. Participants will become 100% vested upon reaching normal retirement age or termination of service due to death or disability.

**Payment of benefits** – On termination of service due to death, a designated beneficiary can receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service for reasons other than death, a participant may receive the value of the vested interest in his or her account as a single sum distribution, substantially equal installment payments over a specified period of time, or partial payments as requested from time to time by the participant. If the participant’s vested interest in his or her account is less than \$5,000, the participant may receive the distribution in cash or as a direct rollover as directed by the participant.

Participants are allowed in-service withdrawals on attainment of normal retirement age, which is 60. In addition, participants are allowed hardship withdrawals, in accordance with Plan provisions.

**Forfeitures** – Forfeitures are the nonvested portion of a participant’s account that is lost upon termination of employment. Forfeitures are retained in the Plan and are used to reduce future Company contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. For the year ended December 31, 2024, \$175,225 was used to reduce employer contributions.

### Note 2 – Summary of Significant Accounting Policies

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – The investments are reported at fair value. The Plan’s trustee, Charles Schwab Trust Bank, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Payment of benefits** – Benefits are recorded when paid.

### **Notes to Financial Statements**

**Expenses** – General Plan administrative expenses may be paid by the Company or allocated to participants on a pro-rata basis. Investment management and distribution fees are paid by the Plan participants.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statement is available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

On June 23, 2025, Alasconnect completed merger with the MTA 401(k) Plan, resulting in the transfer of assets from Fidelity 401(k) Plan into Matanuska Telecom Association Inc. 401(k) Plan. The financial statements presented do not reflect the effects of this transaction.

The Plan has evaluated subsequent events through August 5, 2025, which is the date the financial statements were available to be issued.

### **Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 or 2023.

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Money market deposit accounts* – The money market deposit is an interest-bearing cash account. The account is valued at cost and approximates fair value.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 4 – Tax Status

The Plan document is a prototype non standardized defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on September 21, 2020, which stated the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 5 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

### **Note 6 – Certified Investment Information**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Charles Schwab Trust Bank, as trustee of the Plan, has certified to the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits at fair value as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest and dividends reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the supplemental schedule of assets (held at end of year).

### **Note 7 – Party-in-Interest Transactions**

Certain Plan investments are managed by Charles Schwab & Co., Inc. Charles Schwab Trust Bank is the trustee and is an affiliate of Charles Schwab & Co., Inc., and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

### **Note 8 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

### **Note 9 – Reconciliation of Financial Statements to Form 5500**

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.
