INDEPENDENT AUDITORS' REPORT

To the Plan Administrator,
Earl W. Colvard, Inc. Savings Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Earl W. Colvard, Inc. Savings Plan, (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

(1) **Description of Plan:**

The following description of the Earl W. Colvard, Inc. Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

(a) **General**—The Plan is a defined contribution plan covering all eligible employees of Earl W. Colvard, Inc., d/b/a Boulevard Tire Center and Boulevard Retread Center, Inc. (collectively referred to as the Companies), which are commonly-owned corporations. Employees become eligible to defer income after completing one year of employment and attaining 21 years of age. The Plan administrator is responsible for oversight of the Plan. The Plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Directors. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

(b) **Contributions**—Each year, participants may contribute up to 100% of eligible pre-tax or post-tax annual compensation to a maximum amount allowed by law and defined by the Plan. Eligible participants may also make catch-up contributions or after-tax Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation, increasing by 1% annually to a maximum of 6%, with contributions invested in a designated balanced fund until changed by the participant. The Companies have elected to match 25% of the participant's contributions up to the first 4% of the employee's eligible compensation. Additional discretionary contributions may be contributed at the option of the Companies' board of directors. For the 2024 plan year, the Companies contributed an additional discretionary match of \$272,316, paid on February 28, 2025. To be eligible for matching or discretionary contributions, on each December 31, the employee must be an active participant on that date and have 1,000 or more hours of service in the Plan year. Contributions are subject to certain regulatory limitations.

(c) **Participant accounts**—Each participant's account is credited with the participant's contribution and allocations of (a) the Companies' contributions and, (b) plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Upon enrollment in the Plan, a participant may direct employee and employer contributions among various investment options as detailed in the plan document. The Companies currently offer 28 pooled separate accounts and a guaranteed interest account as investment options for participants. Participants may change their investment allocation at any time, subject to limitations as defined by Voya Retirement Insurance and Annuity Companies, the custodian of the Plan.

(d) **Notes receivable from participants**—Participants may borrow from their fund a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate charged by persons in the business of lending money for loans that would be made under similar circumstances (current rates on loans range from 5.25% – 10.5%). Principal and interest is paid ratably at least as frequently as quarterly over a reasonable amount of time not to exceed five years (thirty years for personal residence).

(1) **Description of Plan:** (Continued)

(e) **Vesting**—Participants are immediately vested in their contributions plus actual earnings thereon. Vesting of 100% in the Companies’ contribution portion of their accounts is based on the attainment of normal retirement age (65), total disability (as defined by the Plan) or death. Vesting may also be achieved by meeting years of continuous service. Participants vest based on the following schedule:

Years of Service	Percentage
Less than 2 years	0%
At least 2 years, but less than 3	20%
At least 3 years, but less than 4	40%
At least 4 years, but less than 5	60%
At least 5 years, but less than 6	80%
6 years or more	100%

(f) **Payment of benefits**—Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments determined by the participant. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The participant’s contributions may also be withdrawn for certain hardship situations.

(g) **Forfeited accounts**—Forfeited accounts may be used to pay administrative fees and to reduce future employer contributions. As of December 31, 2024 and 2023, there were forfeited nonvested balances remaining of \$1,052 and \$5,185, respectively. During 2024, forfeitures totaling \$44,500 were used to reduce employer discretionary contributions.

(h) **Administrative expenses**—The Plan permits payment of administrative expenses to be made from the Plan’s assets and for them to be allocated either proportionately based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan. Certain operating expenses of the Plan, such as audit fees, are paid by the Companies. Plan administration and investment management fees reduce the participants’ account balances. Expenses relating to specific participant transactions (i.e., loan setup, distribution request, etc.) are charged directly against the appropriate participant’s account.

(2) **Summary of Significant Accounting Policies:**

(a) **Basis of presentation**—The financial statements of the Plan are prepared using the accrual method of accounting.

(b) **Notes receivable from participants**—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on upon the terms of the plan document.

(2) **Summary of Significant Accounting Policies:** (Continued)

(c) **Contributions**—Contributions from Plan participants and the matching contribution from the Company are recorded in the year in which the employee contribution are withheld from compensation.

(d) **Investment valuation and income recognition**—The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements. Interest and dividend income are recorded when paid. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(e) **Use of estimates**—The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

(f) **Payment of benefits**—Benefits are recorded when paid.

(g) **Subsequent events**—The Plan has evaluated subsequent events through July 11, 2025, the date the financial statements were available to be issued. No subsequent events requiring recognition or disclosure have been identified.

(3) **Information Certified by the Plan Custodian:**

All investment information except for notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Companies, the custodian of the Plan.

(4) **Investments and Fair Value Measurements:**

FASB *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

(4) **Investments and Fair Value Measurements:** (Continued)

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable that reflect the plan's own assumptions about assumptions that market participants would use in pricing the assets, based on the best information available in the circumstance.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Pooled separate accounts (PSA) – Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the custodian, is based on the fair value of the underlying mutual funds held by the fund less its liabilities.

Guaranteed interest accounts – Valued at the NAV of shares held by the Plan at year end. The NAV, as provided by the custodian, represents the estimated fair value determined by the contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates. Participant transactions (purchases and sales) may occur daily. The guaranteed interest account seeks fixed income with stability of principal.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value at the reporting date.

For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no purchases, issues, or transfers in or out of Level 3.

(5) **Tax Status:**

The IRS has determined and informed the Companies by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by tax authorities, and may change upon examination.

(6) **Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(7) **Parties-in-Interest:**

Voya Retirement Insurance and Annuity Company manages many Plan investments as well as providing administrative services to the Plan and is the custodian, and therefore, Voya Retirement Insurance and Annuity Company qualifies as a party-in-interest to the Plan.

(8) **Plan Termination:**

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of a Plan termination, participants would become 100% vested in their employer contributions.
