Opinion

We have audited the accompanying financial statements of IBEW Local 265 Vacation Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of IBEW Local 265 Vacation Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of IBEW Local 265 Vacation Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023**

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the IBEW Local 265 Vacation Fund provides only general information. Participants should refer to the Trust Document and summary plan description for a complete description of the Fund's provisions.

General

The IBEW Local 265 Vacation Fund was formed under an agreement between the Lincoln Division, Nebraska Chapter, of the National Electrical Contractors Association (NECA) and I.B.E.W. Local Union No. 265 and was implemented by a trust agreement. Most of the participating employers' and unions' business activity is in the electrical industry working in eastern Nebraska, in the Lincoln area. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

To become initially eligible for benefits, a participant must work at least one hour of covered work under the CBA between IBEW Local 265 and an employer who is required to make contributions, and that employer must actually make contributions.

Contributions and Benefits

Funding is provided by participating employers based on the negotiated contribution rates set forth in the collective bargaining agreement, or other written agreements. Employer contributions for the Vacation Fund are deposited directly into each participant's vacation account at the IBEW Local 265 Credit Union. Participants can withdraw funds from their vacation accounts at any time. Claims for vacation funds must be made in accordance with the plan agreement. Failure to claim funds within the specified period will result in such unclaimed amounts being sent to the state unclaimed property. The Fund will do all it can to locate participants and give them their funds before sending to the state.

Service Charge Income

Service charge income of the Fund is used primarily to pay the Fund's administrative expenses. See Note 4 for further details.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Fund are prepared using the accrual method of accounting in accordance with generally accepted accounting principles.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Fund administration to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

IBEW LOCAL 265 VACATION FUND NOTES TO FINANCIAL STATEMENTS

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, Continued

Payment of Benefits

Benefits paid are recorded when paid out of the plan and deposited to the participants' accounts, which is typically the month after the benefits are earned.

Employer Contributions Receivable

Employer contributions receivable represents accrued contributions from employers for hours worked in the current year received by the Fund after the end of the year. Delinquent employer contributions are not recorded as revenue until the amounts are known and received. This effectively establishes an allowance for doubtful accounts of all outstanding delinquent contributions that the amounts are either not yet known or collected.

Date of Management's Review

Subsequent events were evaluated through July 24, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – TAX STATUS

The Trust established under the Fund to hold the Fund's assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code as a tax-exempt organization. The Fund has obtained a favorable tax determination letter from the Internal Revenue Service (IRS) and management of the Fund believes that the Fund, as amended, continues to qualify and to operate in accordance with applicable requirements of the Internal Revenue Code (IRC). Therefore, no provision for income taxes has been included in the Fund's financial statements.

The Fund has adopted guidance on accounting for uncertainty in income taxes issued by the Financial Accounting Standards Board. Management of the Fund believes that the Fund has taken no uncertain tax positions that require adjustment to the financial statements in order to comply with the provisions of this guidance. The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 – RELATED PARTY TRANSACTIONS

Administrative expenses, including wages, were provided for and paid by the IBEW Local 265 Credit Union for the years ended December 31, 2024 and 2023. The Fund collects a service charge from participants at a rate of \$4.50 per month, per participant that has a contribution. Of that amount, \$1.25 is paid to the Credit Union as reimbursement for administrative expenses. Effective January 1, 2024, the reimbursement amount changed to \$1.50. The remaining amount is used by the Fund to pay operating expenses. For the years ended December 31, 2024 and 2023, the Fund paid the Credit Union \$7,150 and \$5,375, respectively, for administrative fees.

Legal and accounting expenses incurred by the Fund totaling \$1,323 and \$11,411 were paid by the IBEW Local Union 265 for the years ended December 31, 2024 and 2023, respectively. The Local Union is not requiring the Fund to reimburse for these expenses.

IBEW LOCAL 265 VACATION FUND NOTES TO FINANCIAL STATEMENTS

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Board of Trustees have the right under the Fund provisions to discontinue contributions and to terminate the Fund. In the event of termination of the Fund, the net assets will be distributed according to the Plan Document and as required by ERISA.

NOTE 6 – RISKS AND UNCERTAINTIES

Cash consists of monies held in non-interest-bearing transaction accounts. The Plan places its cash with a financial institution deemed to be creditworthy. Balances are insured by the FDIC up to \$250,000. At December 31, 2024, the Plan did not have any cash that exceeded the federal insurance limit.

NOTE 7 – BENEFITS PAYABLE

Benefits payable represents the vacation amounts owed to the plan participants as of the year end date. The account balances are immediately 100% vested as the amounts represent employer contributions directed for the benefit of each participant.
