We have performed audits of the accompanying financial statements of Kokatat, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## NOTE 1 - DESCRIPTION OF PLAN

The following description of the Kokatat, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. The Plan is sponsored by Kokatat, Inc. (the Company).

### General

The Plan was established in 1996 and is a defined contribution plan covering all employees, with the exception of excluded employees as defined in the Plan document, who have one year of service. A year of service for eligibility is a twelve-month computation period in which the employee is credited with at least one thousand hours of service. There are no age requirements. An employee who becomes eligible under the Plan begins participation on the first day of the first, fourth, seventh or tenth month coincident with or following the date the service requirement is satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. The Company is responsible for oversight of the Plan. The Company appoints the trustees of the Plan who are responsible for its investment policy. The assets of the Plan are under the direction of the trustees.

### Contributions

Each year, participants may contribute up to the lesser of one hundred percent of compensation or the annual, before tax, dollar limitation, in accordance with the Internal Revenue Service (\$23,000 plus up to \$7,500 in catch-up contributions for participants age 50 or over for 2024). Salary deferral contributions cannot be made from any amount of compensation in excess of the annual dollar limit on compensation, which is currently \$330,000. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (participant rollover contributions). Subject to an investment policy established by the Company, all participant contributions and company contributions are specifically directed by the participants. Participants direct the investment of their contributions and company contributions into various investment options offered by the Plan.

As defined by the Plan, the Company makes Actual Deferral Percentage (ADP) Safe Harbor matching contributions to the Plan to automatically satisfy the ADP test. The ADP test is a nondiscrimination test applied annually to the salary deferral contributions made to the Plan. The matching contribution for each Safe Harbor participant is equal to the sum of one hundred percent of each eligible participant's salary deferral contributions, including "catch-up contributions" that do not exceed three percent of their compensation for the Plan year, plus fifty percent of each eligible participant's salary deferral contributions elective deferrals that exceed three percent of their compensation but do not exceed five percent of their compensation for the Plan year. For the plan year ended December 31, 2023, the Plan included Safe Harbor contributions through September 2023. Effective January 1, 2024, the plan was amended to reinstate the Safe Harbor matching contributions. See Note 9 for further details of this amendment. For the Plan year ended December 31, 2024, the Company made Safe Harbor matching contributions of \$116,113. As of December 31, 2024 and 2023, \$116,099 and 96,066, respectively, of the Safe Harbor matching contributions were accrued as a receivable.

As defined by the Plan, the Company can elect to make profit sharing contributions as defined by management. The Company did not make profit sharing contributions for the years ended December 31, 2024 and 2023.

### Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Expenses that are paid from Plan assets are shared by all participants either on a pro-rata basis or an equal dollar basis. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 1 - DESCRIPTION OF PLAN (continued)**

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts available to offset future employer contributions and administrative expenses totaled \$2,322 and \$5,972, respectively.

**Vesting**

Participants are immediately vested in their voluntary contributions and the Safe Harbor matching contribution plus actual earnings thereon. Vesting in the Company profit sharing contribution plus earnings thereon is based on years of continuous service based on the following vesting schedule:

<u>Years of vested service</u>	<u>Vested percentage</u>
Fewer than 2 years of service	0%
2 years of service	20%
3 years of service	40%
4 years of service	60%
5 years of service	80%
6 or more years of service	100%

A year of service, for purposes of vesting, is a twelve consecutive month computation period during which an employee works 1,000 or more hours.

**Investment Direction**

Participants can direct all contributions to any one or more of the investment funds determined at the discretion of the Plan Administrator and Plan Sponsor. If the participant makes no such direction, the trustee will allocate their contributions to a default investment portfolio based on age.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, the value of a participant's vested benefits will be paid in a single lump sum distribution or rollover to a qualified plan. The Plan also allows in-service distributions and hardship distributions under certain conditions and within limitations specified by the Plan. The Plan has a \$5,000 threshold for vested account balances for terminated employees. If the vested portion of a participant account is below \$5,000 at the time the participant is terminated, the Plan will establish an IRA in another bank, outside of the Plan, and roll the balance of the account to the IRA. If the vested account balance is below \$1,000, and no distribution request is made, and the participant did not elect to have the account rolled out of the plan as specified above, the Plan sponsor will distribute the account balance as a lump-sum cash distribution.

**Retirement**

Normal retirement under the Plan is 59.5 years of age.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting, with the exception of benefits which are recorded when paid.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are carried at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan may be paid directly by the Company and are excluded from these financial statements, while other expenses may be paid from the assets of the Plan. Investment related expenses are included in net appreciation of fair value of investments.

## **NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR Section 2520.103-8 of the Department of Labor Rules and Regulations and disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the trustee, Ascensus, LLC for the years ended December 31, 2024 and December 31, 2023, and was not subjected to any auditing procedures performed:

- All investments shown in the accompanying statements of net assets available for benefits.
- Net appreciation (depreciation) in the fair value of investments and dividend income, as shown on the accompanying statement of changes in net assets available for benefits.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

Quoted prices for identical or similar assets or liabilities in inactive markets;

Quoted prices for similar assets or liabilities in active markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued based on the unit values multiplied by the number of units held. The change in unit value is calculated for each underlying mutual fund in a variable annuity contract. These calculations are performed daily from the previous day's net asset value per share.

A party-in-interest, as defined by the DOL, is anyone who provided services to the Plan during the Plan year. The DOL provides a reporting exemption if the services provided are necessary to the Plan. Platform CPA's LLP and Bidwell Consulting provided administrative services to the Plan.

Certain Plan investments are managed by Newport Group, a company of Ascensus, LLC. Ascensus, LLC is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

#### **NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### **NOTE 7 - RISKS AND UNCERTAINTIES**

Each investment fund is diversified through a portfolio containing a wide variety of investments that fit the particular investment strategy and targeted composition. Further diversification is available to participants through participation in more than one fund. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Credit risk is considered to be minimal. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

#### **NOTE 8 - TAX STATUS**

The Company adopted a Prototype Non-standardized Profit Sharing Plan with a Cash or Deferred Arrangement (CODA), which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020 which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). While the prototype plan has been amended since receiving the letter, the plan administrator believes the Plan has been operated in accordance with the applicable provisions of the IRC. The Plan is qualified under Section 401(a) of the IRC and is exempt from federal income tax under provisions of Section 501(a) of the IRC, and from applicable state tax, as state law conforms to the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan is subject to routine audits by taxing jurisdictions. In general, the Plan's returns are subject to examination by federal tax authorities for a period of three years beginning with the later of the due date of the return or the date they are filed. There are currently no examinations in progress.

**NOTE 9 - PLAN AMENDMENT**

Effective January 1, 2024, the Company amended the safe harbor provision of the Plan. As a result of this amendment, the Company will reinstate the safe harbor matching contribution. The reinstatement of these were made following a comprehensive review of the Company's retirement plan strategy and objectives. This amendment also allowed any eligible long-term part-time employees to receive safe harbor matching contributions once they contribute into the plan.

Participants were notified of this change in accordance with the required notice period, and the amendment has been documented and communicated to ensure transparency and compliance with regulatory requirements.

**NOTE 10 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through August 6, 2025, which is the date the financial statements were available to be issued.
