### Note 1 - Plan Description

The following description of QRM 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Quantitative Risk Management, Inc. (the "Company"). Any employee of the Company who has earned income within the United States of America is eligible to participate in the Plan upon date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary 401(k) contributions up to a maximum of 75 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code (IRC). Participants may also make voluntary after-tax Roth 401(k) contributions, which are also subject to IRC limitations. The Plan also accepts participant contributions in the form of a rollover of funds from another qualified plan.

The employer makes a safe harbor matching contribution equal to 100 percent of the first 3 percent (in relation to compensation) of each participant's contribution and 50 percent of the next 2 percent (in relation to compensation) of each participant's contribution.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the employer's matching contribution, and allocations of plan earnings and charged with allocations of plan losses and administrative expenses. Allocations are based on participants' compensation or participant-directed account balances, as defined. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participant and employer matching contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

#### **Benefit Payments**

Benefit payments are generally paid in a lump sum as soon as practicable after employment with the Company has ended. Participants may elect to defer commencement of distributions until April of the calendar year after they attain the age of 70½. Until such time as the funds are distributed, the participant is entitled to receive a pro rata share of fund earnings. Benefits may also be paid directly to an eligible retirement plan as a rollover distribution.

#### **Party-in-interest Transactions**

Certain plan assets are in investment funds managed by Vanguard Fiduciary Trust Company or its affiliates. Vanguard Fiduciary Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### **Termination**

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net realized and unrealized loss on investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Company.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including July 29, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Note 3 - Fair Value Measurements (Continued)**

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at closing quoted prices reported in active markets.

**Self-directed Brokerage Account Investments**

The Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include various investments in publicly traded securities that are valued at the closing quoted prices reported in active markets. The self-directed brokerage accounts also include interest-bearing cash, which is valued at outstanding balances.

The following tables present information about the Plan's assets measured at fair value on a recurring basis at December 31, 2024 and 2023:
