## INDEPENDENT AUDITORS' REPORT

The Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lineage Profit Sharing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### Basis for Opinion

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



## Notes to Financial Statements

---

### 1. Description of Plan:

The following description of Lineage Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General:

The Plan is a defined contribution pension plan covering employees of Innovative Office Systems LLC (the Plan Sponsor) and its affiliated entities, Advanced Business Machines, Inc., Crockett Business Machines LLC, Avcorp Business Systems LLC, Williams Holdings LLC, Lineage Mailing Services LLC, and Lineage Office Technologies of New York LLC. An employee must attain age 21 and have at least six months of service during which they completed 500 hours of service to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions:

Each year, participants may contribute a portion of pretax annual compensation, as defined in the Plan, provided total deferrals to the account of participating employees for any plan year shall not exceed the amount permitted by Internal Revenue Service regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan Sponsor contributes non-elective safe harbor contributions of 3% of a participant's annual salary, as described in the plan agreement. The Plan also allows for discretionary profit-sharing contributions, determined by the Plan Sponsor, for allocation to participants based on participants' eligible compensation. The profit-sharing contribution totaled \$154,034 in 2024.

Effective July 1, 2025, the Plan was amended to add automatic enrollment of all newly eligible employees unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation, which will increase by 1% on the first day of each plan year until reaching 7%, unless the participant elects a different percentage. Additionally, the Plan was amended to permit rollover contributions.

### Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined.

#### Vesting:

Participants are immediately vested in their voluntary contributions and Company safe harbor contributions plus earnings thereon. Vesting in the Company profit-sharing contributions portion of their accounts plus earnings is based on years of continuous service. A participant is 100% vested in profit-sharing contributions after six years of credited service.

#### Investment Options:

Participants direct contributions into a variety of investments offered by CMFG Life Insurance Company (CMFG), an administrator of the Plan.

#### Payment of Benefits:

On termination of service for any reason, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment payments over a period of not more than the assumed life expectancy of the participant or beneficiary, or defer the commencement of benefits until normal retirement age.

#### Forfeitures:

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$5,354 and \$2,496. These accounts are used to reduce future employer contributions and administrative expenses. In 2024, \$8,164 of forfeitures were used to reduce administrative expenses.

### 2. Significant Accounting Policies:

#### Basis of Accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

### **Use of Estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition:**

The Plan's mutual funds, money market fund and self-directed brokerage accounts are stated at fair value based on quoted prices in active markets. The self-directed brokerage accounts consist of cash, equities and exchange traded funds. The fully benefit-responsive investment contract is valued at contract value as described below.

The Plan maintains a fully benefit-responsive guaranteed investment contract, which is stated at contract value. Contract value, as reported to the Plan by CMFG without further adjustment, represents contributions made, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The insurance company may not terminate the contract at any amount less than contract value and is contractually obligated to pay the principal and specified guaranteed interest rate. The minimum guaranteed interest rate under the contract at December 31, 2024 is 2%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code, (2) complete or partial termination of the Plan, (3) any change in law, regulation, or administrative ruling applicable to the Plan that could have a material adverse effect on a portfolio's cash flow, (4) any communication given to participants not to invest in a portfolio or to transfer assets out of a portfolio, or (5) premature termination of the contract. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Unrealized appreciation or depreciation on investments is charged or credited to the net assets of the Plan.

### **Payment of Benefits:**

Benefits are recorded when paid.

### **Administrative Expenses:**

Investment management and other fees are paid by the Plan. Various administrative expenses were paid by the Plan Sponsor.

### **Subsequent Events:**

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through July 29, 2025 (the date the financial statements were available to be issued).

### **3. Financial Information Certified by the Trustee (Unaudited):**

In accordance with Department of Labor Regulation 2520.103-8, the Plan administrator has obtained certified "Statements of Account" from Matrix Trust Company as of and for the years ended December 31, 2024 and 2023 that the information summarized below is complete and accurate:

- Statements of Net Assets Available for Benefits – Investments.
- Statement of Changes in Net Assets Available for Benefits – Investment income.
- Schedule of Assets (Held at End of Year) – all items and amounts.

### **4. Income Taxes:**

The Internal Revenue Service has issued a favorable opinion letter regarding the tax-exempt status of the Plan. Accordingly, no provision has been made for income taxes.

### **5. Plan Termination:**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **6. Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
