#### NOTE 1 - DESCRIPTION OF PLAN

The following description of The 401(k) Plan of Arrowood Indemnity Company (the "Plan") is provided for general informational purposes only. Participants should refer to the Plan document for more complete information.

##### **General**

The Plan is a qualified voluntary defined contribution plan sponsored and administered by Arrowood Indemnity Company in Liquidation (the "Company" or "Plan Administrator"), a wholly owned subsidiary of Arrowpoint Group, Inc., whose ultimate parent is Arrowpoint Capital Corp. The Plan applies to all employees of the Company and its affiliates. Certain individuals that are not eligible to participate in the Plan include independent contractors and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

##### **Contributions**

Participants of the Plan may contribute up to 75% of pre-tax annual compensation, as defined. In addition to pre-tax deferrals, participants are allowed to make Roth 401(k) deferrals to the Plan. Participants who have obtained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan provides for Company safe harbor matching contributions. Effective January 1, 2023, the Company's safe harbor matching contribution formula is 100% of the first 5% of eligible compensation contributed by participating employees.

All Plan contributions are subject to certain Internal Revenue Code ("IRC") limitations.

##### **Participant Accounts**

Upon enrollment in the Plan, participants may, subject to a procedure established and applied in a nondiscriminatory manner, direct Bank of America, N.A. (the Trustee) to invest their account in one or more of the investment options. Each participant's account is credited with (a) participant and Company contributions, (b) an allocation of investment earnings (losses) and is charged with (c) withdrawals and (d) certain participant-requested service expenses, a quarterly recordkeeping fee, a pro-rata share of expenses related to operating and administering the Plan, and monthly fee rebates as applicable for revenue sharing that is re-invested in certain funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

All participants are 100% vested in their entire account balance, including all Company contributions, regardless of their service.

##### **Payment of Benefits**

Upon retirement or termination from employment, a participant's entire interest in the Plan, including the Company's matching contributions and the participant's own contributions and related investment gain or loss, is payable, regardless of the number of years of participation.

In the event of disability or death before retirement or termination, a participant's entire interest in the Plan, including the Company's matching contributions and the participant's own contributions and related investment gain or loss, is payable to the participant or the participant's designated beneficiary, regardless

of the number of years of participation. A participant is eligible to receive payment if the participant qualifies for disability benefits as determined under the terms of any long-term disability plan maintained by the Company.

In the event of a financial hardship, an active participant may be allowed to withdraw all or part of their interest in the Plan attributable to the participant's contributions and related investment gain or loss.

Minimum required distributions for participants who have reached age 73 also apply per IRC regulations.

While actively employed, a participant may be allowed to withdraw all or a portion of his account subject to Plan rules regarding certain sources of contributions and age requirements.

***Notes Receivable From Participants***

Participants may borrow up to the lesser of 50% of their account balance or \$50,000, with a minimum note amount of \$500. The note repayment terms are for a minimum of one year and a maximum of five years unless the loan is used to purchase their principal residence in which case the term can be up to 10 years. Payments, including principal and interest, are made according to the Company's payroll frequency or lump sum if the entire balance is repaid. The interest rate is based on the prime rate as listed on the last business day of each month in the Wall Street Journal plus 1%. The notes bear interest at rates from 4.25% to 9.50% as of December 31, 2024 and 4.25% to 9.50% in 2023. As of December 31, 2024, participant loans have maturities through 2029. The principal and interest paid are allocated to the appropriate funds according to the participant's investment election at the time of payment.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a description of the fair value measurements. Purchases and sales of securities are recorded on a trade-date basis.

Interest income is recorded when earned. Dividend income is recorded on the ex-dividend date.

Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Risk and Uncertainties***

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities

and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and in the statements of changes in net assets available for benefits.

***Administrative Expenses***

Investment management fees are reflected in net appreciation in the fair value of investments as presented on the accompanying statements of changes in net assets available for benefits. Plan recordkeeping fees are charged on a fixed rate per participant.

Other administrative expenses, including the quarterly recordkeeping fee are charged to all participants. Separately, participants invested in funds that provide revenue sharing receive a monthly credit (fee rebate) that is re-invested as a dividend in the same fund(s).

***Payment of Benefits***

Benefits are recorded when paid.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based on the Plan document and included in benefits paid to participants on the statements of changes in net assets available for benefits.

**NOTE 3 - FAIR VALUE MEASUREMENT**

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of assets or liabilities within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. There were no transfers in or out of any level during the years ended December 31, 2024 and 2023.

*Mutual funds and money market funds* - Valued using active quoted market prices of shares held by the Plan at year-end.

*Collective trust* - Valued at the net asset values ("NAV") of shares held by the Plan at year-end based on information reported by the Trustee. The NAV, used as a practical expedient to estimate fair value, is based on the fair value of the underlying investments of the State Street S&P Midcap Index fund. The investment objective of the collective trust fund is to provide an investment return that approximates as closely as practicable, before expenses, the performance of the S&P Mid Cap 400 Index over the long term. There are no unfunded commitments or redemption restrictions on this investment.

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - INCOME TAX STATUS**

The Plan Administrator has received a favorable determination letter from the Internal Revenue Service ("IRS") dated May 31, 2017, which indicated the Plan, as designed, was in compliance with the IRC. The Plan has been amended since the date of submission for the determination letter. However, the Plan Administrator believes that the Plan is designed and is operating in accordance with the applicable requirements of the IRC, and thus, the Plan and the related trust continue to be tax exempt. On March 3, 2025, the IRS responded to the Form 5310 filing with a favorable determination in regard to plan termination. Refer to Note 6.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. **NOTE 6 - PLAN TERMINATION**

The Company filed Form 5310 (Application for Determination on Termination) to the IRS in December 2023. The Company intends to create a spin-off plan for participants who are active employees of the Company and terminate the remainder plan covering participants who are not active employees of the Company. On March 3, 2025, the IRS responded to the Form 5310 filing with a favorable determination in regard to plan termination. The Company requested approval from the Delaware Department of Insurance Commissioner who has been appointed as the Company's Receiver pursuant to the Liquidation and Injunction Order with Bar Date entered by Vice Chancellor Lori L. Will of the Delaware Court of Chancery on November 8, 2023. In the event the Plan is terminated, the amounts credited to the participants' accounts shall be distributed to the participant or their beneficiaries under the terms of the Plan document and amounts for participants who are actively employed by the Company will be transferred to the spin-off plan. Timing for spin-off and terminated plan actions will be determined after the Receiver responds to the approval request.

Plan management does not consider termination of the Plan to be imminent as of December 31, 2024.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

The Plan has notes receivable from participants. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

**NOTE 8 - SUBSEQUENT EVENTS**

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through July 25, 2025, the date the financial statements were available to be issued.

On March 3, 2025, the IRS responded to the Form 5310 filing with a favorable determination in regard to Plan termination. Refer to Note 6.

Effective April 15, 2025, the Plan was amended to incorporate various provisions required by the Secure 2.0 Act of 2022.
