### **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

#### **NOTE A - DESCRIPTION OF THE PLAN**

The following brief description of the Twin Eagle Resource Management 401(k) and Profit Sharing Plan (the "Plan") is provided for general information purposes only. The Plan is sponsored by Twin Eagle Holdings N.A., LLC (the "Plan Sponsor" or "Company"). Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan covering substantially all employees of the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Plan is administered by the Company. The Plan also utilizes Fidelity Management Trust Company ("FMTC" or "Trustee") as the trustee of the Plan responsible for the management and control of the Plan's assets, which are held in individual participant investment accounts. Fidelity Workplace Services LLC processes and maintains the records of the participant data.

##### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) employer contributions and (b) Plan earnings (losses) and is charged with investment fees and transaction fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

##### ***Participant Contributions***

Participants may elect to defer a percentage or dollar amount of their eligible compensation, as defined in the Plan document, not to exceed the Internal Revenue Service ("IRS") limitations for contribution limits. Participants may also designate all or a portion of their elective deferrals as Roth elective deferrals. Participants who have attained age 50 or older before the end of the tax year are eligible to make catch-up contributions.

##### ***Rollover Contributions***

Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

##### ***Employer Contributions***

The Plan is a safe harbor plan providing contributions under a basic matching contribution formula. The Company provides safe harbor matching contributions equal to 100% of deferrals up to 4% of a participant's eligible compensation. The Company may, at its discretion, elect to make a profit sharing contribution to the Plan. For the year ended December 31, 2024, there was no profit sharing contribution made by the Plan.

##### ***Investment Options***

Participants direct the investment of their contributions into various investment options offered by the Plan. Investment options primarily consist of shares of mutual funds and a money market account. Participants may elect to allocate their total contributions to the various investment options in increments of 1% and may change their investment options daily, subject to certain restrictions on such changes imposed by the Plan's investment funds.

***Vesting***

Participants are immediately vested in their contributions and the Company's safe harbor matching contributions plus actual earnings (losses) thereon.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of their vested account balance, whichever is less. No more than one loan can be outstanding at any one time. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time the loan was initiated as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions. All loans must be repaid within five years, unless the loan is used to purchase a primary residence, for which loan terms may range up to 15 years.

***Payment of Benefits***

On termination of employment, disability, death, or normal retirement, a participant or designated beneficiary may elect to receive a lump-sum distribution equal to the value of the participant's vested account balance, a direct rollover distribution or a combination of a lump-sum cash distribution and direct rollover distribution. Participants may defer receipt of distribution until a later date unless their account balance is \$5,000 or less. If the vested account balance is \$5,000 or less, the Company will direct the Trustee that any amount exceeding \$1,000 be distributed to the participant, without consent, into an IRA for their benefit. If the vested account balance is \$1,000 or less, the account will be distributed to the participant without consent as a lump-sum distribution in cash.

If an active participant has attained age 59½, they may elect to withdraw all or a portion of their account while still employed by the Company. Hardship distributions are available to participants who demonstrate an immediate and heavy financial need. In accordance with IRS regulations, participants must exhaust all other assets reasonably available to them prior to obtaining a hardship withdrawal.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments and are deducted directly from the participant's investment returns. The Plan permits the payment of expenses incurred in connection with the recordkeeping and administration of the Plan to be made from the Plan's assets. Fees related to notes receivable of participants and benefit payments are charged to participant's account.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are presented on the accrual basis of accounting and include all adjustments necessary to present fairly the financial statements of the Plan in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying disclosures. Accordingly, actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The Company determines the Plan's valuation policies utilizing information provided by the trustee. See Note D for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

***Payment of Benefits***

Benefits paid to participants are recorded when paid. For the years ended December 31, 2024 and 2023, there were no amounts allocated to participants who elected to withdraw from the Plan but have not been paid.

***Risks and Uncertainties***

The Plan provides for various investment options in shares of mutual funds and a money market account. Investments, in general, are exposed to various risks, such as interest rate, credit and overall volatility risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE C - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, FMTC, the trustee of the Plan, has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Total investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE D - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC 820”), *Fair Value Measurement*, defines fair value, establishes a consistent framework for measuring fair value and expands disclosure requirements for fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date. Valuation of these instruments does not require a significant degree of judgment since valuations are based on quoted prices that are readily available in an active market.
- Level 2 - Significant observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the financial instrument.
- Level 3 - Significant unobservable inputs that reflect modifications to observable related market data or our assumptions about pricing by market participants.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the net asset value of shares held by the Plan at year end based on published quoted market prices.

*Money Market Fund:* Valued at cost, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments in the mutual funds and the money market account are managed by FMTC, therefore, these transactions qualify as party-in-interest transactions. In addition, notes receivable from participants are considered party-in-interest transactions. All of these party-in-interest transactions are exempt from prohibited transaction rules.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan.

**NOTE G - TAX STATUS**

The Plan utilizes a pre-approved defined contribution plan sponsored by Fidelity. The Plan obtained its latest opinion letter on June 30, 2020 in which the IRS stated that the document, as then designed, followed the applicable requirements of the Internal Revenue Code of 1986, as amended ("Code"). The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
