Independent Auditor's Report

To the Plan Administrator of the NTT DATA Americas 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of NTT DATA Americas 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

A. DESCRIPTION OF PLAN:

The following description of the NTT DATA Americas 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established on May 1, 1984, is a defined contribution plan under section 401(k) of the Internal Revenue Code ("IRC"), covering all employees of NTT DATA Americas, Inc. (formerly NTT DATA, Inc.) and its subsidiary companies who have adopted the plan (collectively, the "Company") who have attained age 18 and are permanent employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

As further discussed in Note H, the following plans merged with and into the Plan during 2024 and ceased to exist as separate plans. Effective January 12, 2024, in connection with the Company's acquisition of Aspirent Consulting, LLC, the Aspirent Consulting LLC 401(k) Plan was merged with and into the Plan and ceased to exist as a separate entity on that date. Effective May 24, 2024, in connection with the Company's acquisition of Secure-24, LLC, the Secure-24 Retirement Plan was merged with and into the Plan and ceased to exist as a separate entity on that date.

Contributions

Participants may contribute up to 75% of their annual compensation, as defined in the Plan and subject to IRC limitations. Participant contributions may be made on a pre-tax basis, or participants may elect to make Roth after-tax contributions to the Plan. Participants may also elect to contribute up to 5% of their compensation to the Plan on an after-tax basis, subject to limitations outlined in the Plan. Participants who are at least age 50 may make an additional "catch-up" contribution subject to IRC limitations. Participants may also contribute funds from another qualified retirement plan ("rollover" contributions), subject to certain requirements.

The company shall make a matching contribution equal to 50% of the first 6% of total eligible compensation that a participant contributes.

Additionally, the Company, at the Board of Director's discretion, may elect to make a discretionary contribution to the Plan. There were no discretionary contributions made for 2024.

Participant Accounts

Each participant's account is credited or charged with contributions, investment income, and administrative expenses. Investment income, including realized and unrealized gains and losses, and expenses are allocated to participants' accounts based on each participant's account balance within each fund. Participants determine the percentage in which contributions are to be invested in each fund. Participants may change their investment options as set forth in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral and rollover contributions and actual earnings thereon. Employees of NTT DATA Consulting, Inc. hired prior to August 1, 2016 and employees of NTT Centerstance are immediately vested in Company contributions with the exception of non-elective contributions which vest ratably over 6 years.

Employees who were hired by the Company in connection with the Company's acquisition of Dell Services in November 2016, employees of MISICOM, Inc. who began providing services to Ettain Group Holdings, LLC on July 1, 2021 under a transition services agreement in connect with the sale of assets of MISICOM, Inc. to Ettain Group Holdings, LLC, and certain employer contribution accounts that are merged into the Plan from other retirement accounts are 100% vested in their company's matching contributions at all times. Participants become 100% vested in the Company's contributions and earnings thereon upon disability or attainment of normal retirement age. Otherwise, participants vest in the Company's contributions based on years of continuous service, as follows:

Certain employer contribution accounts that are merged into the Plan from other retirement accounts are subjected to differing vesting schedules than stated above as outlined in the plan document.

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of a participant's account represents a forfeiture, as defined by the Plan. If a forfeiting participant is re-employed and fulfills certain requirements, as set forth in the Plan, the participant's account will be restored. Any remaining forfeitures shall be used to reduce future employer contributions or to pay plan expenses. Forfeitures of \$149,501 were used to pay plan expenses and \$3,119,913 were used to reduce employer contributions in 2024. Unallocated forfeitures were \$3,088,801 and \$3,466,198 as of December 31, 2024 and 2023, respectively.

Unallocated Assets

The Plan holds assets in a recapture account which receives deposits as a result of a revenue sharing agreement with Fidelity Management Trust Company. Funds in the account are used to pay qualified plan expenses including investment management fees, trustee fees, audit fees, and legal fees. Unallocated assets were \$670,613 and \$351,148 December 31, 2024 and 2023, respectively.

Distribution of Benefits

Benefits may be distributed to participants upon termination of employment by reason of retirement, death, disability or other separation from service. Distributions under the Plan may be made in lump sums or in installment payments.

A participant may request a withdrawal upon attainment of age 59^{1/2} or upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship", as defined in the plan document. Participants may also request a withdrawal from rollover funds at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. Loans must bear a rate of interest of prime rate plus 1%. All loans must be repaid within five years unless the proceeds are used to acquire a principal residence, in which case a longer repayment period is allowed. No more than one loan may be outstanding at any time. Principal and interest is generally paid ratably through payroll deductions each pay period.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Contributions

Contributions from plan participants and company contributions are recorded in the year in which the participant contributions are withheld from compensation.

Expenses of the Plan

Substantially all expenses incurred in the administration of the Plan are paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTES TO FINANCIAL STATEMENTS

Following is a description of the valuation methodologies used by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective investment funds – Valued at the net asset value of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities.

Self-directed brokerage accounts – Consists of mutual funds, common stocks, preferred stocks, exchange traded funds, US government securities and certificates of deposit.

Common stocks, preferred stocks, exchange traded funds – Valued at the closing price reported on the active market on which the individual securities are traded.

US government securities – Valued using pricing models maximizing the use of observable inputs for similar securities.

Certificates of deposit – Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The collective investment funds held by the Plan with the exception of the Fidelity Managed Income Portfolio II, the GW&K Small/Mid Cap Core Fund, and the Galliard Stable Return Fund, allow for daily redemptions for participants; however the Plan is subject to a 60 day redemption notice period. Assets held in the Fidelity Managed Income Portfolio II, allow for daily redemptions for participants; however the Plan is subject to a twelve month redemption notice period. Assets held in the GW&K Small/Mid Cap Core Fund allow for daily redemptions for participants with no redemption notice period. Assets held in the Galliard Stable Return Fund allow for daily redemptions for participants; however the Plan is subject to a twelve month redemption notice period. There are no unfunded commitments for any of the funds.

D. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS:

Section 3(14) of ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and transactions with investment funds managed and held by the trustee are considered party in interest transactions.

E. TAX STATUS:

Effective January 1, 2024, the Plan was restated. A request for an updated IRS determination letter for the January 1, 2024 restatement is pending with the IRS; however the plan administrator believes there have been no significant changes made to the Plan's design that would jeopardize the tax status. The plan administrator believes the Plan is designed and being operated in compliance with applicable requirements of the Code and therefore believes that the Plan, as amended, is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. CERTIFIED INVESTMENTS:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

G. PLAN TERMINATION:

The Plan was established with the intention that it will continue indefinitely. However, the Company reserves the right to suspend its contributions or to terminate the Plan at any time, subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

H. PLAN MERGERS:

As discussed in Note A, the following plans merged with and into the Plan and ceased to exist as separate plans as of the effective date of the merger:

Independent Auditor's Report

To the Plan Administrator of the NTT DATA Americas 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of NTT DATA Americas 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

A. DESCRIPTION OF PLAN:

The following description of the NTT DATA Americas 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established on May 1, 1984, is a defined contribution plan under section 401(k) of the Internal Revenue Code ("IRC"), covering all employees of NTT DATA Americas, Inc. (formerly NTT DATA, Inc.) and its subsidiary companies who have adopted the plan (collectively, the "Company") who have attained age 18 and are permanent employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

As further discussed in Note H, the following plans merged with and into the Plan during 2024 and ceased to exist as separate plans. Effective January 12, 2024, in connection with the Company's acquisition of Aspirent Consulting, LLC, the Aspirent Consulting LLC 401(k) Plan was merged with and into the Plan and ceased to exist as a separate entity on that date. Effective May 24, 2024, in connection with the Company's acquisition of Secure-24, LLC, the Secure-24 Retirement Plan was merged with and into the Plan and ceased to exist as a separate entity on that date.

Contributions

Participants may contribute up to 75% of their annual compensation, as defined in the Plan and subject to IRC limitations. Participant contributions may be made on a pre-tax basis, or participants may elect to make Roth after-tax contributions to the Plan. Participants may also elect to contribute up to 5% of their compensation to the Plan on an after-tax basis, subject to limitations outlined in the Plan. Participants who are at least age 50 may make an additional "catch-up" contribution subject to IRC limitations. Participants may also contribute funds from another qualified retirement plan ("rollover" contributions), subject to certain requirements.

The company shall make a matching contribution equal to 50% of the first 6% of total eligible compensation that a participant contributes.

Additionally, the Company, at the Board of Director's discretion, may elect to make a discretionary contribution to the Plan. There were no discretionary contributions made for 2024.

Participant Accounts

Each participant's account is credited or charged with contributions, investment income, and administrative expenses. Investment income, including realized and unrealized gains and losses, and expenses are allocated to participants' accounts based on each participant's account balance within each fund. Participants determine the percentage in which contributions are to be invested in each fund. Participants may change their investment options as set forth in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral and rollover contributions and actual earnings thereon. Employees of NTT DATA Consulting, Inc. hired prior to August 1, 2016 and employees of NTT Centerstance are immediately vested in Company contributions with the exception of non-elective contributions which vest ratably over 6 years.

Employees who were hired by the Company in connection with the Company's acquisition of Dell Services in November 2016, employees of MISICOM, Inc. who began providing services to Ettain Group Holdings, LLC on July 1, 2021 under a transition services agreement in connect with the sale of assets of MISICOM, Inc. to Ettain Group Holdings, LLC, and certain employer contribution accounts that are merged into the Plan from other retirement accounts are 100% vested in their company's matching contributions at all times. Participants become 100% vested in the Company's contributions and earnings thereon upon disability or attainment of normal retirement age. Otherwise, participants vest in the Company's contributions based on years of continuous service, as follows:

Certain employer contribution accounts that are merged into the Plan from other retirement accounts are subjected to differing vesting schedules than stated above as outlined in the plan document.

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of a participant's account represents a forfeiture, as defined by the Plan. If a forfeiting participant is re-employed and fulfills certain requirements, as set forth in the Plan, the participant's account will be restored. Any remaining forfeitures shall be used to reduce future employer contributions or to pay plan expenses. Forfeitures of \$149,501 were used to pay plan expenses and \$3,119,913 were used to reduce employer contributions in 2024. Unallocated forfeitures were \$3,088,801 and \$3,466,198 as of December 31, 2024 and 2023, respectively.

Unallocated Assets

The Plan holds assets in a recapture account which receives deposits as a result of a revenue sharing agreement with Fidelity Management Trust Company. Funds in the account are used to pay qualified plan expenses including investment management fees, trustee fees, audit fees, and legal fees. Unallocated assets were \$670,613 and \$351,148 December 31, 2024 and 2023, respectively.

Distribution of Benefits

Benefits may be distributed to participants upon termination of employment by reason of retirement, death, disability or other separation from service. Distributions under the Plan may be made in lump sums or in installment payments.

A participant may request a withdrawal upon attainment of age 59^{1/2} or upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship", as defined in the plan document. Participants may also request a withdrawal from rollover funds at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. Loans must bear a rate of interest of prime rate plus 1%. All loans must be repaid within five years unless the proceeds are used to acquire a principal residence, in which case a longer repayment period is allowed. No more than one loan may be outstanding at any time. Principal and interest is generally paid ratably through payroll deductions each pay period.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Contributions

Contributions from plan participants and company contributions are recorded in the year in which the participant contributions are withheld from compensation.

Expenses of the Plan

Substantially all expenses incurred in the administration of the Plan are paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTES TO FINANCIAL STATEMENTS

Following is a description of the valuation methodologies used by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective investment funds – Valued at the net asset value of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities.

Self-directed brokerage accounts – Consists of mutual funds, common stocks, preferred stocks, exchange traded funds, US government securities and certificates of deposit.

Common stocks, preferred stocks, exchange traded funds – Valued at the closing price reported on the active market on which the individual securities are traded.

US government securities – Valued using pricing models maximizing the use of observable inputs for similar securities.

Certificates of deposit – Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The collective investment funds held by the Plan with the exception of the Fidelity Managed Income Portfolio II, the GW&K Small/Mid Cap Core Fund, and the Galliard Stable Return Fund, allow for daily redemptions for participants; however the Plan is subject to a 60 day redemption notice period. Assets held in the Fidelity Managed Income Portfolio II, allow for daily redemptions for participants; however the Plan is subject to a twelve month redemption notice period. Assets held in the GW&K Small/Mid Cap Core Fund allow for daily redemptions for participants with no redemption notice period. Assets held in the Galliard Stable Return Fund allow for daily redemptions for participants; however the Plan is subject to a twelve month redemption notice period. There are no unfunded commitments for any of the funds.

D. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS:

Section 3(14) of ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and transactions with investment funds managed and held by the trustee are considered party in interest transactions.

E. TAX STATUS:

Effective January 1, 2024, the Plan was restated. A request for an updated IRS determination letter for the January 1, 2024 restatement is pending with the IRS; however the plan administrator believes there have been no significant changes made to the Plan's design that would jeopardize the tax status. The plan administrator believes the Plan is designed and being operated in compliance with applicable requirements of the Code and therefore believes that the Plan, as amended, is qualified and the related trust is tax exempt.

NOTES TO FINANCIAL STATEMENTS

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. CERTIFIED INVESTMENTS:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

G. PLAN TERMINATION:

The Plan was established with the intention that it will continue indefinitely. However, the Company reserves the right to suspend its contributions or to terminate the Plan at any time, subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

H. PLAN MERGERS:

As discussed in Note A, the following plans merged with and into the Plan and ceased to exist as separate plans as of the effective date of the merger:

I. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. J. SUBSEQUENT EVENTS:

The plan has evaluated subsequent events through July 28, 2025, the date these financial statements were available for issuance.

Effective March 1, 2025, in connection with the Company's acquisition of Urban Development, NTT UD USA Inc. became a participating employer.

Independent Auditor's Report

To the Plan Administrator of the NTT DATA Americas 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of NTT DATA Americas 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

A. DESCRIPTION OF PLAN:

The following description of the NTT DATA Americas 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established on May 1, 1984, is a defined contribution plan under section 401(k) of the Internal Revenue Code ("IRC"), covering all employees of NTT DATA Americas, Inc. (formerly NTT DATA, Inc.) and its subsidiary companies who have adopted the plan (collectively, the "Company") who have attained age 18 and are permanent employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

As further discussed in Note H, the following plans merged with and into the Plan during 2024 and ceased to exist as separate plans. Effective January 12, 2024, in connection with the Company's acquisition of Aspirent Consulting, LLC, the Aspirent Consulting LLC 401(k) Plan was merged with and into the Plan and ceased to exist as a separate entity on that date. Effective May 24, 2024, in connection with the Company's acquisition of Secure-24, LLC, the Secure-24 Retirement Plan was merged with and into the Plan and ceased to exist as a separate entity on that date.

Contributions

Participants may contribute up to 75% of their annual compensation, as defined in the Plan and subject to IRC limitations. Participant contributions may be made on a pre-tax basis, or participants may elect to make Roth after-tax contributions to the Plan. Participants may also elect to contribute up to 5% of their compensation to the Plan on an after-tax basis, subject to limitations outlined in the Plan. Participants who are at least age 50 may make an additional "catch-up" contribution subject to IRC limitations. Participants may also contribute funds from another qualified retirement plan ("rollover" contributions), subject to certain requirements.

The company shall make a matching contribution equal to 50% of the first 6% of total eligible compensation that a participant contributes.

Additionally, the Company, at the Board of Director's discretion, may elect to make a discretionary contribution to the Plan. There were no discretionary contributions made for 2024.

Participant Accounts

Each participant's account is credited or charged with contributions, investment income, and administrative expenses. Investment income, including realized and unrealized gains and losses, and expenses are allocated to participants' accounts based on each participant's account balance within each fund. Participants determine the percentage in which contributions are to be invested in each fund. Participants may change their investment options as set forth in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral and rollover contributions and actual earnings thereon. Employees of NTT DATA Consulting, Inc. hired prior to August 1, 2016 and employees of NTT Centerstance are immediately vested in Company contributions with the exception of non-elective contributions which vest ratably over 6 years.

Employees who were hired by the Company in connection with the Company's acquisition of Dell Services in November 2016, employees of MISICOM, Inc. who began providing services to Ettain Group Holdings, LLC on July 1, 2021 under a transition services agreement in connect with the sale of assets of MISICOM, Inc. to Ettain Group Holdings, LLC, and certain employer contribution accounts that are merged into the Plan from other retirement accounts are 100% vested in their company's matching contributions at all times. Participants become 100% vested in the Company's contributions and earnings thereon upon disability or attainment of normal retirement age. Otherwise, participants vest in the Company's contributions based on years of continuous service, as follows:

Certain employer contribution accounts that are merged into the Plan from other retirement accounts are subjected to differing vesting schedules than stated above as outlined in the plan document.

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of a participant's account represents a forfeiture, as defined by the Plan. If a forfeiting participant is re-employed and fulfills certain requirements, as set forth in the Plan, the participant's account will be restored. Any remaining forfeitures shall be used to reduce future employer contributions or to pay plan expenses. Forfeitures of \$149,501 were used to pay plan expenses and \$3,119,913 were used to reduce employer contributions in 2024. Unallocated forfeitures were \$3,088,801 and \$3,466,198 as of December 31, 2024 and 2023, respectively.

Unallocated Assets

The Plan holds assets in a recapture account which receives deposits as a result of a revenue sharing agreement with Fidelity Management Trust Company. Funds in the account are used to pay qualified plan expenses including investment management fees, trustee fees, audit fees, and legal fees. Unallocated assets were \$670,613 and \$351,148 December 31, 2024 and 2023, respectively.

Distribution of Benefits

Benefits may be distributed to participants upon termination of employment by reason of retirement, death, disability or other separation from service. Distributions under the Plan may be made in lump sums or in installment payments.

A participant may request a withdrawal upon attainment of age 59^{1/2} or upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship", as defined in the plan document. Participants may also request a withdrawal from rollover funds at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. Loans must bear a rate of interest of prime rate plus 1%. All loans must be repaid within five years unless the proceeds are used to acquire a principal residence, in which case a longer repayment period is allowed. No more than one loan may be outstanding at any time. Principal and interest is generally paid ratably through payroll deductions each pay period.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Contributions

Contributions from plan participants and company contributions are recorded in the year in which the participant contributions are withheld from compensation.

Expenses of the Plan

Substantially all expenses incurred in the administration of the Plan are paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective investment funds – Valued at the net asset value of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities.

Self-directed brokerage accounts – Consists of mutual funds, common stocks, preferred stocks, exchange traded funds, US government securities and certificates of deposit.

Common stocks, preferred stocks, exchange traded funds – Valued at the closing price reported on the active market on which the individual securities are traded.

US government securities – Valued using pricing models maximizing the use of observable inputs for similar securities.

Certificates of deposit – Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The collective investment funds held by the Plan with the exception of the Fidelity Managed Income Portfolio II, the GW&K Small/Mid Cap Core Fund, and the Galliard Stable Return Fund, allow for daily redemptions for participants; however the Plan is subject to a 60 day redemption notice period. Assets held in the Fidelity Managed Income Portfolio II, allow for daily redemptions for participants; however the Plan is subject to a twelve month redemption notice period. Assets held in the GW&K Small/Mid Cap Core Fund allow for daily redemptions for participants with no redemption notice period. Assets held in the Galliard Stable Return Fund allow for daily redemptions for participants; however the Plan is subject to a twelve month redemption notice period. There are no unfunded commitments for any of the funds.

D. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS:

Section 3(14) of ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and transactions with investment funds managed and held by the trustee are considered party in interest transactions.

E. TAX STATUS:

Effective January 1, 2024, the Plan was restated. A request for an updated IRS determination letter for the January 1, 2024 restatement is pending with the IRS; however the plan administrator believes there have been no significant changes made to the Plan's design that would jeopardize the tax status. The plan administrator believes the Plan is designed and being operated in compliance with applicable requirements of the Code and therefore believes that the Plan, as amended, is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. CERTIFIED INVESTMENTS:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

G. PLAN TERMINATION:

The Plan was established with the intention that it will continue indefinitely. However, the Company reserves the right to suspend its contributions or to terminate the Plan at any time, subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

H. PLAN MERGERS:

As discussed in Note A, the following plans merged with and into the Plan and ceased to exist as separate plans as of the effective date of the merger:
