1. DESCRIPTION OF PLAN

The following description of the Plan is provided for general information only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

A. General:

The Plan is a defined contribution retirement plan covering employees who have completed six (6) months of service. Employees who are covered by a collective bargaining agreement or employees who are not resident of Puerto Rico are not eligible to participate in the Plan. The Plan was established effective May 1, 2006. It is subject to the provisions of ERISA.

B. Contributions:

Each year participants may elect to make pre-tax voluntary contributions in an amount not to exceed **\$15,000**. Participants may also contribute amounts transferred from other Puerto Rico qualified retirement plans, subject to the limitations specified in the Plan agreement. Participants direct the investment of their contributions into various investment options offered by the plan.

The Employer contributes to the Plan, on behalf of each Plan participant, **100%** for each dollar of such participant's contribution. However, the Employer will not make matching contributions above **4%** of the participant's compensation. Such contribution will be deposited biweekly into the accounts of all eligible participants as determined by the Plan Administrator. The Employer has the right to designate all or a portion of the matching contribution as "Qualified". To the extent matching contributions are so designated, they are nonforfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age **59½**.

The Employer may also contribute an additional amount determined in its sole judgment. This additional contribution, if any, will be allocated only to non-highly compensated employees, as defined in the Plan agreement, to the extent necessary to meet the actual deferral percentage test of Section 1165(e) of the Puerto Rico Income Tax Act of 1954. These contributions will be nonforfeitable and subject to the same withdrawal restrictions as pre-tax contributions.

Each participant's account is credited with the participant's contribution and an allocation of the Employer's contributions, any Qualified Non-Elective Contribution and Plan earnings. It will be charged with withdrawals or distributions and an allocation of plan losses and administrative expenses, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. *Vesting:*

Contributions made by participants, rollover contributions and Qualified Non-Elective Contributions, plus or minus any earnings or losses, are **100%** vested at all times. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant is **100%** vested after three years of service.

However, a participant who terminates from service due to death, total and permanent disability or retirement on or after his normal retirement date, will automatically be **100%** vested in his employer contributions account. Normal retirement date is the date on which the participant attains age 65 or, if later, the fifth anniversary of the first day of the plan year in which the participant entered the Plan. Also, terminated participants due to partial or total termination of the Plan become **100%** vested in their accounts.

E. *Payment of Benefits:*

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodical installments of substantially equal amounts over a period of years not to exceed ten (10) years.

F. *Forfeitures:*

Employer contributions forfeited by terminated employees may reduce future Employer's contribution to the trust fund. No forfeited amounts were used to reduce employer's contributions during the years ended December 31, 2024 and 2023.

G. *Participant loans:*

Participants may borrow from their fund accounts. A loan to a participant shall not be in an amount that exceeds the lesser of **\$50,000** or **50%** of the vested participant's account balances. A participant, however, may not have outstanding more than two loans in any Plan year. The maximum term of a loan is five years.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. *Date of Management's Review:*

Subsequent events were evaluated through June 21, 2025, which is the date the financial statements were available to be issued.

B. *Use of Estimates:*

Certain amounts included in the financial statements are estimated based on currently available information and the Plan Administrator's judgment as to the outcome of future conditions and circumstances. While every effort is made to ensure the integrity of such estimates, including the use of third-party specialists where appropriate, actual results could differ from those estimates.

C. *Basis of Presentation:*

The accompanying financial statements have been prepared on the accrual basis of accounting.

D. *Investments and Income Recognition:*

The Plan's investments are stated at fair value (refer to **Note 5**). The fair value of a financial instrument is the amount that would be received to sell an asset in an orderly transaction between market participants at the measurement date (the exist price). Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Common stock and U.S. government securities traded in active markets on a national securities exchange are valued at closing prices on the last business day of each period presented. Corporate bonds are valued based on broker or dealer quotations using methods based on market transactions for comparable security and various relationships between securities which are generally recognized by institutional traders. Participant loans are valued at their outstanding balances, which approximate fair value. The fair value of any guaranteed investment contract is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned.

E. *Payment of Benefits:*

Benefits are recorded when paid.

F. Administrative Expenses:

Plan fees and expenses, including fees and expenses connected with the providing of administrative services by external services providers, are paid by the Plan Administrator.

G. Participants' loan receivable:

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

3. INFORMATION CERTIFIED BY THE ASSET CUSTODIAN AND TRUSTEE

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from the Trustee that all information provided by them is complete and accurate. Information included in the accompanying financial statements as to investments and earnings on investments is presented in reliance solely upon those certifications. 4. INVESTMENTS

The Plan entered into an Adoption Agreement with Banco Popular de Puerto Rico to participate in the Popular Master Trust. The Employer selected 29 funding vehicles from the Popular Master Trust to invest all or any specific portion of the Plan funds. All investment instructions in the Popular Master Trust as to each participant's account will be directed by the participant. If no investment instructions are provided by the participant, the participant's contributed money will be directed to the appropriate Freedom Fund based on the participant's date of birth. 5. FAIR VALUE MEASUREMENTS

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three (3) levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the quoted net asset value of shares held by the plan at year ended.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. EMPLOYEE CONTRIBUTIONS

A Department of Labor Regulation requires the employee contributions to the plan to be remitted by the employer as soon as they can be reasonably segregated from the employer's general assets, but no later than "the 15th business day of the following month in which the participant contributions are withheld or received by the employer." DOL may assess penalties on employers or plan administrator who do not comply with these requirements. During the years ended December 31, 2024 and 2023 no payments were issued after deadline.

7. PLAN TERMINATION

Although it has not expressed the intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become **100%** vested in their accounts.

8. TAX STATUS

The Plan has received a favorable determination letter from the Secretary of the Treasury of Puerto Rico dated June 26, 2012, which states that the Plan and its underlying Trust, as then designed, qualifies under the applicable provisions of the PRIRC and, therefore, is exempt from local income taxes.
