Note 1. Description of the Plan

The following description of the MJ Insurance, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which is available from the Plan Administrator.

General

The Plan is a defined-contribution plan sponsored by MJ Insurance, Inc. (Company) for the benefit of its eligible employees who have completed one month of service. Effective January 1, 2024, eligible employees must be age 21 or older. Prior to January 1, 2024, employees had to be age 20 ½ or older to participate in the Plan. ProCourse Fiduciary Advisors, LLC is a participating employer. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) serves as the trustee of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions from 1% to 80% of eligible compensation. Effective January 1, 2024, participants may also make after-tax contributions up to 15% of eligible compensation. Prior to that date, after-tax contribution limit was 10% of eligible compensation. Roth and employee rollover contributions are also allowed. The Company may make discretionary matching contributions for eligible participants. During December 31, 2024 and 2023, the Company matched 100% of eligible employees' salary deferral amounts up to 2% of compensation plus 50% up to the next 4% of compensation deferred. Producers and shareholders are generally not eligible for employer contributions under the Plan. For the 2023 Plan year, highly compensated associates were also generally not eligible for the employer match. Contributions are subject to certain limitations as required by the Internal Revenue Code.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily. Participants may also participate in a self-directed brokerage arrangement under the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of continuous service.

Employees hired before January 1, 2018 are fully vested in their employer matching accounts.

Payment of Benefits

Upon termination of service, an employee is entitled to receive one lump-sum amount equal to the value of his account. Hardship withdrawals, as defined in the Plan Document, and withdrawals after attaining age 59½ are also available to Plan participants.

Forfeited Accounts

At December 31, 2024 and 2023, employer contributions were reduced by \$21,319 and \$28,662, respectively, from forfeited nonvested accounts. Forfeitures may be used to reduce future employer contributions or pay administrative expenses, as determined by the Company. At December 31, 2024 and 2023, the balance of forfeited nonvested accounts available for use were not material.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 2. Summary of Significant Accounting Policies

Method of Accounting

The accompanying financial statements are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Money market funds are valued at costs, which approximates fair value. The investments included within the self-directed brokerage account consists primarily of mutual funds and money market funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the employer or the Plan, at the employer's discretion.

Plan Tax Status

The Plan operates under an adoption agreement in connection with a pre-approved defined contribution plan sponsored by FMR LLC. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the pre-approved defined contribution plan has a favorable opinion letter from the IRS. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Note 3. Certification of Plan Trustee

The Company has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institute, has certified the following information included in the accompanying financial statements and ERISA-related supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-related supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 2 or Level 3 securities in the Plan.

Note 5. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the Plan trustee. The Plan paid \$13,846 and \$12,396 for payment of recordkeeping fees to Fidelity Management Company during December 31, 2024 and 2023, respectively. Individually nonmaterial expenses paid to parties-in-interest totaled \$6,222 and \$4,310 for December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

Note 6. Reconciliation of Financial Statements to Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan (Form 5500) filed with the IRS and the accompanying financial statements include reporting employer contributions in Form 5500 on the cash basis, which excludes the employer contribution receivable and in the accompanying statement of changes in net assets available for benefits based on the accrual basis.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Subsequent Events

Subsequent events have been evaluated through July 29, 2025, which is the date the financial statements were available to be issued.

Note 1. Description of the Plan

The following description of the MJ Insurance, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which is available from the Plan Administrator.

General

The Plan is a defined-contribution plan sponsored by MJ Insurance, Inc. (Company) for the benefit of its eligible employees who have completed one month of service. Effective January 1, 2024, eligible employees must be age 21 or older. Prior to January 1, 2024, employees had to be age 20 ½ or older to participate in the Plan. ProCourse Fiduciary Advisors, LLC is a participating employer. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) serves as the trustee of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions from 1% to 80% of eligible compensation. Effective January 1, 2024, participants may also make after-tax contributions up to 15% of eligible compensation. Prior to that date, after-tax contribution limit was 10% of eligible compensation. Roth and employee rollover contributions are also allowed. The Company may make discretionary matching contributions for eligible participants. During December 31, 2024 and 2023, the Company matched 100% of eligible employees' salary deferral amounts up to 2% of compensation plus 50% up to the next 4% of compensation deferred. Producers and shareholders are generally not eligible for employer contributions under the Plan. For the 2023 Plan year, highly compensated associates were also generally not eligible for the employer match. Contributions are subject to certain limitations as required by the Internal Revenue Code.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily. Participants may also participate in a self-directed brokerage arrangement under the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of continuous service.

Employees hired before January 1, 2018 are fully vested in their employer matching accounts.

Payment of Benefits

Upon termination of service, an employee is entitled to receive one lump-sum amount equal to the value of his account. Hardship withdrawals, as defined in the Plan Document, and withdrawals after attaining age 59½ are also available to Plan participants.

Forfeited Accounts

At December 31, 2024 and 2023, employer contributions were reduced by \$21,319 and \$28,662, respectively, from forfeited nonvested accounts. Forfeitures may be used to reduce future employer contributions or pay administrative expenses, as determined by the Company. At December 31, 2024 and 2023, the balance of forfeited nonvested accounts available for use were not material.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 2. Summary of Significant Accounting Policies

Method of Accounting

The accompanying financial statements are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Money market funds are valued at costs, which approximates fair value. The investments included within the self-directed brokerage account consists primarily of mutual funds and money market funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the employer or the Plan, at the employer's discretion.

Plan Tax Status

The Plan operates under an adoption agreement in connection with a pre-approved defined contribution plan sponsored by FMR LLC. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the pre-approved defined contribution plan has a favorable opinion letter from the IRS. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Note 3. Certification of Plan Trustee

The Company has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institute, has certified the following information included in the accompanying financial statements and ERISA-related supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-related supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 2 or Level 3 securities in the Plan.

Note 5. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the Plan trustee. The Plan paid \$13,846 and \$12,396 for payment of recordkeeping fees to Fidelity Management Company during December 31, 2024 and 2023, respectively. Individually nonmaterial expenses paid to parties-in-interest totaled \$6,222 and \$4,310 for December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

Note 6. Reconciliation of Financial Statements to Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan (Form 5500) filed with the IRS and the accompanying financial statements include reporting employer contributions in Form 5500 on the cash basis, which excludes the employer contribution receivable and in the accompanying statement of changes in net assets available for benefits based on the accrual basis.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Subsequent Events

Subsequent events have been evaluated through July 29, 2025, which is the date the financial statements were available to be issued.
