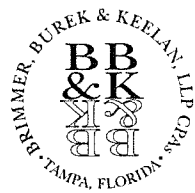

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Spathe Systems LLC 401(k Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company who have three consecutive months of service and are age twenty-one or older.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants may contribute from 1% to 90% of the compensation. Contributions are subject to Internal Revenue Service limits. Participants will be able to contribute a portion of their compensation as a pre-tax deferral or as a Roth Deferral. The Company may make a matching contribution equal to a uniform percentage of salary deferrals, the percentage to be determined each year. The Company made a 50% match of the salary deferrals up to 6% of compensation during the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, matching contributions by the Company, and an allocation of the Plan’s earnings. Allocations are based on participant account balances, as defined. Forfeited balances of terminated participants’ nonvested accounts are used to reduce future Company contributions. The Plan reduced employer contributions by \$12,664 using forfeited balances during the year ended December 31, 2024. At December 31, 2024, the balance of the forfeitures account was \$4,431

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after two years of credited service.

Payment of Benefits

Benefits payable under the Plan by reason of a participant's retirement, disability, death or severance from employment will be paid, in a lump sum, as soon as practicable following the participant's retirement, disability, death or other termination of employment, as the case may be. A participant will receive a benefit equal to the balance of his accounts as of the date of distribution. If the vested benefit in the Plan exceeds \$5,000, the participant must consent to the distribution before it may be made. If the distribution amount exceeds \$1,000 and the participant does not elect either to receive or to rollover the distribution, then the distribution must be rolled over to an IRA.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in 1% increments into various investment options offered by the Plan. The plan currently invests in pooled separate accounts investing directly in various mutual funds, using a risk based allocation model.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loans fund. Loans are not permitted from the participant's Roth Deferrals.

The participant is charged with any costs incurred by the employer with respect to the processing of the loan.

Investment Options (Continued)

Loan terms are up to five years. Each loan is secured by 50% of the vested interest of the participant in his accounts and bears interest at prime plus 2% as specified by the Wall Street Journal. Principal and interest is paid ratably through payroll deductions or automated clearing house system for electronic funds transfer (ACH).

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Investment income includes interest and dividends earned on a participant account, as well as any gains and losses realized and unrealized.

Payment of Benefits

Benefits are recorded when paid.

Participant Notes Receivable

Loans receivable are carried at their estimated collectible amounts. Interest income on loans receivable is recognized using the interest method.

Management Estimates

The preparation of financial statements, in conformity with generally accepted accounting principles, requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 3 - PLAN TERMINATION AND AMENDMENTS

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. In its latest determination letter, the Internal Revenue Service stated that the Plan, as then designated, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe the Plan was qualified as of the financial statement date.

NOTE 4 - TAX STATUS

The Internal Revenue Service has determined and informed the Company by letter dated October 6, 2020 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. The Plan administrator has adopted all Plan provisions within the prototype document and believes the Plan, as currently amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 - INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments and the interest bearing cash account reflected on the accompanying statements of net assets available for benefits as of December 31, 2024. Reliance has also certified the completeness and accuracy of the schedule of assets held for investment at end of year as of December 31, 2024, and the related investment activity reflected in the statements of changes in net assets available for benefits for the year ended December 31, 2024. The information certified includes total investments of \$5,223,697 at December 31, 2024 and related income of \$553,168 for the year ended December 31, 2024.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7 - FAIR VALUE MEASUREMENTS

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on quoted market prices.

Level 2 Fair Value Measurements

The fair value of fixed accounts is based on other significant observable inputs include (quoted prices for similar investments, interest rates, prepayment speeds, credit risks, etc.). Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.
