Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Avaap USA, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 Code of Federal Regulations (CFR) 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of the Plan

Avaap USA, LLC 401k Plan (the Plan) is sponsored by Avaap USA, LLC (the Company). The following brief description of the Plan provides only general information. Participants should refer to the Plan documents for a complete description of the Plan's provisions.

General

The Plan is a defined contribution benefit plan formed January 1, 2012 and established to provide certain employees of the Company with retirement benefits in accordance with Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan was amended and restated effective January 1, 2022 and June 1, 2022.

Effective January 1, 2025, the Plan's trustee changed from Reliance Trust Company to ADP Retirement Trust Services, LLC.

Eligibility

An employee is eligible to participate in the Plan on the first day of the month once the employee has reached the age of 21 and has completed one month of service.

Contributions

Participants may elect to defer from 1% up to 90% of eligible compensation in the Plan. Contributions may be made to the Plan on a pre-tax and/or Roth salary deferral. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified retirement plans (rollover). Contributions are subject to certain annual limitations, as imposed by the Internal Revenue Code (IRC).

Effective January 1, 2022, the Company makes matching contributions equal to 50% of the participant's contribution up to a maximum of 7% of the participant's compensation.

Participant Accounts

Each participant's account is credited with their contributions, the Company's matching contributions, and the earnings thereon. Contributions to the Plan are invested by the trustee as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Company matching contributions and nonelective contributions plus actual earnings thereon vest based on the following schedule:

Forfeitures

Upon termination of employment, participants forfeit their nonvested balances. Forfeiture allocations may be used to pay administrative expenses or to reduce Company contributions, in accordance with the Plan document. Plan forfeitures of \$82,622 were applied in conjunction with the payment of Employer contributions for the year ended December 31, 2024. Forfeitures from employees including interest earned on forfeited amounts were \$82,312 during the year ended December 31, 2024. The available balance of forfeitures as of December 31, 2024 and 2023 were \$26,420 and \$26,730, respectively.

Benefits

Participants are eligible to receive distributions from their accounts at normal retirement age, disability, death, or termination of employment. Participants who leave the Company can receive their vested benefits in a single lump-sum payment or have the payment paid as a direct rollover to an individual retirement account or individual retirement annuity (IRA) or to another employer's tax-qualified plan. Participants are eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000, reduced by their highest outstanding loan balance during the previous 12 months, or 50% of their vested account balance. The terms of the loans range from one to five years and may be longer for the purchase of a principal residence but not to exceed 30 years. The loans are collateralized by the vested account balance and bear interest at a rate 2% above the prime rate, as defined at the time of the loan. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses and Other Income

Certain administrative expenses of the Plan are paid directly by the Company and are excluded from these financial statements. These include legal and audit fees. Other administrative expenses, such as investment management, consulting, recordkeeping, and individual participant transaction fees, are paid for by the Plan.

An ERISA Budget Account (EBA) is maintained by ADP, LLC, which may be used to pay Plan expenses. Asset-based payments are calculated based upon an average daily balance of the investments for the month. During the year ended December 31, 2024, the Plan received \$46,911 from the EBA with \$1,374 of interest and utilized \$52,758 to pay certain Plan expenses. Such amounts are reflected as other income and included in administrative expenses in the accompanying statement of changes in net assets available for benefits, respectively. The available balance in the EBA was \$41,007 and \$45,481 as of December 31, 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor and Reliance Trust Company. See Note 4 for further discussion of the value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions, based on the terms of the Plan document. For the year ended December 31, 2024, notes bear interest between a rate of 5.25% and 10.50%.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivables from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA required supplemental schedule.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: (a) quoted market prices of investments for similar assets or liabilities in active markets; (b) quoted prices for the identified or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies of these items held at December 31, 2024 and 2023.

Mutual Funds – Mutual funds are valued at the daily closing price, as reported by the fund. The mutual funds held by the Plan are actively traded.

Common Collective Trusts – The common collective trusts (CCTs) are stated at fair value using the net asset value (NAV) practical expedient. The NAV of the CCTs is determined using the market price of the underlying securities and the contract value of investment contracts held by the CCTs, as determined by the trustee of the CCTs. There are no restrictions on the redemption of these investments and no unfunded commitments.

Self-Directed Brokerage Account – The plan allows for the participants to invest in mutual funds, exchange-traded funds (ETFs), individual equities, and fixed income investments. These investments are valued at unadjusted quoted market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related-Party and Party-in-Interest Transactions

ADP is the record-keeper for the Plan and therefore, these services qualify as party-in-interest transactions. Fees paid to the Plan's investments advisor also qualify as party-in-interest transactions. Fees paid to ADP and the investment advisor during the year ended December 31, 2024 were \$160,911.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

On October 6, 2020, the Internal Revenue Service (IRS) stated that the prototype plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the IRC. The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8. Risks and Uncertainties

The Plan invests in various investment options that are exposed to various risks such as interest rate, market, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through July 24, 2025, which is the date the financial statements were available to be issued.
