**NOTE A -- DESCRIPTION OF PLAN**

The following brief description of the Learning Technologies Group, Inc. Enhanced Match 401(k) Plan (“the Plan”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan effective September 1, 2021, covering substantially all employees of the Company. Effective May 1, 2024, the Plan was amended naming Learning Technologies Acquisition Corporation as the employer (“the Company”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Prior to the aforementioned amendment Learning Technologies Group, Inc. was the Plan sponsor.

Eligibility Requirements: All employees of the Company who have attained age 18 are eligible to become active members of the Plan on the first day of the pay period after or coincident with the date eligibility requirements are met. The Plan provides an automatic enrollment feature whereby employees are automatically enrolled in the Plan upon meeting the eligibility requirements at a deferral rate of 1% if no affirmative election to opt out election is made prior to their 31<sup>st</sup> day of employment.

Contributions: Eligible employees are allowed to have made on their behalf, through salary reduction, an elective contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with the Code. A participant may also designate some or all of their deferral contributions as a Roth deferral contribution.

The Company must make mandatory matching contributions for all participants equal to 100% of the first 4% of eligible employee compensation. The Company made mandatory matching contributions of \$337,898 in 2024.

These mandatory matching contributions allow the Plan to be considered a “safe harbor” plan; thus, requiring no discrimination testing of deferral and matching contributions.

The Company may also decide to make a discretionary profit sharing contribution to the Plan, although the Company is not required to do so. The Company did not make a discretionary profit sharing contribution in 2024.

A participant may also, at the discretion of the plan administrator, transfer a distribution, tax free to the Plan from another qualified plan, provided the transfer qualifies as a rollover contribution under the Code. Rollover contributions are not matched by the Company.

Contributions to the Plan are invested by Reliance Trust Company (“Reliance” or the “Trustee”) as directed by the participants. Each participant may select from one or more of the investment options offered pursuant to the provisions of the Plan.

Participant Accounts: Each participant’s account is credited with the participant’s semi-monthly contributions and Company matching contributions as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Directed Investment Accounts: Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

Vesting: Participants are fully vested immediately in their contributions and Company matching contributions plus actual earnings thereon.

NOTE A -- DESCRIPTION OF PLAN -- Continued

Forfeited Accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,684 and \$10,515, respectively. These accounts will first be used to pay administrative expenses. Any remaining amounts will be used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$367 from forfeited nonvested accounts.

Funding Policy: The employer is generally required to pay its contribution to the Plan for each Plan year within the time prescribed by law, including extensions of time for the filing of the employer's federal income tax return for the fiscal year. However, employee elective contributions accumulated through payroll deductions shall be paid to the trustee as of the earliest date on which contributions can reasonably be segregated from the employer's general assets, but in any event, within the time prescribed by law. Furthermore, any additional employer contributions which are allocable to participants' accounts for a Plan year shall be paid to the Plan no later than the twelve-month period immediately following the close of such Plan year.

Payment of Benefits: On termination of service due to death, disability, or retirement, the participant, or his or her beneficiary in the event of death, is entitled to receive a distribution of the participant's entire vested balance. Participants who have attained age 59 ½ may withdraw any portion of the vested value of their account to the extent the balance is not required to secure the outstanding balance of a loan to the participant.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Transactions are treated as a transfer between the investment options and the participant's note fund. Loans bear a reasonable rate of interest as determined by the Plan Administrator. The entire amount of the participant's account serves as collateral for the loan. All loans must have a definite repayment period not to exceed five years unless it is for the purchase of their principal residence when the repayment period may be longer. Principal and interest are paid ratably through payroll deductions. A participant may only have one loan outstanding at any given time. Interest rates range from 4.25% to 9.50% at December 31, 2024 and mature at various dates through 2029.

Hardship Withdrawals: Withdrawals due to financial hardship are permitted with the approval of the Plan Administrator for the following reasons: medical expenses, purchase of primary residence, post-secondary tuition payment, eviction from or foreclosure on principal residence and other expenses creating a financial need, as provided in published IRS revenue rulings. Withdrawals may only reduce employee deferrals and are not permitted after a participant has separated from service.

NOTE B -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions: Participant contributions are accrued in the Plan year to which they relate.

Payment of Benefits: Benefit payments are recorded when paid.

Expenses: The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Date of Management's Review of Subsequent Events: The Plan has evaluated subsequent events through August 6, 2025, the date the financial statements were available to be issued.

NOTE C -- FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are as described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels: The availability of observable market data is monitored to assess the appropriate classifications of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of levels 1, 2, or 3.

**NOTE D -- RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Reliance Trust Company ("Reliance Trust"). Reliance Trust is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for the investment management services were \$725 in 2024.

**NOTE E -- PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE F -- TAX STATUS**

Effective September 1, 2021, the Company adopted a non-standardized pre-approved profit sharing plan sponsored by Automatic Data Processing. The prototype plan obtained a determination letter dated October 6, 2020, in which the Internal Revenue Service (IRS) stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the prototype plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated, in compliance with applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE G -- RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE H -- CERTIFIED INVESTMENTS**

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).
