**Note 1:      Description of Plan**

The following description of the SJC Holdings Inc. Retirement Savings Plan (formally the SJC Holdings, dba American Highway a Simplex Co. Retirement Savings Plan) (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established on February 20, 2021, by SJC Holdings, dba American Highway a Simplex Co. (the Company) to provide retirement benefits for its employees in accordance with section 401(k) of the Internal Revenue Code (IRC). To be eligible to participate in this Plan, employees must complete one hour of service and have attained the age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute a portion of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may change the amount of contributions at the beginning of each payroll period.

The Company makes matching contributions equal to 50% of a participant's salary deferrals that do not exceed 8% of the participant's compensation. To be eligible for this contribution, the participant must be making deferral contributions to the Plan.

Each participant may elect to have their individual account invested in any combination of funds made available to the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's own contributions, an allocation of the Company's contributions, and an allocation of net earnings from investments and changes in investment values. Allocations are based on each participant's contributions, earnings, or account balances, as defined by the Plan agreement. The benefit that a participant is entitled is limited to the benefit that can be provided from the participant's account.

**Vesting**

Participants are vested immediately in their contributions and any earnings thereon. Participants vest in Company contributions at the rate of 100% after one year based on completion of 1,000 hours of service in the year. The non-vested portion of a terminated participant's account balance is forfeited.

**Forfeitures**

Contributions by the Company that are forfeited by participants upon termination may be used to pay Plan administrative expenses or used by the Company to fund future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$128 and \$3,087, respectively. During the Plan year ended December 31, 2024, \$8,094 of the forfeiture balance was used.

**Payment of Benefits**

Upon termination of service, including termination due to death, disability or retirement, a participant may receive a lump-sum distribution or a direct rollover distribution into a qualified plan. At the time of retirement the participant may delay the distribution. A participant may also elect to receive a pre-retirement distribution if the participant is 100% vested in the amount being distributed, and has reached the age of 59½.

**Administrative Expenses**

The Company has elected to fund all administrative costs other than those associated with certain participant-directed transactions, such as participant loan fees.

**Notes Receivable from Participants**

Notes receivable from participants consists of loans received by participants in exchange for the distribution of cash from the Plan. A participant is allowed to borrow a minimum of \$1,000, up to one half of the balance of their Plan account, up to a maximum of \$50,000. Loans must be repaid over no more than a five-year period with the exception of a loan for the participants' principal residence that may have a repayment period beyond five years. Principal and interest is paid ratably through payroll deductions. Loans to participants are stated at the principal amount outstanding, which approximates fair value.

Effective August 4, 2024, the Plan was amended to limit participants to a maximum of two outstanding loans at any time.

**Change in Custodian**

Effective July 11, 2024, the Plan changed its custodian from Fidelity Brokerage Services LLC to John Hancock Life Insurance Company. All plan assets were transferred to the new custodian in accordance with the Plan's provisions.

**Payment of Benefits**

Benefits are recorded when paid.

**Investment Valuation and Income Recognition**

Investments are stated at fair value as certified by the Plan's custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year.

**Note Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. The Plan distributed defaulted loans of \$18,465 as of December 31, 2024.

**Use of Estimates**

In preparing the financial statements in accordance with accounting principles generally accepted in the United States of America, management makes estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Subsequent Events**

In preparing the accompanying financial statements, management has considered events that have occurred after December 31, 2024, through July 25, 2025, the date these financial statements were available for issuance. At such date, management was not aware of any subsequent events requiring additional disclosure.

**Note 3:**      **Information Certified by the Custodian**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from July 11, 2024 to December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the custodian of the Plan).

**Note 4: Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1) Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2) Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3) Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a PSA is calculated based on a compilation of primarily observable market information. There were no unfunded commitments or redemption restrictions as of December 31, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Vanguard Target Retirement Funds* invest in a mix of Vanguard mutual funds (underlying funds) according to an asset allocation strategy designed for investors planning to retire and leave the workforce in or within a few years of the target year. The fund is designed for an investor who plans to withdraw the value of an account in the fund over a period of many years after the target year. The fund's asset allocation will become more conservative over time, meaning that the percentage of assets allocated to stocks will decrease while the percentage of assets allocated to bonds and other fixed income investments will increase.

*Fidelity 500 Index Fund* is a diversified domestic large-cap equity strategy that seeks to closely track the returns and characteristics of the S&P 500 index.

**Note 5: Plan Termination**

Although it has not expressed any intent to do so, the Plan sponsor reserves the right to terminate the Plan at any time. In the event of Plan termination, all accounts become fully vested and non-forfeitable. Plan assets would first be used to pay any expenses properly charged to the Plan. The remainder would then be distributed to participants in a lump sum.

**Note 6:**      **Tax Status**

On September 6, 2023, the IRS stated that the non-standardized pre-approved plan adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognizes tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7:**      **Party-In-Interest Transactions**

Certain Plan investments include shares of registered investment company funds managed by John Hancock Life Insurance Company (John Hancock). As John Hancock is the custodian and recordkeeper of the Plan, transactions with this entity qualify as exempt party-in-interest transactions.

**Note 8:**      **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9:**      **Excess Contributions Payable**

The Plan failed the non-discrimination testing for the year ended December 31, 2024. The Plan distributed excess contributions, amounting to \$6,401, during the year ending December 31, 2025.
