### Report on the Audit of the Financial Statements



**NOTE 1 DESCRIPTION OF THE PLAN**

The International Bowling Campus 401(k) Retirement Plan (the Plan) was established on January 1, 1995. The Plan was amended and restated effective August 15, 2021. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of United States Bowling Congress, Inc., International Bowling Campus, LLC, International Bowling Museum and Hall of Fame, Inc., Bowling Proprietors Association of America, Inc., Contemporary Bowling Association, Inc. dba: Strike Ten Entertainment, The Bowling Foundation, and IBC Youth Bowling, Inc. (the Companies). Participants must have attained age 21 and completed 30 days of service. The Plan is subject to the provisions of ERISA.

**Contributions**

Participants may voluntarily contribute up to Internal Revenue Service (IRS) limits of their annual compensation. The Companies match 100% of the first 3% of employee contributions, plus 50% of the next 2% of employee contributions. The Plan also allows after-tax contributions in the form of a Roth 401(k). The Companies may also make additional discretionary contributions. No discretionary matching contributions were made for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participants' Accounts**

Each participant's account is credited with the participant's voluntary contributions, the Companies' matching contributions, and an allocation of the Companies' discretionary contributions and Plan earnings or losses. Allocations are based upon the participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions and the Companies' matching contributions, plus actual earnings thereon. Vesting in the discretionary contributions is based on years of credited service. A participant is 100% vested after four years of credited service or upon termination of service due to death, disability, or retirement.

**Notes Receivable from Participants**

Participants may borrow up to the lesser of 50% of their vested account balance or \$50,000. The interest rate for the loans shall be a commercially reasonable rate. Loan terms are not to exceed five years, unless the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account.

**Payment of Benefits**

On termination of service, death, or disability, a participant may elect to receive the vested portion of his or her account in a lump sum or installment payment.

A terminated employee may also leave a portion or all of his or her vested benefit, if greater than \$1,000, in the Plan until such time they wish to withdraw it, with the account continuing to share in the trust fund income and losses. If a terminating participant's vested account balance does not exceed \$1,000, the Plan will distribute in a lump sum as soon as administratively practicable.

**Trust**

Certain members of management of the Companies are trustees of the Plan. Ascensus Trust Company is the qualified institution of the Plan.

**Forfeitures**

Forfeitures of terminated participants' nonvested accounts may be used to reduce future employer contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0-. There were \$23 of forfeitures used to pay the Plan's administrative expenses in 2024. No forfeitures were used to reduce employer contributions in 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements have been prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investments Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to settle a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Principal and interest is paid ratably through payroll deductions. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Certain administrative expenses are paid by the Companies and certain expenses are paid by the Plan.

**Subsequent Events**

The Plan has evaluated subsequent events through July 25, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Ascensus, LLC, as an authorized representative of Ascensus Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies utilized at December 31, 2024 and 2023.

*Short-Term Cash Investments* – Valued at cost, which approximates fair value.

*Money Market Funds* – Money market funds are valued at a stable \$1.00 net asset value.

*Mutual Funds* – Mutual funds are valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Companies' contributions.

**NOTE 7 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter received from the IRS on the pre-approved plan indicating that the Plan is designed in accordance with the applicable section of the Internal Revenue Code (IRC) and is therefore not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Ascensus Trust Company, the qualified institution of the Plan, and other service providers. Therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
