## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following brief description of Ability Partners Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more information and a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established to provide retirement benefits to employees of Finger Lakes United Cerebral Palsy, Inc. (Happiness House), Rochester Rehabilitation Center, Inc. (Rochester Rehab), and CP Rochester (the Plan Sponsors) who meet certain eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

Nationwide Financial Services, Inc., (Nationwide) and Mutual of America Life Insurance Company (Mutual of America) are custodians of the Plan. Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF) are the insurance companies of the Plan. Nationwide and Mutual of America are collectively referred to as the custodians.

#### **Eligibility**

Voluntary deferrals can be made by all employees. Participants become eligible for employer contributions after the completion of two years of service and the attainment of age eighteen (18). A year of service is defined as twelve months of service beginning on the date of hire, during which the employee completes at least 1,000 hours of service. Employees of Rochester Rehab employed prior to January 1, 2018 were required to complete 6 months of service to become eligible for employer contributions.

#### **Contributions**

Participants may make voluntary contributions subject to certain limitations of the Plan and the Internal Revenue Code (IRC).

Happiness House makes matching contributions equal to 100% of the participant's contributions for employees who have between two and five years of service, 150% of the participant's contributions for employees who have between six and fourteen years of service, and 200% of the participant's contributions for employees who have over fifteen years of service. The match applies to elective deferrals up to 3% of eligible compensation for employees who have ten or fewer years of service and 4% for employees with over ten years of service.

Rochester Rehab makes matching contributions equal to 100% of the participant's contributions for employees who have two years of service or more. The match applies to elective deferrals up to 3% of eligible compensation.

## 1. DESCRIPTION OF PLAN (Continued)

### **Contributions (Continued)**

CP Rochester makes matching contributions equal to 100% of the participant's contributions for employees who have between two and six years of service and 150% of the participant's contributions for employees who have six years of service or more. The match applies to elective deferrals up to 3% of eligible compensation.

Happiness House, Rochester Rehab and CP Rochester can also make discretionary contributions to all eligible employees. No discretionary contributions were made in 2024 or 2023.

### **Rollover Contributions**

The Plan will accept direct rollover contributions from a qualified plan, as defined by the Plan document.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, Happiness House, Rochester Rehab and CP Rochester's contributions, an allocation of Plan earnings/losses on all contributions, and an allocation of administrative expenses. Allocations are based on participant earnings/losses or account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their voluntary contributions and the Plan Sponsors' contributions into various investment options offered by the Plan.

### **Vesting**

Participants are immediately fully vested in all contributions plus earnings/losses thereon.

### **Payment of Benefits**

On termination of service due to death, retirement or other reasons, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or periodic payments.

### **Hardship Withdrawals**

Hardship withdrawals from the Plan are permitted from a participant's account. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

### **Plan Administration Costs**

Happiness House, Rochester Rehab and CP Rochester pay certain administrative costs of the Plan and certain costs are passed through to plan participants.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Investments**

Investments are reported at fair value (except for fully benefit responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

The Plan's investments in fully benefit responsive fixed annuity contracts are comprised of guaranteed insurance contracts established between the Plan's participants, TIAA and Mutual of America.

TIAA maintains Plan contributions in separate accounts. The accounts are credited with contributions and earnings on the underlying investments and are charged for Plan withdrawals. Earnings on the underlying investments are guaranteed by TIAA at 1% to 3% interest rate.

Interest for the Plan's interest accumulation account with Mutual of America is credited at a rate determined by Mutual of America. Mutual of America reserves the right to change the interest rates applicable to amounts held in this account at their discretion, but not below the minimum guaranteed interest rate (0.15% and 1.00% for 2024 and 2023, respectively). The crediting rate determined by Mutual of America was 2.85% and 3.00% as of December 31, 2024 and 2023, respectively. The amount in the guaranteed interest contract, at any time, will be equal to the sum of all amounts that have been allocated to such account, including interest credited to the account, less the sum of all amounts that have been withdrawn from such account. Participants' principal and previously-credited interest are guaranteed. Mutual of America assumes the investment risk of the underlying investments of the guaranteed interest contract. This guarantee is subject to Mutual of America's financial strength and claims-paying abilities. Mutual of America's general account investment strategies are to maintain high-quality assets with excellent liquidity, strong capital adequacy, and a proper matching of assets. The interest rate credited to amounts in the general account is a current rate and is not dependent upon the length of time the assets are invested with Mutual of America. Further, requests for withdrawal, subject to Plan provisions, can be made at any time and are processed on the day that they are received; they are not dependent on Mutual of America having to liquidate securities in order to generate a payment. The contract value is the redeemable value of the fund; there are no deferred sales charges, load assessments, interest rate adjustments, or surrender charges that would affect the value as a result of a withdrawal request. As such, contract value is equal to fair value, and the amounts held in the general account are considered fully benefit responsive.

### **Fair Value Measurement - Definition and Hierarchy**

GAAP provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Fair Value Measurement - Definition and Hierarchy (Continued)

The three levels of the fair value hierarchy under GAAP are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodology used for assets measured at fair value:

*Registered investment companies and pooled separate accounts:* Valued at the net asset value of shares held at year end based on quoted market prices in active markets.

*Separate account funds:* The separate account funds are invested in domestic stocks, international stocks, and fixed securities, such as asset or mortgage-backed securities and corporate bonds, and in mutual funds that hold such investments. The net asset value of the separate account funds is not publicly quoted. The values of the underlying investments are used in determining the net asset value of the separate account fund. Underlying equity securities have observable quoted pricing inputs. Underlying fixed securities have observable pricing inputs, including quoted prices for similar assets in the active or non-active markets. Underlying mutual funds are valued at publicly quoted pricing inputs.

There are no restrictions in connection with the transfer among or withdrawal from any of the investment alternatives in the separate account, other than that excessively frequent transfers or redemptions might be rejected. Each underlying fund has reserved the right to reject any aggregate purchase of fund shares that it determines to be inconsistent with their fund's policies and procedures relating to market timing.

The separate account funds currently invest in underlying funds, which have different investment objectives, investments policies, and risks. The investment strategies of these funds will vary based on the participant's chosen risk preferences. The separate account fund does not have any unfunded commitments.

*Non-Benefit Responsive Fixed Annuity Contracts:* Value is calculated as accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, political, currency and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

### Payment of Benefits

Benefit payments to participants are recorded when paid.

### Estimates

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. FAIR VALUE OF FINANCIAL INSTRUMENTS (Continued)

##### Fixed Annuity Contracts

TIAA maintains the Plan contributions to non-benefit responsive fixed annuity contracts in separate accounts. Lump-sum withdrawals are available within 120 days of termination of employment and are subject to a 2.5% surrender charge. All other withdrawals and transfers from the account must be spread over 10 annual installments.

Under the terms of the existing Bank of America - Fixed account contract, the crediting rate is currently reset on an annual basis. The fixed contract does not have a maturity date and the contract's provisions do not provide for a distribution at book value at some future specified date. The contract holder can request a lump sum distribution with a market value adjustment, or an installment payout over a period of years. The fixed contract continues in force until all assets have been distributed, or no future payments are due.

During the years ended December 31, 2024 and 2023, investments classified as Level 3 within the fair value hierarchy totaling \$21,294 and \$24,818, respectively, were purchased. During the years ended December 31, 2024 and 2023, investments classified as Level 3 within the fair value hierarchy totaling \$71,320 and \$556,470, respectively, were sold.

## **5. PLAN TERMINATION**

While the Plan Administrator has not expressed any intent to discontinue the Plan, it has the right to do so at any time, subject to the provisions of ERISA. In the event of the Plan's termination, participants would remain 100% vested in their accounts.

## **6. TAX STATUS**

The Plan is exempt from federal income tax under Section 403(b) of the IRC.

The Plan is required to operate in conformity with the IRC to maintain its tax exempt status. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

## **7. PARTY-IN-INTEREST TRANSACTIONS**

Nationwide and Mutual of America are custodians of the Plan. TIAA and CREF are the insurance companies of the Plan. Happiness House, Rochester Rehab and CP Rochester are the Plan sponsors. As such, transactions between the custodians, TIAA and CREF, Happiness House, Rochester Rehab and CP Rochester and the Plan qualify as party-in-interest transactions.

## **8. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through August 4, 2025, which is the date the financial statements were available to be issued.
