## INDEPENDENT AUDITOR'S REPORT

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to Financial Statements

### 1. Description of the Plan

The following description of the CPPIB America, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### 1.1 General

The Plan is a defined contribution plan covering substantially all U.S. employees of CPPIB America, Inc. (Plan Sponsor or Employer or Company) who have attained age 21 and who are not subject to a collective bargaining agreement or covered by another plan. The Board of Directors of Canada Pension Plan Investment Board have delegated certain responsibilities to various committees of the Board, to the President, to the Pension Committee and to the Senior Managing Director and Chief Talent Officer, Human Resources. Ascensus Trust Company (the Trustee) is the trustee of the Plan. The Vanguard Group, Inc. (Vanguard) provides recordkeeping services through their subcontractor Ascensus, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### 1.2 Contributions

Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) contributions made by the Company; and (iii) participant rollovers from another qualified plan. Participants have the option to make Roth elective salary reduction contributions to the plan.

Participants may elect to contribute a percentage of their compensation to the Plan each year, subject to the limitations, as defined in the plan document. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Employer contributes an amount equal to 3% of eligible compensation during the plan year, for all eligible employees.

Participants may also contribute amounts representing rollover distributions from other retirement arrangements into this Plan. Contributions are subject to certain IRC limitations.

#### 1.3 Participant Accounts

Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contributions, including amounts rolled over from other retirement arrangements into this Plan, the Employer's contributions, and allocations of investment results and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### 1.4 Investments

Participants may direct the investment of their own contributions and Employer contributions into various investment options offered by the Plan and may change investments and transfer amounts between funds daily.

## Notes to Financial Statements

### 1.5 Vesting

Participants are vested immediately in their contributions and Employer contributions plus actual earnings thereon.

### 1.6 Payment of Benefits

On termination of service with the Company (including termination of service due to death, disability or retirement), a participant may generally elect to receive an amount equal to the value of the participant's interest in their account as a lump sum or as installment payments. Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

## 2. Summary of Accounting Policies

### 2.1 Basis of Presentation

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) and the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 2.2 Use of Estimates

The preparation of the financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### 2.3 Risks and Uncertainties

The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

### 2.4 Valuation of Investments

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

### 2.5 Investment Gains (losses)

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### 2.6 Contributions

Participant and employer contributions are recorded when withheld and earned, respectively. Participant rollovers are recorded when received by the trustee.

## Notes to Financial Statements

### 2.7 Payment of Benefits

Benefit payments are recorded upon distribution. There were no participants or beneficiaries who elected to withdraw from the Plan but had not yet been paid at December 31, 2024 or 2023.

### 2.8 Administrative Expenses

Administrative expenses of the Plan are paid by the Plan or the Plan Sponsor, as provided in the Plan document. Participants pay administrative costs for distributions, qualified domestic relation orders, and advisory services. All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

## 3. Certified Investment Information

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule that was prepared by or derived from information prepared by Ascensus, LLC, as an authorized representative of Ascensus Trust Company, the trustee of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the Trustee that such information is complete and accurate.

## 4. Fair Value Measurements

*Financial Accounting Standards Board Accounting Standards Codification ASC 820, Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly

transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows:

- Level 1 - Quoted prices from active markets for identical assets or liabilities;
- Level 2 - Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (as prices) or indirectly (derived from prices); and
- Level 3 - Inputs for the asset or liability that are not based on observable market data (unobservable inputs).

**Asset Valuation Techniques**—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

**Mutual Funds**—Valued at the daily closing price as reported by the funds and are considered Level 1 investments. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Money Market Funds** — includes interest bearing cash. Fair value is determined using cost, which, together with accrued interest income, approximates fair value due to the short-term or floating rate nature of these assets.

The following tables set forth by level within the fair value hierarchy a summary of the Plan’s investments measured at fair value on a recurring basis at December 31, 2024 and 2023.

### 5. Related-Party Transactions and Exempt Party-In-Interest Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. Certain plan investments are shares of various mutual funds that are managed by Vanguard. These transactions qualify as exempt party-in-interest transactions.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right, under the Plan, to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

### 7. Tax Status

The Plan uses a prototype Plan document sponsored by Ascensus, LLC. Ascensus, LLC received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

### 8. Subsequent Events

Subsequent events were evaluated through July 30, 2025, the date the financial statements were available to be issued. Effective April 11, 2025, the Plan changed its recordkeeping, custody and trustee services to Fidelity Investments. The Plan Sponsor is not aware of any additional subsequent events which would require recognition or disclosure in the financial statements.
