## INDEPENDENT AUDITORS' REPORT

To the Trustees and Participants of Shamrock Trading Corporation

### Opinion

We have audited the financial statements of Shamrock Trading Corporation ESOP Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Emphasis of Matter

As discussed in Note 3, the financial statements include investments in Shamrock Trading Corporation common stock valued at \$77,634,260 (79% of total assets), whose fair value has been estimated based upon an independent appraisal in the absence of readily determinable fair values. Our opinion is not modified with respect to that matter

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of the Shamrock Trading Corporation ESOP Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**General** – The Plan was adopted by the Board of Directors of Shamrock Trading Corporation (the “Company” or the “Sponsor”) effective January 1, 2003. The Plan exists for the benefit of substantially all employees of the Company and affiliated employers. The Plan excludes union employees and non-resident aliens. Employees of the Company serve as Trustees of the Plan.

**Eligibility** – Employees of the Company become eligible to participate in the Plan once they have attained age 21 and have completed one year of employment with a minimum of 1,000 hours of service. Participants enter the Plan on January 1 or July 1 once eligibility requirements are met. Effective January 1, 2014, certain key employees and relatives are no longer eligible to participate in the Plan.

**Contributions** – Discretionary Company contributions to the Plan are determined by the Company. To receive an allocation of the Employer Contribution, a participant must be employed on the last day of the Plan year and must have worked 1,000 hours during the Plan year. Participants who are not actively employed on the last day of the Plan year due to retirement, total and permanent disability or death, will share in the allocation of contributions and forfeitures for the Plan year, regardless of hours of service. Participants may not make contributions to the Plan.

The Company declared a contribution of 4% of a participant’s eligible compensation, which was contributed to the Plan subsequent to year end. The Company contribution may be made in cash or contribution of shares. For the year ended December 31, 2024, the Company contribution was made in cash.

**Allocations to Participants’ Accounts** – The Company contributions are allocated to each participant in an amount that bears proportionally to the ratio of each participant’s compensation to the total compensation of all participants eligible to receive a contribution. Forfeitures are allocated to the account of each participant in the same manner as contributions. The net income or loss of the Trust is determined annually as of each anniversary date. Net income or loss attributable to the Company Stock Account shall be allocated to each participant’s Company Stock Account in the ratio in which the cumulative shares allocated to the Participant’s Company Stock Account bears to the total cumulative number of Company Stock allocated to the Company Stock Accounts of all participants’ as of the valuation date. Dividends declared on Company Stock will be allocated based on the number of Company Shares held by the participant on the date the dividend is declared.

**Vesting** – A participant’s account becomes 20% vested after two years of service, with an additional 20% accruing with each additional year of service. Full vesting occurs after six years of service.

**Forfeitures** – Forfeitures occur when a participant is less than 100% vested in his or her account balance and incurs five consecutive one-year breaks in service. In addition, if a participant receives a distribution of 100% of their vested account balance, the distribution will result in forfeiture of the nonvested portion of their account balance. In 2024, forfeitures of \$105,515 in cash and 4,773.63 shares were reallocated to eligible participants’ accounts.

**Payment of Benefits** – Participants are eligible for benefit distribution upon retirement, termination of employment, disability, or death. A lump sum payment is the only form of payment available. The amount to be distributed is based upon the account valuation date immediately preceding the distribution. Any company stock held by the participant is converted to cash. Participant balances under \$5,000 may be automatically distributed, and, if no election is made, may be transferred to the participant's account in the Shamrock Trading Corporation 401(k) Profit Sharing Plan. If a participant's account balance is between \$1,000 and \$5,000, the balance will be automatically rolled over to an IRA, unless a different election is made. If a participant's account exceeds \$5,000, and no election is made, the balance will be automatically transferred to the participant's account in the Shamrock Trading Corporation 401(k) Profit Sharing Plan.

**In-Service Withdrawals** – Participants may make withdrawals prior to termination of employment if they are at least 55 years old and have 10 years of service.

**Dividends on Company Common Stock** – Participants of the Plan may receive cash dividends on the Company's common stock based on the number of shares of Company stock allocated to their account. Dividends declared in 2024 totaled \$3,107,442.

**Voting Rights** – Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustees are permitted to vote any share for which a participant has not given instructions.

**Put Option** – Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair value of the stock. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Diversification** – Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account over a six-year period. Beginning in Plan year 2022, eligible participants may elect to diversify up to 25% of their investment in Company stock during the first 5 years of the six-year period, and up to 50% in the sixth year. Participants who elect to diversify may rollover their balance to another qualified plan.

**Expenses** – The Company pays all administrative expenses of the Plan. The Company also provides the Plan with certain administrative services at no cost.

**Termination of the Plan** – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants will become 100% vested in their accounts. Any unallocated forfeitures or contributions as of the date of the Plan termination will be allocated based on normal Plan provisions. Account balances would be adjusted for earnings or losses since the last valuation date. The Plan's normal provisions concerning the form and procedures for benefit distributions would be applied.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting and Presentation** – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation and Income Recognition** – The Plan's investments are stated at estimated fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Dividends are recorded on the ex-dividend date. Interest is accrued when earned. Purchases and sales of securities are recorded on a trade-date basis.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates. The Plan relies significantly on the use of estimates in determining the valuation of the Plan's common stock.

**Risks and Uncertainties** – The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**Contributions** – Contributions are recorded in the year service is rendered by the participant.

**Payment of Benefits** – Benefit payments are reported in the year paid.

**Transfer to Affiliated Plan** – During the year ended December 31, 2024, assets of \$266,333 were transferred to the Shamrock Trading Corporation 401(k) Profit Sharing Plan. This may occur when a terminated participant with a vested balance greater than \$5,000 fails to elect a form of distribution, or for diversification elections.

**Date of Management's Review** – Subsequent events have been evaluated through August 5, 2025, which is the date the financial statements were available to be issued, and there were no subsequent events requiring additional recognition or disclosure.

### 3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Money market and interest-bearing checking accounts – The money market and the interest-bearing checking accounts are reported at cost, which approximates fair value.

Certificates of Deposit – The Certificates of Deposit (“CDs”) are reported at cost plus accrued interest, which approximates fair value. The interest on the CDs are paid monthly.

Shamrock Trading Corporation common stock – The fair value of the Shamrock Trading Corporation common stock held by the Plan is valued at fair value based upon an independent appraisal. This appraisal was based upon a combination of the Market Approach and the Income Approach. These techniques are consistent with prior years. These methods take into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated earnings capacity. Plan management has also considered that a market participant would also recognize a discount for lack of marketability.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The valuation process involves Plan management's selection of an independent appraiser under contract with the right to cancel such contract at any time. Plan management accumulates the data for the appraiser from the audited financial statements of the Company. The appraiser prepares a preliminary report which Plan management and the ESOP trustees review in detail, discuss and approve.

#### 4. RELATED PARTY AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Company common stock. This is a related party and party-in-interest transaction. The Company pays substantially all Plan expenses.

Plan investments include an interest bearing checking account and Certificates of Deposit issued and held by Regions Bank. Regions Bank is a custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest.

The Plan has a number of service providers. Such providers are party-in-interest under ERISA.

#### 5. TAX STATUS

The Plan has adopted a Non-Standardized Pre-Approved ESOP Plan, which received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the Plan is qualified, under the Internal Revenue Code ("IRC") and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the letter. However, the Plan Administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. CONCENTRATION OF CREDIT RISK**

Financial instruments, which could potentially subject the Plan to significant concentrations of credit risk, consist primarily of the investment in common stock of the Company. The investment in the common stock of the Company accounts for 79% and 77% of the Plan's net assets available for benefits at December 31, 2024 and 2023, respectively. The value of this investment is dependent upon the future operations of the Company.

The Plan maintains its cash balances in several financial institutions. The cash balances held by the Plan occasionally exceed the FDIC coverage limit of \$250,000.



