#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

**NOTES TO FINANCIAL STATEMENTS**

**NOTE 1 - DESCRIPTION OF THE PLAN:**

The following description of the Trillium Corporation 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was created on January 1, 1992, and was most recently restated as of March 1, 2022. The Plan is a defined contribution Plan covering substantially all eligible employees of Cascade Hardwood, LLC, Port Angeles Hardwood, LLC (effective August 1, 2021), and Cascadia Newspaper Company, LLC (effective March 1, 2022), as well as former employees of Trillium Corporation (collectively, "the Company), other than those classified as leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is responsible for oversight of the Plan, which include determining the appropriateness of the Plan's investment offerings, monitoring investment performance, and reporting to the Company's Board of Directors.

Eligibility

The Plan covers all employees of the Company who have six months of service (with 500 hours of service) and are age 18 or older, as defined by the Plan. Employees enter the Plan on scheduled enrollment dates following completion of the eligibility requirements.

Contributions

Participant – The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants may elect to contribute on a pretax or post-tax (Roth) basis up to 90 percent of annual compensation, as defined by the Plan, and subject to certain Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants age 50 and over may elect to defer additional amounts ("catch-up" contributions) to the Plan.

Employer Safe Harbor Matching – The Company provides for a safe harbor matching contribution equal to 100 percent of the first 3 percent, and 50 percent of the next 2 percent, of compensation that a participant contributes to the Plan, up to a maximum of 4 percent and applied to all participants on a uniform basis. Safe harbor matching contributions were \$659,297 for the year ended December 31, 2024. Participant contributions and employer safe harbor matching contributions are paid at each payroll, with a true-up for employer safe harbor matching contributions accrued at year-end and remitted in the subsequent year.

## **NOTE 1 – continued:**

Profit Sharing – Additional profit-sharing amounts may be contributed at the option of the Company’s board of directors. There was no profit-sharing contribution for the plan year ended December 31, 2024.

### Participant Accounts

Individual accounts are maintained for each participant. Each participant’s respective account is credited with the participant’s contributions and Company safe harbor matching contributions, as well as an allocation of the Company’s profit-sharing contribution, if any, and Plan earnings. Participant accounts are charged with withdrawals, an allocation of investment losses, and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may move portions of their accounts between investment options and can change their salary deferral.

### Notes Receivable from Participants

The Plan permits participants to borrow a minimum of \$1,000 up to a maximum of 50% of their vested account balance not to exceed \$50,000. The notes are secured by the balance in the participant's account. The loan interest rate is the prime rate, as specified in the Wall Street Journal. Principal and interest are paid ratably through payroll deductions and notes must be fully repaid within five years unless it is for the purchase of a primary residence in accordance with Plan provisions. Participant notes are valued at their outstanding principal balance plus accrued and unpaid interest.

### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, a partial payment, or installment payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants with vested account balances of \$1,000 or less will be distributed as a lump-sum cash distribution upon termination of service.

Hardship withdrawals and in-service distributions (for those age 59.5 or greater) are permitted by the Plan. Hardship withdrawals must be approved by the Plan Administrator and are available from all money types that are 100 percent vested, including earnings. In-service distributions are available from all money types that are 100 percent vested, including earnings.

### Vesting and Forfeitures

Participants are vested immediately in their deferral contributions plus actual earnings thereon.

## **NOTE 1 – continued:**

Participants are also vested immediately in the Company's safe harbor matching contributions. Vesting in the Company's profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested in the profit-sharing contributions after six years of credited service.

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$114 and \$368, respectively. These accounts may be used to reduce future employer contributions or to pay administrative expenses of the Plan. Also, for the year ended 2024, forfeitures of \$281 were used to pay administrative expenses.

### Subsequent Events

The Plan has performed an evaluation of subsequent events through August 6, 2025, which is the date the financial statements were available to be issued.

## **NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES:**

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

### Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**NOTE 2 – continued:**

Contributions

Contributions from participants are recorded as they are withheld from the participant's wages. Contributions from the Company are recorded in the period in which the related participant contributions are due.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation / depreciation of fair value of investments.

**NOTE 3 - FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"><li>• Quoted prices for similar assets or liabilities in active markets;</li><li>• Quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• Inputs other than quoted prices that are observable for the asset or liability;</li><li>• Inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul>

**NOTE 3 – continued:**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds:

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open- end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Group annuity contract:

Composition includes fully-benefit responsive investment contracts that are valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. The NAV per unit is calculated as of the close of trading on the NYSE. The NAV per unit is computed by dividing the total fair value of the assets in the fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the fund and included in the determination of unit values.

**NOTE 4 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including the fair value of investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation / depreciation in fair value of investments, dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus as agent for Ascensus Trust Company (the trustee of the Plan).

**NOTE 5 - FEDERAL INCOME TAXES:**

Effective March 1, 2022, the Plan adopted a new Non-Standardized Pre-Approved Profit Sharing Plan with CODA. Ascensus, LLC, the sponsor of the prototype that the Plan has adopted, obtained its latest IRS determination letter on June 30, 2020, in which IRS stated that the form of the Plan, as then designed was in compliance with the applicable requirements

**NOTE 5 – continued:**

of the Internal Revenue Code (IRC). The Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions to the extent not already fully vested.

**NOTE 7 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS:**

The Company is a party in interest to the Plan. However, there were no transactions with the Company other than employer contributions and the payment of certain administrative expenses to the Plan. The Plan uses third party service providers for administration and custodial services. These transactions qualify as exempt party-in-interest transactions.

**NOTE 8 - RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
