Independent Auditor's Report

To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. **Nature of Business and Significant Accounting Policies**

Basis of Accounting - The financial statements of the plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition - Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Administration of the Plan - Expenses of administration, except custodian and investment advisor fees, are paid by Comprehensive Senior Care Corporation ("the Organization").

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Distributions of Employee Account Balances - Distributions are recorded when paid. Amounts allocated to accounts of participants who have elected to withdraw from the Plan, but have not yet been paid, were \$-0- and \$-0- at December 31, 2024 and 2023, respectively.

Expenses - Certain expenses of monitoring the Plan are paid by the Organization and therefore, are excluded from the financial statements. Record keeping fees are shown in the financial statements.

Subsequent Events - Subsequent events have been evaluated through July 30, 2025, which is the date the financial statements were available to be issued.

2. Description of Plan	<p>The following description of the Comprehensive Senior Care Corporation 403(b) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.</p> <p><u>General</u> - The Plan is a defined contribution 403(b) profit-sharing plan, established March 1, 2010, covering all full-time employees of the Organization who are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors of the Organization oversees governance of the Plan.</p> <p><u>Tax Status</u> - The Plan is a qualified plan under the Internal Revenue Code and is exempt from federal income taxes under Section 403(b) of the Code. All tax years remain statutorily open for review.</p> <p><u>Contributions</u> - Participants may contribute a portion of their annual cash basis compensation to the limit as permitted by law. The Organization may make discretionary contributions to match a percentage of participant contributions of staff member employees.</p> <p>The Organization elected to make a discretionary matching contribution to the plan for the year ending December 31, 2024 and 2023. The employer's discretionary matching contribution is paid into the Plan each payroll period. Contributions totaled \$298,899 and \$258,427 for the years ended December 31, 2024 and 2023, respectively.</p> <p><u>Participant Accounts</u> - Each participant account is credited with the participant's contributions, the employer's matching amount, and an allocation of Plan earnings and expenses. Allocations are based on participant earnings, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.</p> <p><u>Vesting</u> - Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Organization's discretionary contribution portion of their accounts plus actual earnings thereon is also immediate.</p> <p><u>Payment of Benefits</u> - Once a participant reaches age 65, participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. For termination of service due to other reasons, participants can elect to get a distribution for their vested account balance, net of tax. Hardship distributions are allowable under the plan, but certain criteria must be met before any hardship withdrawal is distributed. A participant may elect to receive an early distribution equal to their vested account balance.</p>

Under the Contract, it is possible to make transfers between the various options and to redirect the investment of future contributions as specified by the governing Plan document and Contract provisions.

Fixed Option

Funds allocated to the Fixed Option are placed in the AUL general account where they are invested in accordance with AUL's general account investment policy. The objective of that investment policy is to maximize long-term, risk-adjusted returns. AUL's general account assets are predominately fixed-income investments (bonds, mortgages, and private placements). The average maturity for these assets is just over 10 years, and the average duration is between 7 and 8 years. The quality of these investments is high.

Following are some features and characteristics of the Fixed Option:

- Interest rates are declared in advance as described in the contract and will always equal or exceed the contractually guaranteed rate.
- All benefit-responsive Plan benefit payments and transfers out of the fixed option (as outlined in the Contract) made prior to Contract liquidation are made at book value (principal invested plus interest earned).
- Transfers in and out of the Fixed Option are permitted based on the contract.

For the Fixed Option, the contract value is equal to the principal invested plus interest earned (also known as the participant's Fixed Option "Account Value"). Pursuant to ASC 962 – *Plan Accounting - Defined Contribution Pension Plans*, we believe contract value is an appropriate determination of fair value for the Fixed Option. Participant-initiated benefit-responsive Plan withdrawals from the Fixed Option and transfers between the Fixed Option and the variable investment options, as allowed under the terms of the Plan and the Contract, are performed at contract value. The Contract's Fixed Option has no liquid market value because it is not tradable or assignable, and there are no defined maturities of the cash flows. The reported values for the Fixed Option are reported daily based on the valuation formula disclosed in the Contract, as calculated by AUL.

Liquidation of the entire Contract may cause a one-time adjustment to the aggregate contract value of the Fixed Option, resulting in a fair value different from the contract value. This total liquidation is a contingent event, which cannot be initiated by the Plan

participants, and can only be initiated by the Plan Trustee(s) upon termination of the Plan or complete termination of the Contract.

Pooled Separate Accounts

Amounts allocated to a variable investment account within an AUL pooled separate accounts are credited to a participant's account in the form of accumulated units. The value of an accumulated unit of any investment account is determined at the close of each business day and is directly related to the net asset value of the shares and the underlying investment adjusted for any dividends or distributions received by AUL and the daily equivalent of any fee charged by AUL pursuant to the Contract. The value of each accumulation unit is published each business day. Each investment account is invested by AUL exclusively in shares of a specific mutual fund or other investment entities as directed by the contract holder and/or the participant.

Termination

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on completing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-off's of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

The termination and subsequent distribution of the entire contract may result in the application of a surrender charge and/or a one-time adjustment to the aggregate fixed option value. This is a contingent event, which cannot be initiated by the Plan participants, and can only be initiated by the Plan trustee(s) or plan sponsor. The contract termination value includes a provision for a market value adjustment and a surrender charge. This value is available upon request, but AUL does not believe termination value is an appropriate measure of fair value. The Plan may also be eligible for installment payments over 5 years.

To the Plan Administrator and the Board of Trustees of Comprehensive Senior Care Corporation 403(b) Plan

We have audited the financial statements of Comprehensive Senior Care Corporation 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit) for the year ended December 31, 2024, and we have issued our report thereon dated July 30, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by American United Life Company, the custodian, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedule, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated January 16, 2025. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by Comprehensive Senior Care Corporation 403(b) Plan are described in Note 1 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because

of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated July 30, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).
