Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bryan Health Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

1. Plan Description

The following description of the Bryan Health Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Bryan Health, the controlling company. Participating companies in the Plan include Bryan Medical Center ("the Medical Center"), Crete Area Medical Center ("Crete"), Merrick Medical Center ("Merrick"), Bryan Physician Network ("Physicians Network"), Bryan Enterprises ("Enterprises"), Bryan Health Connect, ("Connect") LifePointe, Inc, ("LifePointe"), Bryan Hospital Kearney d/b/a Kearney Regional Medical Center ("Bryan Kearney"), Grand Island Regional Medical Center ("Grand Island"), and Integrated Cardiology Group d/b/a Bryan Heart ("Bryan Heart") (collectively "the Company").

Employees are eligible to make pre-tax and after-tax Roth contributions and receive matching contributions after attaining age 21. To be eligible for discretionary employer contributions, employees must be age 21, complete one year of service with the Company, and be employed on the last day of the plan year, in which they worked at least 1,000 hours, or separate from service during the plan year on or after normal retirement age. Eligible employees may become participants for salary deferral contributions and matching contributions on the first payroll date following the date on which entry requirements were fulfilled. The entry date for discretionary employer contributions is the first day of the month following the date on which entry requirements were fulfilled.

Contributions

Participant

Participants may make salary deferral contributions up to 80% of annual eligible compensation as defined by the Plan, subject to the maximum dollar amounts allowable by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Effective January 1, 2024, participants are automatically enrolled once they are eligible at a pre-tax deferral rate of 7%. Prior to January 1, 2024, participants were automatically enrolled at a pre-tax deferral rate of 5%. At any time, a participant may elect not to contribute or may increase or decrease their deferral rate to any rate allowed under Plan provisions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer – Matching Contributions

Effective January 1, 2024, the Company makes matching contributions equal to 100% of the first 3% of the participant's eligible compensation contributed to the Plan plus 50% of the next 4% of the participant's eligible compensation contributed to the Plan. For those participants having more than 15 years of service, the Company will make matching contributions equal to 100% of the first 7% of the participant's eligible compensation contributed to the Plan.

Prior to January 1, 2024, the Company made matching contributions equal to 50% of the first 5% of the participant's eligible compensation contributed to the Plan. For those participants having more than 15 years of service, the Company made matching contributions equal to 70% of the first 5% of the participant's eligible compensation contributed to the Plan. Certain grandfathered employees of Bryan Heart received different matching contributions.

Employer – Additional and Discretionary Contributions

Effective January 1, 2024, the Company no longer makes additional employer contributions, but the Company may still make additional discretionary employer contributions. There were no such discretionary contributions made for the years ended December 31, 2024 and 2023.

Prior to January 1, 2024, the Company made additional employer contributions to participants based on a percentage of their eligible compensation and based on their years of service, as follows:

<u>Years of Vesting Service Completed by Participant</u>	<u>Employer Contribution Percentage of Compensation</u>
Less than 10 years	3%
10 years, but less than 15	4%
15 years, but less than 20	5%
20 years, but less than 25	6%
25 years or more	7%

The Crete, Physicians Network, and Merrick participants received additional employer contributions at a fixed rate of 3% of each participant's eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company matching contributions, discretionary employer contributions, and additional employer contributions (prior to January 1, 2024), (b) Plan earnings or losses, and (c) an allocation of administrative expenses. The Company's matching contributions are allocated among participants based on each participant's elected salary deferral. Additional employer contributions (prior to January 1, 2024) and discretionary employer contributions are allocated based upon eligible compensation and years of service. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Union Bank and Trust Company (UBT).

Vesting

All participants are vested immediately in their contributions, plus actual earnings thereon. Participants are fully vested for their matching contributions plus the earnings thereon, if they attained 21 years of age and completed one year of service as of December 31, 2011. Starting January 1, 2012, most participants are vested on a five-year graded vesting schedule for their matching contributions, plus the earnings thereon. Most participants are vested on a six-year graded vesting schedule for their additional employer contributions and their discretionary employer contributions, plus the earnings thereon, regardless of the year they were employed. Certain participating employers have different vesting schedules for the matching employer contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates that are commensurate with the local prevailing rates at the time of issuance. Principal and interest are paid through payroll deductions. Plan participants are not allowed to refinance existing loans.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive a lump sum payment or partial payments equal to the value of the vested funds allocated to the participant's account. The Plan requires that in the event the participant balance is under \$1,000, the participant may only receive a lump sum payment. The Plan requires mandatory distribution payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement account designated by the retirement committee in the event the participant does not elect otherwise. Upon attainment of age 59½, a participant may withdraw all or a portion of their funds in which they are 100% vested. The Plan also allows for financial hardship withdrawals. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability or death, the portion of their Company contributions not then vested shall be forfeited. If a participant is re-hired within a five-year period, the forfeited contributions are re-instated. Forfeited balances of terminated participants' non-vested accounts are used to offset future Company contributions or used to pay administrative expenses of the Plan. The forfeited non-vested accounts available to offset future Company contributions and administrative expenses as of December 31, 2024 and 2023 were \$1,261,786 and \$7,271, respectively. Forfeitures of \$0 and \$665,907 were applied to offset employer contributions or used to pay administrative expenses for the years ended December 31, 2024 and 2023, respectively.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting-Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Reclassifications

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 presentation.

Administrative Expenses

Administrative expenses included in the accompanying financial statements represent record-keeping fees, distribution fees, and participant loan origination fees associated with notes receivable from participants. The Company provides certain administrative and accounting services to the Plan at no cost. Audit and legal fees paid directly by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. There are several funds in the Plan which pay revenue-sharing payments, but those amounts are rebated back to the funds.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through August 5, 2025, noting no items requiring disclosure.

3. Information Certified by UBT

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by UBT, except for comparing such information certified by the custodian and trustee to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the funds. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their Net Asset Value (NAV) and to transact at that price. Funds held by the Plan are deemed to be actively traded.

Collective Trusts: Valued at the Net Asset Value (NAV) per unit based on the market value of its underlying investments. FASB 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these trusts meet those requirements. Participants can redeem the trusts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Internal Revenue Service (IRS) has determined and has informed the Company by a letter to the Plan dated November 21, 2014, that the respective Plan was designed in accordance with the applicable regulations of the Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distributions to participants of the account balances would be made as soon as practicable after the termination date.

7. Related Party Transactions

Plan investments include unallocated cash which is managed by UBT. UBT is the custodian and trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

8. Plan Mergers

In November 2022, the Board of Directors of the Company voted to merge the Bryan Hospital Kearney dba Kearney Regional Medical Center Retirement Plan into the Plan. Certain assets of the Bryan Hospital Kearney dba Kearney Regional Medical Center Retirement Plan, totaling \$30,915,924, were transferred into the Plan in January 2023 and the remaining assets of \$3,415,392 were transferred into the Plan in September 2023. In connection with this transaction, participants of the Platte Valley Medical Group were spun out into a new Plan. As a result, in October 2023, Plan assets of \$2,890,998 were transferred out of the Plan to the Platte Valley Medical Group 401(k) Plan.

In December 2022, the Board of Directors of the Company voted to merge the Grand Island Regional Medical Center Retirement Plan into the Plan. The assets of the Grand Island Regional Medical Center Retirement Plan, totaling \$5,626,202, were transferred into the Plan in January 2023.

In December 2022, the Board of Directors of the Company voted to merge the Bryan Heart Retirement Savings Plan into the Plan. The assets of the Bryan Heart Retirement Savings Plan, totaling \$31,413,168, were transferred into the Plan in March 2023.
