Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Shamrock Trading Corporation 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. SHAMROCK TRADING CORPORATION 401(k) PROFIT SHARING PLAN

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Shamrock Trading Corporation 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. The Plan was originally established January 1, 2002, and was amended and restated effective January 1, 2022, with substantially the same provisions.

General – The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) for employees of Shamrock Trading Corporation (the “Company”) and affiliated employers.

The Plan’s investment custodian and participant recordkeeper is Merrill Lynch, a wholly-owned subsidiary of Bank of America Corporation. Bank of America, N.A. is the Trustee. MHM Retirement Plan Solutions LLC serves as the third-party administrator of the Plan.

Plan Amendment – Effective October 1, 2024, the Plan was amended as follows:

- The automatic deferral rate for Participants hired on or after October 1, 2024, increased from 1% to 3%.
- Part-time, temporary or seasonal employees whose regularly scheduled service is less than 1,000 hours are now eligible to participate in the Plan.

Eligibility – An individual is eligible to participate in, and may enter, the Plan for purposes of salary deferrals on date of hire. Nonresident aliens, employees covered by a collective bargaining agreement are not eligible to participate.

A participant becomes eligible for purposes of employer contributions upon attaining age 21 and completion of one year of service. Employees may enter the Plan for employer contributions on the first day of the Plan quarter coinciding with or next following the date after meeting the eligibility requirements.

Contributions – Participants may elect to contribute up to 75% of their annual compensation subject to certain IRC limitations. Participants are automatically enrolled in the Plan at a deferral rate of 3% (1% prior to October 1, 2024), unless an affirmative election is made for a different election. In addition, the Plan has an automatic increase provision, whereby deferrals are increased by 1% in January of each year, up to a maximum of 6%. Participants may designate all or any portion of their contribution as Roth contributions. Participants age 50 and over may make catch-up contributions.

The Company makes a safe harbor non-elective contribution for all eligible participants of 3% of compensation.

The Company may make matching contributions equal to a discretionary percentage of a participant’s deferral determined annually by the Company. In 2024, no discretionary matching contributions were declared.

The Company may make profit-sharing contributions as determined by the Company on an annual basis. In 2024, the Company declared a profit-sharing contribution of 1% of an eligible participant’s eligible compensation. Participants must be employed on the last day of the year to share in the profit-sharing contribution.

Participant Accounts – Each participant’s account is credited with the participant’s and Company’s contributions, investment earnings, and is charged with the participant’s withdrawals and distributions, and an allocation of expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – The Plan offers a variety of mutual funds and a common collective trust as investment options for participants. In addition, participants may direct their contributions to an individually directed brokerage account.

Vesting – Participants’ contributions and employer safe harbor contributions are fully vested at all times. Discretionary employer matching and profit-sharing contributions vest in 20% increments, with 20% vested after 2 years of service and become fully vested after 6 years.

In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company contributions will become fully vested. An employee must work 1,000 hours in a year to earn one year of service.

Forfeitures – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeitures may be used to pay Plan expenses, or to reduce future employer contributions. During 2024, \$72,085 in forfeitures was used to pay Plan expenses. As of December 31, 2024 and 2023, there was \$161,573 and \$28,235, respectively, in forfeitures available.

Payment of Benefits – Distributions of a participant’s vested balance may occur upon normal retirement, termination of employment, death or permanent and total disability. A lump sum payment is the only form of payment available. Participant balances under \$5,000 may be automatically distributed. If a participant’s account balance is between \$1,000 and \$5,000, the balance will be automatically rolled over to an IRA, unless a different election is made.

Notes Receivable from Participants – Participants may borrow a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan payments are made through payroll deductions and must be repaid to the participant’s segregated account within five years, unless the loan is for a home purchase, which may be repaid over 15 years. The loans are secured by the balance in the participant’s account and bear interest at the published prime rate, as determined by the Wall Street Journal on the day of the loan request, plus 2%. A participant is charged \$75 for a loan application fee.

In-Service Withdrawals – Participants may make withdrawals prior to termination of employment if they are at least 59½ years old.

Other Income – During 2024, the Plan received \$100,511 in revenue sharing payments. Revenue sharing payments may be reallocated to participants or may be used to pay administrative expenses. In 2024, \$175,000 was reallocated to participants. As of December 31, 2024 and 2023, the revenue sharing account had a balance of \$46,998 and \$119,194, respectively.

Administrative Expenses – Administrative expenses incurred by the Plan may be paid by the Plan or by the Company. During 2023, the Plan paid administrative expenses of \$96,535.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants shall become fully vested, and all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is accrued when earned.

Management fees and operating expenses charged to the Plan for investments in the mutual funds, money market funds and the common collective trust are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

Payment of Benefits – Benefit payments are reported in the year paid.

Date of Management's Review – Subsequent events have been evaluated through August 5, 2025, which is the date the financial statements were available to be issued, and there were no material events requiring additional recognition or disclosure.

3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes used in the methodologies used at December 31, 2024 and 2023:

Mutual Funds – Valued at the closing price reported on the active market on which the individual securities are traded. The money market funds held in the individually directed brokerage accounts are valued at cost, plus accrued interest, which approximates fair value.

Common Collective Trust (“CCT”) – The investment manager calculates a unit value (similar to a net asset value “NAV”), which is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any.

Common Stocks (held in individually directed brokerage accounts) – Valued at the closing price reported on the national exchange on which the securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Bank of America, N.A., the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

- Investments, at fair value
- Notes receivable from participants, and related interest
- Net appreciation in fair value of investments
- Dividends and interest
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Plan investments included in the self-directed brokerage accounts include common stock of Bank of America Corp. The Plan also holds investments issued by Merrill Lynch, a wholly-owned subsidiary of Bank of America Corporation. Bank of America serves as the trustee for the Plan, and therefore, these transactions qualify as party-in-interest. The Plan also pays certain fees to Bank of America to administer the Plan. These transactions qualify as party-in-interest. Notes receivable from participants are party-in-interest transactions.

7. TAX STATUS

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan, which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
