Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Partnership With Children, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. Description of Plan

Effective August 27, 2013, Partnership With Children, Inc. (the "Employer") adopted the Partnership With Children, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"). The following brief description and summary of major provisions of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and Eligibility

The Plan is a defined contribution plan covering eligible employees of the Employer at least 21 years of age. Such employees are eligible to make contributions to the Plan immediately upon their date of hire. Participants become eligible for Employer contributions when they have at least twelve months of service and are 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year participants may elect to have a percentage of their compensation, as defined by the Plan, deducted on either a pre-tax or Roth basis. A participant may elect to increase, decrease or suspend their contributions according to procedures established by the Employer. There is an annual dollar limit as to the amount that can be contributed on a pre-tax basis into the Plan which is determined by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the Plan year end are eligible to make catch-up contributions up to the statutorily permitted amounts.

The Plan provides for an Employer matching contribution which is allocated to each participant based on their eligible compensation (as defined in the Plan) not to exceed the Internal Revenue Code ("IRC") annual limit. In addition, profit sharing amounts may be contributed at the option of the Employer on an annual basis. During the year ended December 31, 2024 the Employer did not make any profit-sharing contributions. Contributions are subject to certain limitations as specified in the Plan document.

Participant Accounts

Each participant's account is credited for employee and Employer contributions and the investment earnings and (losses) thereon. The contributions are allocated among the investment options according to the participant's instructions. Participant accounts are charged with an allocation of investment transaction fees that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are 100% vested immediately in their contributions plus actual earnings thereon.

Participants are 100% vested immediately in Employer matching contributions and profit-sharing contributions and earnings thereon.

1. Description of Plan (*continued*)

Notes Receivable from Participants

A participant may borrow a minimum of \$1,000 from his or her account up to a maximum equal to the lesser of \$50,000 or 50 percent of the account balance. The loans are secured by the balance in the participant's account and bear interest rates ranging from 4.50 to 9.50 percent, which is commensurate with local prevailing rates as determined by the third-party administrator. Principal and interest is paid ratably through bi-weekly payroll deductions.

The loan shall by its terms require that repayment be amortized in level payments, not less frequently than quarterly, over a period not extending beyond five years from the date of the loan, unless such loan is used to acquire a dwelling unit which, within a reasonable time, will be used as the principal residence of the participant.

Payment of Benefits

Participants' vested account balances are eligible for payment upon reaching age 59½. Upon termination of service due to death, disability, or retirement, a participant may elect to receive a distribution in the amount equal to the value of the participant's interest in his or her account. Participants may elect to receive benefits from several options available as set forth in the Plan.

Retirement benefits must normally begin no later than April 1 of the calendar year following the year in which the participant attains age 73, or, if later, April 1 following the calendar year in which the participant retires.

Beginning March 20, 2018, a participant may apply for a hardship withdrawal at any time. This withdrawal must be for an immediate financial need for which funds are not reasonably available from other resources. Hardships include post-secondary educational expenses for the participant, their spouse, or their dependents, medical expenses to the extent not otherwise reimbursed under the Employer's medical programs, expenses for the purchase of a principal residence or major alterations thereto, to prevent eviction from or foreclosure on a principal residence, to pay for funeral or burial expenses or immediate and heavy financial need as determined based on IRS regulations.

In accordance with IRS regulations, participants must first exhaust all other assets reasonably available to them prior to obtaining a hardship withdrawal. Participants are eligible to make contributions to the Plan immediately following the hardship withdrawal.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. All investments at December 31, 2024 and 2023 were valued using level 1 inputs under the fair value hierarchy.

Investment Valuation and Income Recognition

Investments are stated at fair value. The mutual funds are valued at the net asset value of the shares held by the Plan at year end based on quoted market prices. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Administrative expenses are paid by either the Plan or the Employer, as provided by the Plan's provisions. Administrative expenses paid by the Plan include record-keeping and custodian fees. Investment transaction fees are charged directly to participants accounts and are included in net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is July 24, 2025.

3. Information Certified (Unaudited)

Certain information related to investments in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments held at December 31, 2024 and 2023, and net appreciation in value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company ("MATC"), a qualified institution.

4. Investments

The Plan's mutual fund investments (including gains or losses on investments bought and sold, as well as held during the year) appreciated in value by \$454,500 for the year ended December 31, 2024.

5. Excess Contributions Payable

Excess contributions payable represent amounts due to participants for a return of excess employee deferral contributions as required to satisfy the relevant nondiscrimination requirement of the IRC.

6. Plan Termination

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Tax Status

The Internal Revenue Service ("IRS") issued an opinion letter to the prototype plan document preparer dated August 31, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

8. Party-in-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Employer, who may also be participants in the Plan, perform administration services to the Plan at no cost to the Plan.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
