We have audited the financial statements of L.R. Willson & Sons, Inc. Employee Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit] for the year ended December 31, 2024, and we will issue our report thereon dated August 4, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Ascensus Trust Company, the Trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of Generally Accepted Accounting Principles (GAAP). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with Generally Accepted Accounting Principles. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated April 28, 2025. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by L.R. Willson & Sons, Inc. Employee Retirement Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year ended December 31, 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the consolidated financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Management's estimate of the investments at fair value are based on quoted market prices in active markets or net asset value (NAV) per share (or its equivalent). We evaluated the methods, assumptions, and data used to develop the investments at fair value and contract value in determining that it is reasonable in relation to the financial statements taken as a whole.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, none of the misstatements detected as a result of audit procedures and corrected by managements were material, either individually or in the aggregate, to the financial statements taken as a whole.

Significant Audit Matters (Cont.)

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated August 4, 2025.

Management Consultations with Other Independent Accountants



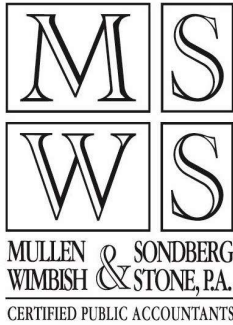

We have performed audits of the accompanying financial statements of L.R. Willson & Sons, Inc. Employee Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Note 1 - Description of Plan

The following description of the L.R. Willson & Sons, Inc. Employee Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The L.R. Willson & Sons, Inc. Employee Retirement Plan, established on March 1, 1977 and restated effective April 15, 2023, is a defined contribution plan covering substantially all employees of L.R. Willson & Sons, Inc. (the Employer). Under the provisions of the Plan, employees are eligible to make elective deferrals and receive employer contributions upon hire after turning 18 years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute up to 100% of their pre-tax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (contributions). There were no rollover contributions during the years ended December 31, 2024 and 2023. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer makes prevailing-wage contributions (referred to herein as "Davis-Bacon contributions") to the Plan on behalf of the applicable employees to meet certain requirements specified in the Davis-Bacon Act. The Davis-Bacon Act applies to federally funded construction projects and requires the Employer to provide specified fringe benefits to employees on such projects. The Employer has elected to remit the excess fringe benefits portion of the prevailing wages for these employees to the Plan as Davis-Bacon contributions. Only employees who work on contracts covered by the Davis-Bacon Act are eligible for this contribution. The Employer may also make non-elective profit-sharing contributions and/or Employer matching contributions of discretionary amounts. During the plan year ended December 31, 2024, the plan made only discretionary contributions equal to 5.70% of employee gross pay less the amount received from Davis-Bacon. For the year ended December 31, 2023, the Employer made two discretionary contributions. The Employer made a discretionary contribution equal to 50% of employee contributions. The Employer also made a discretionary contribution equal to 5.70% of employee gross pay less the amount received from Davis-Bacon. Participants also direct the investment of Employer contributions. Contributions are subject to certain Internal Revenue Service limitations. Contributions made by the Employer for the years ended December 31, 2024 and 2023 totaled \$1,360,077 and \$1,870,786, respectively.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and, (b) the Employer's match of salary deferral, (c) an allocation of Plan earning and reduced by applicable fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Contributions are invested, at the discretion of the participants, in one, several, or all of the investment alternatives selected by the plan administrator.

Note 1 - Description of Plan (Cont.)

Vesting: Participants are vested immediately in their contributions, Davis-Bacon contributions and employer matching contributions, plus actual earnings thereon. Vesting in the Employer's non-elective profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in nonrecurring partial payments from the vested portion of their individual account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Eligible distributions may also be rolled over to another qualifying plan or IRA. Hardship withdrawals are permitted in accordance with Internal Revenue Service regulations.

Forfeitures: Forfeited non-vested accounts for the years ended December 31, 2024 and 2023 totaled \$-0-. Employer contributions were reduced by forfeited non-vested accounts of \$24 and \$1,107 for the years ended December 31, 2024 and 2023.

Note Receivable from Participant: Under certain circumstances, as outlined in the Plan document, the Plan allows employees to obtain loans from the Plan. These loans are secured by the vested portion of the participants account and bear interest at 4.25% to 9.50%. Repayment of loans is provided through automatic payroll deduction.

Administrative Expenses: The administrative expenses related to the Plan's Trustee are paid by the Plan. The Employer pays all other administrative expenses of the Plan.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. This basis of accounting involves the application of accrual accounting; consequently, revenues and gains are recognized when earned, and expenses and losses are recognized when incurred.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2 - Summary of Accounting Policies (Cont.)

Note Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. As of December 31, 2024 and 2023, the loan balances outstanding totaled \$778,085 and \$667,651, respectively. The Plan administrator has determined all notes receivable are fully collectible from the participants' vested account balances; consequently, no amounts have been recorded as an allowance.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and Related Receivables

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from the amounts paid. The Employer discretionary match is recorded in the year in which the Employer designated the contributions. All participant and Employer contributions are participant-directed. The plan administrator has determined that all participant and employer contributions receivable are fully collectible; consequently, no amount has been recorded as an allowance for credit losses in the accompanying statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid. Benefits paid, including deemed distributions of participant loans, to participants amount to \$2,115,428 and \$2,025,821 for the years ended December 31, 2024 and 2023, respectively.

Note 3 - Information Prepared and Certified by Trustee

Investment Data

All data contained in the statements of net assets available for benefits and statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, the Schedule H, line 4i - Schedule of assets (held at end of year) for the year ended December 31, 2024, was summarized from information supplied and certified as complete and accurate by the Ascensus Trust Company, the Trustee of the Plan.

Schedule of Assets Held for Investment Purposes

The accompanying Schedule H, line 4i - Schedule of assets (held at end of year) represents a detailed listing of all investments held by the Plan as of December 31, 2024.

Note 4 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

ASC 820-10 "Fair Value Measurements" establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under *FASB ASC820* are as described as follows:

- Level 1: Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs that are unobservable and supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Note 4 - Fair Value Measurements (Cont.)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

In addition, under *FASB ASC 820* the fair value of certain investments may be measured using the net asset value (NAV) per share (or its equivalent). Such investments are not classified in the fair value hierarchy.

The Plan has no Level 2 or Level 3 investments. As of December 31, 2024 and 2023 the Plan's Level 1 investments comprise of registered investment companies valued at \$11,090,045 and \$9,729,654, respectively.

Registered Investment Companies

Registered investment companies are valued at the daily closing prices as reported by the funds. Registered investment companies held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Common Collective Trusts

The common collective trust is composed primarily of stable value investment contracts valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

- a) The common collective trust is investments represented by a unit of account whose per unit value is the result of the accumulated values of the underlying investments. The underlying investments are public investment vehicles valued using NAV per share. The NAV is based upon the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding.

The Employer provides certain accounting and administrative services to the Plan for which no fees are charged. The Plan's auditor, who audits the Plan's financial statements are paid directly by the Plan Sponsor. These fees are not reflected in these financial statements.

Certain Plan investments are shares of mutual funds managed by Ascensus Trust Company. Ascensus is the Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. For the years ended December 31, 2024 and 2023, fees paid by the Plan for the investment management services amounted to \$69,229 and \$66,739, respectively.

Note 6 - Reportable Transactions

A reportable transaction is a transaction, or series of transactions, exceeding five percent of the current value of the Plan's assets at the beginning of the year. During the plan years ended December 31, 2024 and 2023, there were no reportable transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their accounts.

Note 8 - Tax Status

Effective March 31 2008, the Plan adopted a non-standardized form of a prototype plan sponsored by Ascensus LLC. The prototype plan has received an opinion letter dated June 30, 2020, from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since this determination letter has been received. However, the plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Service.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10 - Subsequent Events

The Plan has evaluated the impact of subsequent events and transactions for potential recognition in the financial statements. There have been no subsequent events through August 4, 2025, the date the Plan's financial statements were available to be issued, that require recognition or disclosure.
