## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. PLAN DESCRIPTION

The following description of the Total Sand Services, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan was created on September 1, 2018. The Plan is a defined contribution plan covering substantially all employees of the following participating employers as defined in the Plan: Total Sand Services, LLC, Texas Specialty Sands, LLC, and Resource Transport, LLC, collectively known as the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

The Company is the sponsor of the Plan. Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, "Empower Retirement") is the Plan's custodian, third-party administrator, and non-discretionary trustee of the Plan.

#### **Eligibility**

Employees of the Company that are not nonresident aliens or represented by a collective bargaining agreement are eligible to participate in the Plan upon the completion of three months of service and attainment of age 18. Part-time, temporary, and seasonal employees are excluded from participation in the Plan, unless they work over 1,000 hours during an eligibility computation period, which is defined as the participant's anniversary year. Contributions begin on the first of the month following completion of each of these eligibility requirements.

#### **Contributions**

The Plan allows participants to contribute up to 100% of their annual compensation, subject to certain limitations of the Plan and the Internal Revenue Code (IRC). Participants may direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan.

The Plan provides for a safe harbor contribution. Under this provision, the Company contributes up to 100% of the elective deferral contributions up to 4% of eligible compensation. The Company may also make discretionary matching and qualified nonelective contributions on behalf of participants. The Company elected not to make any discretionary matching or qualified nonelective contributions for the years ended December 31, 2024 and 2023.

## 1. PLAN DESCRIPTION (Continued)

### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor contributions and allocations of (a) the Company's discretionary matching and qualified nonelective contributions and (b) the participant's share of the Plan's income (loss). Allocations are based on participant earnings and losses and plan expenses on account balances, as defined.

### Vesting

Participants are immediately vested in their contributions, safe harbor matching contributions, qualified nonelective contributions and actual earnings and losses thereon. Participants become vested in their Company discretionary matching contributions based upon years of service, as defined in the Plan as follows:

Years of Service	Vesting Percentage
Less than 1	0%
1	33%
2	66%
3	100%

### Benefit Payments

The Plan provides for benefit payments upon termination of service due to death, disability or attainment of retirement age. Participants may elect disbursement of their vested account balance in either a lump-sum amount or direct rollover into an individual retirement account or another qualified plan. The normal retirement age is the date a participant reaches the age of 65. Additionally, the Plan provides for in-service withdrawals allowed from rollover contributions at any time. The Plan allows for in-service distributions to actively-employed participants that have reached the age of 59 ½.

Effective April 1, 2024, benefit payments from the Plan will be made in a lump sum distribution if the balance is less than \$7,000 and the participant does not direct the Plan otherwise. Prior to April 1, 2024, benefit payments from the Plan were made in a lump sum distribution when the balance was less than \$5,000.

### Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's account.

### Administrative Expenses

Plan expenses primarily consist of recordkeeping fees. The Plan pays certain administrative expenses associated with the administration of the Plan. Certain administrative expenses are paid by the Company. Participant accounts are charged fees for processing benefit payments.

### Forfeitures

Forfeitures of non-vested account balances are used to reduce Company contributions or pay Plan expenses. As of December 31, 2024 and 2023, there were no available forfeited non-vested accounts. During 2024 and 2023, there were no plan expenses or employer-matching contributions paid from forfeited non-vested accounts.

### Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, all participant accounts would become fully vested.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

### **Investments and Income Recognition**

The Plan's investments are reported at fair value as reported by the custodian. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. The net appreciation (depreciation) in fair value of investments consists of both realized and unrealized gains and losses on the Plan's investments.

### **Fair Value Measurements – Definition and Hierarchy**

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 – Valuations based on quoted prices in active markets for identical assets or liability that the Plan has the ability to access.
- Level 2 – Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 – Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

See Note 4 for a description of where the Plan's assets fall within the fair value hierarchy.

### **Risks and Uncertainties**

Investment securities are exposed to various risks, such as interest rate, market, economic conditions, world affairs, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the accompanying financial statements.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Benefit Payments

Benefits are recorded when paid.

### Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

*Collective trust funds, at net asset value:* Valued at the net asset value of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value at the reporting date.

#### 5. PARTY-IN-INTEREST TRANSACTIONS

Empower Retirement is the custodian of the Plan assets for the years ended December 31, 2024 and 2023. As such, transactions involving Empower Retirement and the Plan qualify as party-in-interest transactions.

## 6. INCOME TAX STATUS

The Plan is based on an IRS approved prototype plan provided by Empower Retirement, LLC. The IRS has determined, by the letter dated November 14, 2022, that the written form of the underlying prototype plan document is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Plan itself has not received a determination letter from the IRS. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.
