### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Western Pennsylvania Conservancy Money Purchase Pension Plan and Trust (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

## NOTES TO FINANCIAL STATEMENTS

### 1. Plan Description

The Western Pennsylvania Conservancy (Conservancy) is a public 501(c)(3) tax-exempt nonprofit organization that protects and restores exceptional places to provide our region with clean waters and healthy forest, wildlife, and natural areas for the benefit of present and future generations. The Conservancy creates green spaces and gardens, contributing to the vitality of our cities and towns, and preserves Fallingwater, a symbol of people living in harmony with nature. On February 1, 1973, the Western Pennsylvania Conservancy Money Purchase Pension Plan and Trust (Plan), a non-contributory defined contribution pension plan, was established for the purpose of providing retirement benefits to the employees of the organization.

The following description of the Plan provides only general information. Participants should refer to the Plan document, including any amendments, for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution (money purchase) 401(a) plan covering all employees of the Conservancy and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Eligibility and Contributions

Employees become eligible to join the Plan upon attainment of age 21 and completion of 12 months of employment with at least 1,000 hours of service. Benefits under the Plan are funded solely by the Conservancy. The Conservancy's contribution to the Plan is equal to 8% of an individual's compensation up to the Social Security wage base and an additional 5.7% of an individual participant's compensation above the Social Security wage base.

#### Participant Accounts

Each participant's account is credited with the Conservancy's contributions and Plan earnings or losses. Participant accounts are directly charged for fees related to the administration of distribution requests. The benefit to which a participant is entitled is the vested balance in the participant's account at termination of service or at retirement.

### Vesting

All contributions to the Plan are vested immediately.

### Minimum Funding

During 2024 and 2023, the minimum funding requirements of approximately \$912,000 and \$844,000, respectively, were contributed to the Plan.

### Notes Receivable from Participants

No loans are permitted under the Plan.

### Investment Options

Upon enrollment in the Plan, a participant may direct their contributions in any of the investment options provided under the Plan.

### Payment of Benefits

Normal retirement age is 65. Upon reaching retirement age, or earlier termination of service at any age, a participant is entitled to and may elect to receive benefits under any of the following options: single life annuity, joint and survivor annuity, lump sum, fixed-period annuity, installment payments, or rollover to an eligible retirement plan such as a traditional IRA. Participants with accumulated balances of \$5,000 or less at date of service termination shall receive a distribution of their vested balance, to the extent permitted by the funding vehicles selected by the participant.

All benefits under the Plan are fully funded and are provided through group retirement annuity certificates and mutual funds as selected by the participants; therefore, benefits are not subject to, or covered by, federally funded termination insurance.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefit payments are recorded upon distribution to participants. There were no benefits allocated to the accounts of persons who had withdrawn from the Plan but were not paid as of December 31, 2024 and 2023.

#### Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Conservancy and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments. Fees related to the administration of distribution

requests are directly charged to the participant's account and are included in administrative expenses.

### Subsequent Events

Subsequent events have been evaluated through the Independent Auditor's Report date, which is the date the financial statements were available to be issued.

### **3. Plan Termination**

Although it has not expressed any intent to do so, the Conservancy has reserved the right to terminate or to amend the Plan at any time, subject to the provisions of ERISA.

### **4. Tax Status**

The Plan is a Non-standardized Pre-approved plan. The Pre-approved plan received an opinion letter from the Internal Revenue Service on October 7, 2020 that stated that the Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Further, the Plan annually files a Form 5500.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress for the Plan.

### 5. Investment Contract with Insurance Company

TIAA Traditional Annuity (TIAA Traditional) is an unallocated fixed-annuity contract that's fully and unconditionally guaranteed by TIAA. TIAA Traditional provides a guarantee of principal, a guaranteed minimum rate of interest (generally 3%, but in some recent contracts between 1% and 3%) and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the "declaration year," which begins each March 1. Additional interest isn't guaranteed for future years. Contributions to a participant's account purchases a guaranteed amount of lifetime annuity income. When a participant's account in TIAA Traditional is annuitized based on available options, the present value of the stream of payments is equal to the account balance. The subsequent stream of annuity payments occurs outside of the Plan and doesn't represent an obligation of the Plan.

The Plan holds two contracts under TIAA Traditional: the Group Retirement Annuity (GRA) and the Retirement Choice (RC), both of which are non-benefit responsive contracts. The non-benefit responsive contracts are included in the financial statements at fair value. The fair value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. The GRA contract allows lump-sum withdrawals within 120 days after termination. Outside of the 120 window, participant-initiated withdrawals may only be made in 10 annual installments. The RC contract allows lump-sum withdrawals within 120 days after termination. Outside of the 120 window, participant-initiated withdrawals may only be made in 84 monthly installments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2024 and 2023 was \$2,013,581 and \$1,980,811, respectively. The effective annual yield and crediting interest rates for the years ended December 31, 2024 and 2023 were 1.00% - 3.00%. Interest is compounded daily and is periodically adjusted by TIAA.

TIAA is responsible for maintaining the balances due to each of the eligible participants in the Plan. The net assets available for benefits include assets available to current eligible employees as well as terminated employees who have not yet been paid their benefit by the Plan. TIAA is also responsible for the proper payouts of benefits to eligible terminated employees per the terms of the Plan documents.

### 6. Fair Value Measurements

Fair values for Level 1 investments are determined by reference to quoted market prices and other relevant information generated by market transactions. Fair values for Level 2 investments are determined by reference to quoted prices for similar investments in active markets. Level 3 investments have significant unobservable inputs, as they trade infrequently or not at all. Fair values for Level 3 investments are determined by significant unobservable inputs, including the Plan's own assumptions in determining the fair value of investments.

The CREF accounts and the pooled separate account are valued at net asset value per share as determined by investment managers under the so-called "practical expedient." The practical expedient allows net asset value per share to represent fair value for reporting purposes when the criteria for using the method are met.

The CREF accounts' objective is to provide a wide range of investment alternatives and each account has its own individual investment objective, policies, and special risks. Each of the accounts will provide its participants with at least 60 days' prior notice before making changes to its investment strategy. The accounts invest principally in equity securities, fixed-income instruments, and short-term investments. Account investments are valued at fair value, which is primarily derived from the market quotations or prices, obtained from independent pricing sources, of the underlying equity, fixed income, and short-term investments. Each account determines its unit value on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023. Transfers into a specific account will not be permitted for 90 calendar days if a purchase or sale within that account is made with a sixty-day period.

Interest in the pooled separate account, which funds variable annuity contracts issued by TIAA, is valued at fair value, which is principally derived from the market value, as determined using external appraisals, of the underlying real estate holdings and real estate related investments. The pooled separate account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Unit values are calculated on a daily basis. Transactions out of the account are limited to one per calendar quarter and there are no unfunded commitments as of December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of the future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **7. Information Certified by the Plan's Custodian**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net (depreciation) appreciation in fair value of investments and dividends and interest for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF, the custodian of the Plan.

### **8. Related-Party Transactions and Party in Interest Transactions**

Certain Plan investments in the pooled separate account, the investment contract, and registered investment companies are managed by TIAA and CREF. TIAA and CREF is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees for investment management services incurred by the Plan are included in net appreciation in fair value of the investment rather than a direct payment. Administrative fees paid by the Plan to the custodians amounted to \$30,199 and \$21,424 for the years ended December 31, 2024 and 2023, respectively.

### **9. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Management of the Plan is diligent in remaining in compliance with IRS and DOL regulations and while potential matters of noncompliance periodically can arise, management is not currently aware of any such matters material to the Plan.
