### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Salt River Materials Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net position available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net position available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

We are required to be independent of Salt River Materials Group 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.



Enclosed is a Form 5500 Annual Report for the above referenced Plan. Please note that the plan sponsor is a division of the Salt River Pima-Maricopa Indian Community (SRPMIC), a federally recognized Indian tribal government. SRPMIC has made a good faith determination under Section 906 of the Pension Protection Act of 2006 (the "PPA") that the sponsor performs essential government functions that are not commercial in nature. This determination is also directed by Salt River Ordinance 327-08. As such, it is the SRPMIC's intent to preserve its right to treat the plan as a governmental plan under Internal Revenue Code Section 414(d) and ERISA Section 3(32).

The only federal guidance on essential government functions or commercial activities under the PPA as of the date of this filing is IRS Notice 2006-89. That Notice listed 5 activities presumed to be "commercial" in nature for purposes of the IRS good faith transition relief pending further guidance, and requested comments prior to the issuance of formal guidance under the PPA. SRPMIC, along with other tribes and tribal organizations across the country, submitted timely comments in opposition to the approach taken in Notice 2006-89. No formal guidance or regulations have been issued in response to the comments as of this date. Rather, the IRS extended its good faith relief until a date that is six months after formal guidance is issued. (Notice 2007-67).

The above plan does not include any employees engaged in activities identified as "commercial" in Notice 2006-89. SRPMIC and the Salt River Materials Group (SRMG) reserve their rights to assert government status under the PPA for the above plan and have requested consultation and participation in the pending regulatory efforts to define commercial activities under the PPA. The enclosed filing is not to be construed as a waiver of sovereignty or government status of SRPMIC or any of its divisions or their plans. The filing is a voluntary undertaking solely as a result of the lack of any regulatory guidance under Section 906 of the PPA at this time.

SRPMIC and SRMG reserve their right to consultation under Executive Order 13175 with regard to all matters arising under or out of the PPA.
