Conway County Regional Water Distribution District Profit Sharing Plan
Attachment to Parts I and VII of Form 5500

The Conway County Regional Water Distribution District (the “CCRW District”) was created under Act 114 in 1957 by the General Assembly of the State of Arkansas. This legislation is formally set out in §14-116-101 of the Arkansas Code.

§414(d) of the Internal Revenue Code (the “Code”) and §3(32) of the Employee Retirement Income Security Act of 1974 (“ERISA”) define a governmental plan as “a plan established and maintained for its employees by the Government of the United States, by the government of any State or potential subdivision thereof, or by any agency or instrumentality of any of the foregoing.” Pursuant to §4(b)(1) of ERISA, governmental plans are not subject to ERISA. As a result, governmental plans are not required to file a Form 5500 or provide a summary plan description (“SPD”) to its employees.

As a governmental entity, the CCRW District is not required to file an annual Form 5500. As a result of the CCRW District being a governmental entity, the attached 2023 Final Form 5500 is the last Form 5500 that will be filed by the CCRW District for the Conway County Regional Water Distribution District Profit Sharing Plan.
