Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1. Description of Plan

The following description of FR Parallel Sub LLC 401(k) Profit Sharing Plan and Trust (Previously known as PBM Parallel Sub LLC 401(k) Profit Sharing Plan and Trust) (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide employees of FR Parallel Sub LLC (Previously known as PBM Parallel Sub LLC) (the Company) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Eligibility

All employees of the Company, other than employees covered by a collective bargaining agreement, nonresident aliens, and certain other employees as described in the plan document, are eligible to participate in the Plan if they are at least 21 years of age and have completed six consecutive months of service, as defined in the Plan document. Employees are eligible to participate in the Plan immediately upon meeting the applicable eligibility requirements.

The Plan also includes an automatic enrollment provision. Therefore, when an employee becomes eligible to be a participant in the Plan, the Company will automatically, on behalf of those participants, defer 3% of the participants' eligible compensation (as defined). Participants who were automatically enrolled, are also subject to an auto escalation of 1% of compensation up to a maximum of 10%. These increases will take place on the first day of each plan year. These deferrals will be allocated to a default fund as defined in the plan document. Participants may cancel, modify or otherwise change any of the automatic elections. Effective October 01, 2023, automatic enrollment provision has been made not applicable for the Plan through a plan amendment.

Participant Contributions

Eligible participants may make voluntary contributions through salary reductions of up to 92% of their annual pre-tax compensation, limited to the maximum amounts allowed under the provisions of the IRC (\$23,000 in 2024). Further, participants who are 50 years of age or older as of December 31, 2024 may contribute an additional "catch up" contribution (\$7,500 in 2024). The Plan also allows for participants to defer funds into a Roth 401(k). These deferrals are subject to federal income taxes, and the maximum allowable participant contribution is \$23,000 combined between both the Roth and pre-tax deferral. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

The Plan also allows rollover contributions from other qualified plans as defined in the plan document.

Employer Contributions

The Plan provides for the Company to make a discretionary matching contribution. The Company may also make discretionary profit sharing contributions to participants that are employed on the last day of the plan year. The Company may also contribute an amount which they designate as a qualified nonelective employer contribution (QNEC). There were no discretionary matching contributions, discretionary profit sharing contributions, or a QNEC made for the year ended December 31, 2024.

Participants' Accounts

Each participant's account is credited with its respective contribution and its allocation of (a) employer contributions and (b) plan earnings or losses.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are 100% vested in discretionary matching contributions and discretionary profit sharing contributions after two years of service. In the event of termination of employment due to death or disability, participants' accounts become fully vested.

Payment of Benefits

Upon termination of employment, retirement, death, or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum, in the form of partial payments, installments or an annuity contract, as defined in the plan document. Further, withdrawals from the Plan before leaving the Company are available after attaining the age of 59½. Distributions to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. The interest rate for participant loans is set periodically to be in line with current market rates for similar types of loans. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended. Loans are secured by the balance in the participant's account. Principal and interest are paid ratably through automatic payroll deductions.

Forfeitures

The Plan provides that forfeitures, the unvested portion of Company discretionary matching contributions and discretionary profit sharing contributions, will serve to reduce future Company contributions or pay Plan expenses. The Company did not use any forfeitures to reduce employer contributions or pay Plan expenses during the year ended December 31, 2024. There was no forfeiture balance as of December 31, 2024 and 2023.

Administrative Expenses

The Company may, at their discretion, pay the expenses incidental to administering the Plan. In the event that the Company does not pay Plan expenses, the expenses shall be paid by the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent Events

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

Note 3. Investment Information Certified by the Plan's Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mid Atlantic Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024
- Investment income as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3** Significant unobservable inputs, including the Company’s own assumptions in determining the fair value of the investments

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at unadjusted quoted prices reported in an active market at year-end.

The methods and significant assumptions used result in a measure of fair value appropriate for financial measurement and disclosure purposes. Investments in the common collective trust fund have no restrictions on participant directed redemptions or participant redemption notice periods required.

Note 5. Related-Party Transactions

Administrative services performed by the custodian are paid by the plan sponsor on behalf of the Plan. Fees paid by the Plan for administrative services amounted to \$9,520 and \$5,672 for the years ended December 31, 2024 and 2023, respectively.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan obtained its latest determination letter on August 31, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, however, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Financial Accounting Standards Board has issued a standard regarding the accounting and recognition of income tax positions taken or expected to be taken by the Plan. The plan administrator assesses the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan's investments include various investment securities. Such securities are subject to various risks that affect the value of the funds. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these securities it is at least reasonably possible that the changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.
